PRESIDENT'S REPORT By Roger Askew

LOCAL NEGOTIATIONS

Our branch has recently completed the local negotiation process within the three installations that we represent. Big thanks to Art Bocek, Leslie Michelsen, Steve Seyfried, Calvin Brookins, Robert Johnson, Robert Enz, Janette Dolabson and Jim Martin. The branch voted to expend up to an amount of \$2000.00 for this process and we will come in under budget. More than 130 hours were put in by these officers.

The agreement reached in Tarzana is not that much different from the last four years. In Sun Valley, we were able to increase the number of leave slots during Thanksgiving and Christmas. In Van Nuys, in regard to annual leave, we decided that we would be better off going to an actual number system over the next four years. We believe that the number of carriers within the Van Nuys Installation will decrease during the next four years, so we will be better off with this type of system than a percentage one. In addition the way we sign up for leave will change in Van Nuys to coincide with the language in the National Agreement. The annual leave that you are presently signed up for will be honored and the new changes will not take place until the calendar year 1997. In addition, at Van Nuys the amount of time required to notify local management for the signing up of spot annual has been reduced to 8 days instead of the previous 10 (this will start on March 1, 1996). The last change in Van Nuys will be how the delegates are placed on the leave chart. At the next Shop Steward meeting each steward will be given an update as to the changes. In addition the branch will be publishing a booklet for each member to have. These booklets should be available to each union member at their respective office by the first week in April. When you receive this booklet, review it and be aware of what your negotiated rights are.

GOLD CARDS

We have recently receive news from the National Headquarters that two (2) of our retired members have qualified for Gold Cards. All you have to do is be a union member for Fifty (50) years to receive this award!!! Bob Kopczynski and Alfred Danker from the Encino office have been issued these cards. I have been in contact with both of these long time union members and they would like to have these presented at the yearly Retiree's Night.

In addition two other members have informed me that believe they qualify. I have sent a letter to Washington, D.C. to ask headquarters to research the records of these two members. If we receive a favorable response then will make their presentations at the Retiree's Night also. The possibility that we could present four of these cards is great! Fifty years is a long time!!

Both Al and Bob are to be congratulated for the support they have given this organization over the years. Consider that both of these individuals started their careers in the Postal Service in the 1940's. Maybe we should ask them the number of changes that have happened to the Postal Service since then.

The next time you think that the union does nothing for you, ask either of these men, or any of the retired members how much the NALC has given them over the years. Ask any active carrier that started prior to the Postal Reorganization Act of 1970 what the conditions were like. How often do we take for granted what these men and others before us have left. We have all heard the talk before, but we truly do owe these people a well deserved thanks for creating working conditions for us that are better now that when they started.

PRESIDENT'S REPORT

C.O.P. MEETING

I have just returned from the Bi-Annual Committee of Presidents (C.O.P.) meeting in Cincinnati Ohio. The conference is a Bi-Annual conference for all Branch Presidents and State Association Presidents. The conference was well worth the time and money we have spent. The conference is held over a two day period. One fourth of the time is given to President Sombrotto for an update as to what is going on at the National level. The rest of the time was spent discussing issues that are going on across the country.

The first issue discussed was in the area of ongoing legislation. As I have said many times, we must be very watchful of what is happening in Congress. With the House of Representatives and the Senate controlled by the Republican party, the only positive side is that President Clinton can veto any legislation that would not be in our interest. This makes the national election in November of this year even more important that ever. I guess the short course is, vote for the person that will best benefit you and your family. If all three of the branches in government are controlled by the Republican party we could be in for real trouble. We would probably see a privatization of the Postal Service along with a reduction or elimination of our recently negotiated national agreement (what we were able to win in 1970 can be taken away with one congressional bill). All of our Retiree's would be effected by an elimination of their cost of living raises.

The seminar then went into area that effect our jobs as carriers. With D.P.S. just around the corner, we should all be very concerned with this. I received notice that the national level arbitration on the Fourth Bundle issue will be presented on April 26th. We should receive word on this issue just about the time the routes in Sun Valley are being adjusted. Management at the national level and the local level have refused to discuss the matter of casing the D.P.S. mail prior to us delivering it. Makes you wonder just how much they are really interested in the success of automation. I had a number of conversations with branch presidents that are presently involved with the automation of mail. By best count we can expect to take from 30 to 45 minutes longer in our street duties. Maybe with most of the routes in Van Nuys in excess of 8 hours we can expect local management to reduce the size of our assignments.!!!

Another area that was discussed was the recent mandate from President Sombrotto concerning the appointment of NALC committee members and E.I. Facilitators. I have personally had the Health Benefit Plan since 1968 and am extremely satisfied with it. I can say without any reservation that this issue will be brought up at the National Convention in Orlando. Each of our delegates must be prepared to vote on this controversial issue. President Sombrotto had made it quite clear that no appointments will be made to any union member unless that have the health benefits plan.

President Sombrotto then held a short discussion on the recent embezzlement of funds from the national headquarters. Although he could not respond to many of the questions (because of the pending legal action) he did inform us that legal action was being taken against the individual who is responsible. He informed us that the Department of Labor and the Department of Justice are both involved in this matter. In addition a civil suit has been filed in the state of Maryland against the individual. As more details are made known I will let you know.

jury Compensation The Committee of Presidents then passed a unanimous motion to have our national leadership look into having a congressional investigation into the constant delay we have with the InDepartment of the Postal Service. Our local

branch has had a number of problems with forms being either being misplaced or delayed in sending them to the Santa Clarita office.

A total of 273 branch presidents were in attendance. We collected a total of \$ 1021.00 for COLCPE.

GOLD CARDS

We have received word from the national secretary's office that two additional members have qualified for a gold card. We will be presenting 4 of these cards at our annual Retirees dinner to be held on Friday October 27, 1996.

Besides for Robert Kopczynski and Alfred Danker, long time members Keith Mower and Yewed Shipp have qualified for these cards. Should be some kind of recognition night. Make plans to be there and honor these well deserving members.

VICE PRESIDENT'S REPORT By Art Bocek

"Only in Corporate America!"

Listen my children and you shall hear, of the midnight ride of Postal Insincere. One, if by land, and two if by sea, and we on the opposite shore will be, ready to spread the alarm, to every Middlesex, village and farm. "The Bonuses are here, the bonuses are here,"... just for management. Well, by now you must have guessed what this article is all about, corporate greed. There are approximately 85 district managers, and about 30 area vice presidents in the Postal Service. I might have missed a few so lets round the numbers off to 125 upper management personnel. \$11 million dollars in bonuses was distributed to these individuals for all their hard work and efforts. Well, get out your calculators and figure out for yourself what the amount of monetary bonuses were awarded. It is a little more than what any letter carrier makes, don't you say? To make you feel a little bit better, no line supervisor or station manager received a monetary bonus. Don't be worried, be happy as they say. Remember, you get your award every two weeks no matter what it takes in time or cost. Also while you were hard at work delivering mail, supervisors and station managers of Van Nuys, while on the clock were being fed at your expense and expense of the Postal Service, as well as receiving large brass eagles on marble stands for their hard work and efforts in the EXFC project. Letter carriers, on the other hand, were being compensated by either overtime or auxiliary assistance in the name of EXFC. In conclusion, I truly believe this time lower management received the most appropriate award possible, "The Bird."

Work Standards

While at the Tarzana Post Office, management posted a list of routes depicting volumes of mail, hours work and indicating that a figure of 17' of mail in a certain amount of time was unacceptable. First, there is no work standard, only "Reasonable Effort." Second, it is a violation of Article 34 of the National Agreement for management to attempt to set up work standards. The posting of name, volumes of mail and work hours per route for any or all employee to see is "Causing and Creating a Hostile Environment." By doing so, management's action is inappropriate and unacceptable and must be grieved. If this happens anywhere, bring the matter to your steward's attention, ASAP.

Jury Duty

Accommodations of employees called for court service is covered in Section 516.44 of the ELM.

Employees who are eligible for court leave and who have a conflict with court duty and work schedules have the following options:

- Work their postal tour of duty in addition to performing court service. Have their work schedules changed temporarily to conform to the hours of court service. (Employees who do not choose this option may not have their work schedule changed and are expected to report for postal duty upon completion of their court service.)
- Have their work schedule changed temporarily to conform to the hours of court service.
 (Employees who do not choose this option may not have their work schedule changed and are expected to report for postal duty upon completion of their court service.)

- 3. If an employee works their full postal tour of duty in addition to court service, the court service is not charged to court leave. Accordingly, the employee may keep any fees received from the court for jury service. When an employee chooses to work a full postal tour of duty in addition to performing court service, but are required to be in court beyond the starting time of their scheduled reporting time, they report for postal duty as soon as possible after completion of court service and work the remaining hours of their scheduled tour. The hours of court service which overlap the employees' scheduled tours of duty are charged to court leave and the employees remit to he Postal Service that portion of court fee received for the hours charged to court leave. The combined leave and postal work may not exceed 8 hours.
- 4. An employee who chooses to have their work schedule changed temporarily for personal convenience in order to conform to court duty should file a Form 3189, in conjunction with a Form 3971, as soon as possible, to an appropriate postal official. Such request states that the temporary schedule change is for the employees benefit and is agreed by the local union. Employee who exercise this option receive full pay for court duty to include any night differential if applicable.

In section 516.45 of the ELM it states: No overtime is allowed for court service performed while an employee is on court leave or for a combination of postal work and such court service. Unless you are either on a case or in a jury panel, management has the option to allow a temporary change of schedule for jury service. However, if by "Past Practices" management has allowed temporary changing of schedule for jury service even though an employee is not on either a panel or a case, management may not unilaterally change that practice.
