PRESIDENT'S REPORT By Roger Askew

FINANCIAL

At last months regular branch meeting, the yearly budget for 1997 was discussed and passed. Along with the annual budget meeting, the Audit Committee gave it's semi-annual report on the condition of the financial affairs of the branch. I would like to thank Robert Johnson, Velma McClinton, Frank Brash and Calvin Brookins for their hard work. The branch has a long standing commitment to the membership about how we handle financial matters. I know of very few Branches that are as forthright with the membership about such things as monthly disbursement and financial reports. After a through debate on all of the items that were requested to be discussed (take note of the minutes that are printed elsewhere in this issue of the Mail Call) the budget was passed as printed in the last edition of the mail-call.

NOMINATIONS FOR OFFICER'S

The By-Laws of the Branch require that nominations for branch officers be taken at the April branch meeting (April 1, 1997-No Fooling!). The duties of the officers are described in the National Constitution under "Government of Subordinate and Federal Branches". If you are considering running for a branch office please make yourself aware of the requirements for that office prior to accepting nomination. In addition, the Executive Board has described duties of the Editor under Article VI Section 6. Please make yourself aware of these responsibilities.

Recently we have all heard about the bonus checks that were given to our managers. It seems strange to me that the craft employees each receive an amount that is fixed by the National Agreement while managers receive a bonus that it measured by some abstract number that is decided by self serving people. The Postmaster General has decided to reward his managers with bonuses that total over 156 million dollars. Why aren't we putting that money towards automation prior to passing out checks to people who don't touch the mail? How is it possible that certain stations haven't received any recognition from last year and money seems to flow into the pockets of high officials? I can't wait till next year when the monster from the Potomac tells us there are no available funds for pay raises in the next contract because we failed to make some number.

We continue to be told stories that we must pull together to make the Postal Service the best service in the world. I would make the case to management that the carriers who work for them are concerned about the future of our organization and the way we seem to be going. The same carriers that were carrying the mail last year are the same

them this year. The only thing that has changed is the management style in the Van Nuys District and from what I have seen so far this year we are in big trouble. Maybe the thing that should change is the way management performs there daily job!!!

Vice Presidents Report by Art Bocek

Employee's Partial Recovery from a "Compensable Disability."

When an employee has partially overcome a compensable injury or disease, under Section 546.141 of the ELM, the Postal Service must make every effort to assign "Limited Duty."

In assigning such work, the Postal Service should minimize any adverse or disruptive impact on the employee. The following considerations must be made in effecting such limited duty assignments:

- a. To the extent that there is adequate work available within the employee's work limitations tolerances; within employee's craft; in the work facility to which the employee is regularly assigned; and during the hours when the employee regularly works; that work constitutes the limited duty to which the employee is assigned.
- b. If adequate duties are not available within the employee's work limitation tolerances in the craft and work facility to which the employee is regularly assigned within the employee's regular work hours of duty, other work may be assigned within that facility.
- c. If adequate work is not available at the facility within the employee's regular hours of duty, work outside the employee's regular schedule may be assigned as limited duty. However, all reasonable efforts shall be made to assign the employee to limited duty within the employee's craft and to keep the hours of limited duty as close as possible to the employee's regular schedule.

Carrier Satchel

According to Section 125.41 of the M-39, carriers must use the satchel when delivering mail on foot other than for authorized dismount deliveries. Section 154.42 of the M-41 states: "carriers must load their satchel with all the letter, flat and SPR mail for a loop or relay to minimize the trips to the replenish point, except when this would require them to carry more than 35 pounds of mail." Section 321.3 of the M-41 states: "Peel off the letters and circulars for the first house from the bundle carried in the hand, and the flat mail from standing on end in satchel."

The rule or regulation requiring letter carriers to hold flats in his or her arm does not exist. If you choose to carry flat on your arm, this is your decision alone. If management orders you to carry flats over your arm, you need to indicate to the supervisor you feel the carrying of mail over your arm is unsafe. The extending and locking of an arm, to be held rigid with weight bearing down, could very easily strain or pull a muscle or even worse in an arm. When management is willing to take chances by ordering you to work in an unsafe manner, then management must bear the responsibility and cost of an "on the job injury." If given a direct order to carry flats over your arm, comply with the order if you can. Request to see your steward in order to file a grievance, whereby, management is mandating an employee to work in an unsafe manner in violation of Article 14 of the National Agreement.

Phase five: Promote the right to strike. The Postmaster General feels that letter carriers should be allowed the right to strike, because he believes arbitrated contracts (forget about mutually bargained) are too binding, and that both sides have nothing to lose. The PMG has also declared that if letter carriers have the ability to strike, both carriers and management would have something to lose if the latter were to occur. Yes, there would be two losers, letter carriers and the public-while management would walk away victorious. Why would management welcome a strike? Because, they could accomplish what they have not been able to do in the past, to fire all letter carriers and hire the inexpensive workforce management has so desired; this of course would mean even greater profits.

Consider the scenario: if carriers are allowed to strike, management would step-up their total disregard towards carriers. Imagine experiencing what management does to the carrier now, ten-fold. Carriers will demand justice, but none can be had through the articles of the contract, because management will slam the door on the contract for good. So, carriers will strike, management will ignore, and the public will become infuriated. Enter the Government and so-long carriers; management wins. With letter carriers (and other bargaining unit employees soon to follow) and their union gone, management may now enter the final phase of the Postmaster's agenda.

Phase six: The selling of the Postal Service. This will be a very simple task for the PMG to handle, for he has taken a non-profit organization and turned it into a lucrative profit making business.

How can the Postal Service be sold to the highest bidder when it is still a governmental operation? Who would get the money from such a transaction? The public will be informed that the sale of the Postal Service to private industry will not only take the task of delivering the countries mail away from the incompetent hands (once again, management created) of those over-paid union slackers, but also create hundred-of-thousands of jobs (forget about the hundred-of-thousands who lost their jobs). The public will embrace and christen the selling of the Postal Service because the current service is plagued with shoddy service (ENFC? Carrier Redesign? sure), and the public just cannot trust those *striking carriers* anymore; give the private sector a chance to provide good ol' fashion competitive service.

Funds acquired in the sale of the Postal Service will then be claimed to be used in the reduction of the federal deficit. This will be the deciding factor for the public to bless this unholy transaction.

The "dime-a-minute" Postal Service will arrive; competitive rates for those who live and work *in profitable* sectors; increased rates or no service at all for those customers living and working just south *of profitville*.

It is most likely that the microcosmic legion of uppermanagement Postal conspirators will be rewarded with very nice retirement packages and stock ownership, from whatever corporation that benefited from purchasing the Postal Service. Do not think for one moment that the PMG and his henchmen have one iota of concern for the improvement of the Postal Service, the only concern those individuals have is for their own financial improvement. Money is the God to which management worships, and how much they can attain for themselves, individually; this is management's agenda.

What is an individual carrier to do? How can a single carrier fend off upper-management sharks cash feeding frenzy? David and Goliath? Try a hard working carrier versus the cash craving corporate wanabe, wearing a tie or a dress, within the ranks of the illustrious management craft.

You, as one, can fight the good fight by simply being all the professional letter carrier you can be. Follow the rules to the letter and use the contract to your advantage, even if management ignores it and violates it. Remember, when management violates the contract, they laugh; when you violate the contract, expect to sign for that letter of warning.

Management relies on many intimidated and ill-informed carriers within our craft to spread management's disease of dissension, to realize the PMG's distorted vision of the Postal future; besides, intimidated carriers are the easiest led. That's why management pits carrier against carrier; to falsely remove carriers only to reinstate them over a year later; and disregard all forms of carrier safety: all this to intimidate you into a numbing submission. NO!

Intimidate this: I will not work in a unsafe manner. I will not disregard the service to our customers. I will not stand by and watch my fellow sister and brother intimidated, nor will I be intimidated. I will not turn against my sister or brother because of some management ploy to spread dissension. I will not disregard the contract because management makes a mockery of it. I will not remain silent when a voice needs to be heard. I will not go without a fight.

The above is by no means a cure all to management's quest to fulfill their agenda. However, it is a path, if followed vehemently by all, that can very well shift the tide in our humble campaign to maintain a high level of service to our customers, to continue our deserved (and more) quality of life, and to be proud of the fact that we are *letter carriers*. We must stand together as one; "united we stand, divided we fall", the profound simplicity of this statement underscores the necessity for total solidarity in the face of upper-management's hideous beast known as the agenda.

Management's agenda is calling. Will you be intimidated by their phases, or will you stand by your union and fight?
