#### PRESIDENT'S REPORT

ANNUAL PICNIC

Vice-President Brookins has made arrangements with Magic Mountain and the picnic will be held on Sunday August 30, 1998. We will be placing flyers for you to review in each office and an adjacent sign up sheet so that we can make arrangements for the food. In addition, the editor will be placing an announcement in this issue of The Mail Call so that you will be aware of the ticket prices as we need to know the amount of tickets that you will be purchasing. We have made arrangements for the following prices; each member will have the opportunity to purchase up to 4 tickets at a reduced price of \$ 15.00. Each additional ticket that you need will cost 30.00. The regular fare for Magic Mountain is approximately \$ 35.00. As you can see, the value is quite significant, so make arrangements to attend this great time. For those of our retired members who will be attending, you can purchase your tickets by sending the appropriate amount to the branch office located at 6910 Hayvenhurst Ave #101, Van Nuys, California 91406. Make your check payable to Branch 2462 and we will send the tickets to you. The picnic hours are from 11:00 am - 3:00 pm. with the food being served from 11:30 am until 1:30 pm. After we complete the food we will be having our raffles and the Magic Mountain staff will be conducting some of the usual picnic games. You should also know that parking is not included in the price of the ticket. The parking rate at Magic Mountain is \$ 7.00 per vehicle. Please make sure you provide an accurate count of the number of tickets that you will be needing. This should be a great time, and we will also be able to go into the park after the picnic and enjoy ourselves (at no additional expense).

#### RICHARD NIXON DAY OF MOURNING

We have recently received word of a national level arbitration case. In April of 1994, a national day of mourning was declared when President Richard Nixon's funeral took place. The date of this event was April 27, 1994. All post office were closed by a Presidential Order. For all of those employees whose regular schedule day off it was or who were on annual leave or used sick leave on this day, you will be granted a day of administrative leave. The leave must be taken this year. We have been provided a list for all of those affected letter carriers and will be letting them know by the middle August that they are eligible. If you feel you are eligible and have not been notified, please let your shop steward know. Although you can imagine that I am glad about this decision, it does seem a shame that it took almost 4 years to

receive. Hopefully in the future we can find a process that will expedite the settlement of these types of grievances. Recently a Dispute Resolution Process has been undertaken between the Postal Service and the National Association of Letter Carriers. There are approximately 19 of these test sights throughout the country. The evaluation of this new system should be completed within one year and hopefully modifications to Article 15 can be submitted.

# Vice President Report By Calvin Brookins

By the time you receive this issue of The Mail Call every station in the Van Nuys installation will have received a luncheon and raffle. This is for being the best in EXFC (External First Class Measurement System) score. EXFC scores measures the on time delivery of overnight committed first class mail. In a recent issue of The Mail Call I talked about the reward the managers and supervisors received compared to the reward that the carriers received for making these on time deliveries. Well this time the rewards are better than the last time. They are raffling off some very nice gifts. So local management is showing more of an appreciation to the craft employees who make most of the efforts to get the work done. I have never seen this type of appreciation before. I would also like to commend the Postmaster of Van Nuys for the job he has done in the time he had been here. Since he has been here some positive things have happened, He seems to be willing to work with the local union and keep an open mind about it. I hope that will continue. It will be a plus when the rest of our stations go into a DPS environment. Thanks Woody Dewitt Postmaster Van Nuys.

Now on to the National level do you know that when Postmaster General Marvin Runyon left in May, the U.S. Postal Service threw two farewell parties in his honor. The first, an invitation only affair at Union Station, featured a band, cocktails and dinner with two entrees and wine. The second was an intimate reception for lawmakers on Capitol Hill. Their cost \$82,508.09. Officials initially declined to provide cost figures for the May 4th. Runyon dinner, several weeks after a Freedom of Information request was filed with the agency spokesman Frank Brennan provided an estimate of the cost of the parties. The dinner for the head of the Postal Service, an independent federal agency, contrasted sharply to retirement parties given to two members of President Clinton's Cabinet. Ferderico Pena left employees from the departments of Energy and Transportation, both of which he had headed, threw a farewell party all paid for by government employees cost \$4,183. When Jesse Brown left the Department of Veterans Affairs, the VA gave him a party outside his office. Veterans organizations picked up the tab for the cookies and punch. \$82,508.09 seems to be a lot of money to spend on a couple of parties for someone who was only with the Postal Service for six years. Go Figure.

#### ARTICLE 8

Recently I have hand some discussions with the new Postmaster Woody Dewitt. In our conversations he asked what I thought was the single biggest cause of all the grievance we have filed against management. (An excess of over 750 last year alone) I responded that over 75% of our grievance have something to do with Article 8 of the national agreement. In an attempt to reduce the grievances in this area, we will be conducting some joint training. The training will involve each shop steward, each line supervisor, and each station manager. This is the first time in over 5 years we have been involved in any type of joint training with management. The training outline has been completed and we have had the national business agents office review it. The training should take place by the middle of next month and hopefully we can reduce our grievances in this area. I have seen some positive things happen since the Postmaster has been installed and hopefully we can build a better working environment for the letter carriers that we represent.

#### NATIONAL CONVENTION

As you read this issue of the branch newspaper, we will be attending the national convention in Las Vegas. We will be making arrangements as usual to send a copy of the Convention Chronicles to each station. This is a daily publication that is provided the next day and recaps the events that took place on the previous day. We will have someone place them on the union bulletin board for you to review. You should also be aware that arrangements have been made to have someone answer the messages on the office answering machine. So, if you encounter a situation while on the work room floor that you believe is a problem, please call the office and leave a message. Either Calvin or I will get back to you as soon as possible.
