#### PRESIDENT'S REPORT By Roger Askew

#### **CONTRACT NEGOTIATIONS**

By the time you read this we will know the results of our next national agreement. As you are aware our contract with the postal service expires on November 20th, 1998. Yesterday I called the hot line number (1-877-235-NALC) in Washington DC. President Sombrotto has about a 4 to 5 minute message on tape. About 2/3 of the information concerns the recent elections. The remaining 1/3 talks about our contract. He reports that talks are proceeding and the parties will return to the main table negotiations this week. The main table negotiations will be centered around salaries, wages, and items in this most important area. With our employer making record profits over the last 4 years, we as letter carriers deserve our fair share. With the emphasis more and more in the area of customer satisfaction, we as letter carriers should be rewarded for our efforts. Hopefully both sides will realize the importance of a negotiated contract. The membership deserves a right to vote and either ratify or reject the offer. As the results come in of what's happening I will be letting you know.

#### RECENT ELECTIONS

By now all of us our aware of recent successes from the national elections held on November 3rd. Our branch was able to make the efforts of Governor Elect Gray Davis, Senator Barbara Boxer, Congressmen Howard Berman and Congressman Brad Sherman a great victory. It was especially nice to have Congressman Sherman stop by for a short visit during our last branch meeting. Congressman Sherman came by to say thanks to all of our members for their support during his campaign and to speak on some upcoming matters in congress. Three of these leaders have given letter carriers tremendous support over the last 2 years with their voting record on our issues and Governor Elect Davis has supported labor for a number of years. With the year 2000 census just around the corner and the expectation that California will get between 3 and 4 additional seats in the House of Representatives his election will have additional importance. We should keep in mind that what we were able to obtain in 1970 with the enactment of the Postal Reorganization Act, congress could take this away with some sort of misguided legislation. A thanks go to all of you for turning out at the ballot box and supporting those who support us.

The branch will be holding an open house on Friday, December 4th beginning at 6:00 PM. If you would like to stop by and have some food and enjoy the holiday season take the time and join us.

## VICE PRESIDENT'S REPORT by CALVIN BROOKINS

Last month my article was about the Family and Medical Leave Act. This month I am writing about Sick leave for Dependent Care. The Family and Medical Leave Act and Sick Leave for Dependent Care are two different entitlements. FMLA is a federal law and Sick Leave for Dependent Care is a contractual right granted to letter carriers under our National Agreement. However they sometimes overlap, you may be covered by FMLA and Sick Leave for Dependent Care, while caring for a family member with a "serious health condition" as defined in the FMLA law. For the definition of a serious health condition see my article in last months MailCall.

Sick Leave for Dependent Care is a contractual right won for letter carriers by the union during our last contract negotiations. Under this provision our members are entitled to use up to 80 hours of sick leave per year. "To give care or otherwise attend to a family member with an illness, injury or other condition which, if an employee had such a condition, would justify the use of sick leave by that employee". Family members are a son or daughter, spouse or parent as defined in the ELM section 515.2,

Sick Leave for Dependent Care does not entitle employees to additional sick leave; rather you would use sick leave earned under the existing Postal Service sick leave policy. Medical documentation would be necessary only under the same conditions, as it would be necessary for you as a letter carrier to submit medical documentation. If management asks for medical for an absence of three days or less and the employee is not on restricted sick leave, the employee has to submit the documentation and file a grievance asking that the Postal Service to pay the doctor bill and related expenses.

If you are not sure whether an absence should be covered under FMLA or Sick Leave for Dependent Care ask your steward or call the union office.

#### Things to always remember:

Supervisors shall not require, nor permit, employees to work off the clock.

Article 41.3.K of the National Agreement.

Letter carriers may cross lawns while making deliveries if customers do not object and there are no particular hazards to the carrier.

Article 41.3.N of the National Agreement.

Do not inspect or load your vehicle while the engine is running.

Try to avoid backing your vehicle in all instances.

Report all accidents immediately.

Make sure all mail is removed from your vehicle before you end your tour.

## YOUR RIGHTS UNDER OWCP by ART BOCEK

#### **Health Benefits Refund Program**

Those injured employees enrolled in an Office of Personnel Management (OPM) approved health plan (such as NALC Health Benefit Plan or others) are entitled to continue coverage while receiving OWCP compensation benefits.

While on compensation disability benefits for the first year, OWCP deducts health benefit premium at the Postal Service rate. After 1 year OWCP will deduct the premium at the standard rate for federal employees.

Federal employees standard premium rate is significantly higher than the Postal Service rate; therefore, an injured employee enrolled in a health benefit plan who are in a leave-without-pay (LWOP) status for more than a year and are receiving OWCP compensation benefits maybe due a refund for OWCP's "over deduction" of health benefit premiums.

The following criteria must be meet by an employee for a health benefit refund:

- 1. The employee must be in an LWOP/injury-onduty status. Employees who are separated from the Postal Service are not eligible.
- 2. The employee must receive OWCP compensation payments with health benefit premiums deducted at the higher federal rate.
- 3. A period of at least one (1) year must have elapsed since the employee initially placed on OWCP compensation. Also, the employee needs to apply to the Postal Service at the installation where the employee last worked (i.e., refunds are not automatically paid).

After the employee has properly filed for a refund, the installation will complete Form 202, "Health Benefits Refund Program Payment Authorization"; obtain approval by the management Sectional Center (MSC) manager, the Division General Manager, or designee; and submit the Form 202 to the appropriate MSC or Division Finance Office for payment to the employee. A copy of Form 202 will be sent to the employee by the Finance Office.

Provisions covering the above cited subject matter can be found in USPS Employee and Labor Relations Manual (ELM) Issue 12, May 1989 and updated (see Subchapter 520, Health Benefits Program 525, special Circumstances Affection Health Insurance Coverage).

OWCP bills the Postal Service for the difference between the tow rates (i.e., OWCP will obtain the difference between the federal rate and the Postal Service from the Postal Service).

If you have problems in securing a refund, contact your NALC branch office or your National Business Agent (NBA) for assistance in learning about your rights in order to resolve your problem.
