PRESIDENT'S REPORT By Roger Askew

NATIONAL AGREEMENT

The latest news from Washington, D.C. appears in the recent issue of the NALC bulletin. Management has ended their testimony in front of the arbitration panel. The National Association of Letter Carriers began the rebuttal phase on Tuesday August 16th, 1999. I would expect the rebuttal phase to last from 5-8 days. After that both parties will submit written briefs to support their positions. Upon completion of this phase the arbitrator will have up to 30 days to render a decision. What does this mean to you and me? We should probably have some sort of decision towards the middle of September or the first couple of weeks in October. As soon as the final contract is announced we will be supplying each shop steward with a copy. From information I have been receiving, our national leadership is presenting a case that would make us all proud. The effort to secure a financial increase worthy of our labors has been pursued sparing no expense. We are all too aware that the main issue has to do with Article 9 and the salary and benefits we receive.

IN MEMORY - JOSEPH ILETO

I'm sure we are all horrified about the events that occurred on Tuesday August 10th. For an individual to take another persons life based solely on the fact he was a government employee and a person of a different race is beyond my understanding. All Joseph lleto was doing was earning a living for his family. Although I spend a lot of time and effort chastising management on how they run the post office, in this matter, upper management deserves some praise. Mr. Ordonez and the senior management staff in the Van Nuys Cluster did the right thing. From the moment the events took place, management had personnel in place to deal with the needs of the family and the needs of the employees at the Chatsworth Post Office. In addition to the personnel being in place, management paid for the cost of the funeral and the other expenses of the lleto family. Additionally, management saw to it that all of the carriers in Chatsworth who desired to attend the services were placed on administrative leave to attend. To those of you from the Van Nuys branch who delivered mail on Saturday in Chatsworth my thanks and appreciation. Each of those carriers from Chatsworth who I talked to told me the same story of how much they appreciated the effort of those who took their place for this day. Each one told me how deeply they were effected by the overwhelming response from letter carriers in the immediate area. Please take a moment to remember the lleto family and those carriers and clerks in the Chatsworth Post Office.

HIGH BLOOD PRESSURE.....

isn't being treated aggressively enough. Treatment should bring blood pressure down to 140/90 or lower. Yet in a recent study, only 7 % of hypertensives' whose readings were consistently above that level, go additional treatment. Self-Defense: If your readings remain elevated despite treatment, ask your doctor if your dosage should be increased....or if you should be switched to another blood pressure drug.


Family member's include--enrollees Spouse--Unmarried children under age 22, including illegitimate and legally adopted children, stepchildren and foster children, if they live with the employee in a regular parent-child relationship, are also covered. Certain unmarried children over the age of 22, who are incapable of self support because of a mental or medical condition, are also included.

ASPIRIN CAN HELP

Daily aspirin therapy can help people with adult onsent (Type II) diabetes, avoid heart attack. Aspirin has long been prescribed to prevent a second heart attack in those who have already had one. Emerging consensus: A daily aspirin tablet also helps these people avoid a first attack. Check with a doctor before beginning aspirin therapy.

C FOR THE HEART

Vitamin C seems to guard against heart disease. I a recent study, individuals who had recently suffered a heart attack had low levels of Vitamin C in their blood. Researchers theorize that Vitamin C helps prevent physiological processes that can trigger heart attack, including blood clot formation, and the rupture of fatty blockages in coronary arteries. Be sure to get at least 200 mg of Vitamin C per day, through diet or supplements. One cup of fresh orange juice contains 124 mg of Vitamin C.



VICE PRESIDENT'S REPORT By Calvin Brookins

On August 2nd I was called back to Washington DC as a possible rebuttal witness. While I was there I got to sit in on the last part of the NALC's direct testimony and the first part of the U.S. Postal Services direct testimony.

President Sombrotto closed out the direct testimony for the NALC. He reminded the Fleischli arbitration board that the Stark arbitration panel in 1994 did not reject an upgrade to level 6 for letter carriers. He noted that it was premature because only a small percentage of the nation that was on DPS at the time. The USPS has over 97% of all city offices on DPS at this time. There were also a 20 minute portion of a video shown about the informational picketing where the arbitration panel were able to hear from several picketing letter carriers from different parts of the country.

President Sombrotto also testified that the NALC supported automation and that the USPS made billions of dollars, what good for the USPS is good for letter carriers. Included in his testimony was the fact if all processing plants were fully robotized the mail will still have to come to the letter carrier in order for it to get delivered to the proper address.

His testimony also included how the APWU's most important issue in their contract negotiation was job security. NALC's priority is how the work of the letter carrier has changed, gotten harder and more difficult due to automation.

My opinion is that DPS has changed the letter carrier job, it puts the carrier on the street longer and forces the carrier to handle mail on the street that he/she would have other wise handled in the office prior to going out to the street. Some people refer to letter carrier office work as soft time and street work as hard time, with automation you the letter carrier are doing more of that work that is considered hard time.

The USPS begins their testimony:

The first witness for USPS was John (Jack) Potter, Senior Vice President of operations he was also the head of the negotiation teams which involved separate negotiations with four different unions. His testimony included a wide range of items such as the agreements reached with the clerks, mail handlers, and rural carriers.

He states that the letter carriers job has changed, but there have not been enough changes to what a carrier does to warrant level 6 pay. That is a real creditable statement from someone who was hired in as a casual carrier back in 1978 and hired as a clerk after that casual term was up what does he know about carrying mail (nothing). He also testified on cross-examination that carriers job for all intensive purposes have not changed prior to DPS to after DPS.

He testified that NALC should get the same contract that the other unions settled for because if the NALC get anything different they will have to hear it from the other unions and that the other employees are craft employees also. He also testified that it must be a fair contract because the APWU ratified it 2 to 1, he failed to mention that only 40% of the APWU's membership voted for that ratification. He also states that it was fair contract because the rural carriers union bought in to it, by the way the rural carriers union had negotiated what is referred to as a me to clause. Which allows them to take

whatever one of the other union gets as far as a contract is concern. Why they took what the APWU settled for is beyond me. It might have been smart to wait and see what the NALC got.

He also testified that the agreement with APWU allows contracting out for anything that the USPS had plans for within the next 18 months. (Their contract is only for 2 years) Contracting out was a big issue for the APWU. He also testified that the postal service gain an advantage over APWU as far as the cap on casuals is concern, they went from 6% across the country to 15% within an AP to be monitored at the district level.

I do not know if he was testifying truthfully, but since he was under oath I would like to think so. If he was then I would have to agree with a remark that I heard on crossexamination. A SCAM IS A SCAM IS A SCAM.

SPECIAL REPORT By

Pursuant to Article 6 of the Constitution for the Government of Subordinate and Federal Branches the following report is submitted to the membership for review. The report covers the term ending July 1999.

GRIEVANCE ACTIVITY

Since July of 1997 the branch has processed 1198 grievances against management for violations of the National Agreement. There are 2 cases pending at the Step 3 level along with 19 grievances that have been certified for arbitration by the National Business Agent. All of the grievance activity since 1993 has been logged on the office computer and each shop steward is supplied updated reports when ever they are requested. We now have the capability to track grievances by office and by any individual.

FIDUCIARY RESPONSIBILITY

The end of June shows a balance of \$ 97,132.29. Four times during the last two years the Trustees have conducted regular audits of the branch books and all was found to be in order. The branch has maintained the practice of informing every member by publishing monthly reports that are available at the regular monthly meetings. The Financial Secretary has seen to it that all of the required reports have been filed with the Department of Labor and the Internal Revenue Service.

EDUCATION & TRAINING

The process of Education & Training is an ongoing one. During the annual budget meetings held in February of each year the membership has chosen to budget approximately 10% of the yearly income of the branch to see that training is received. The branch has continued to send members to the Health Benefits Seminar each year. Three training sessions were held for shop stewards. We have held two training sessions at the Branch office that have been conducted by the national business agent office. We have held sessions for the Tarzana, Encino, Civic Center, Panorama City and Sherman Oaks offices on the proper method of route inspections. In addition, we continue to encourage attendance at all training sessions held in conjunction with the state and national conventions. The national business agents office always conducts training sessions prior to the state convention and each day of a national convention training sessions are held prior to the daily business sessions. I can report that all of the shop stewards who were delegates were in attendance at the Contact Administration Units training session that was conducted by Executive Vice President Bill Young along with the other resident officers in Las Vegas, Nevada.

CONVENTIONS & SPECIAL MEETINGS

In August of 1998 the branch sent 26 delegates to the national convention held in Las Vegas, Nevada. The state convention was held in Burlingame in May of 1998. Over the three


days of business at the state convention there were 10 delegates that were in attendance. The branch authorized the Branch President to attend one C.O.P. (Committee of President's) meeting that was held in San Antonio, Texas. The Treasurer attended a seminar held in San Diego, California in May of 1998 for the purpose of fiduciary responsibilities. I also attended two Special Sessions that was called for by President Sombrotto. One in April of 1998 and another in May of 1999. Both of these sessions were held in Chicago, Illinois.

RECOGNITION

Over the last two years two of our members continue to be legislative liaisons for the 24th and 26th Congressional districts in California. Velma McClinton has the position in the 26th district (Howard Berman's) and Robert Johnson holds the title in the 24th district (Brad Sherman's). Calvin Brookins continues to be the D.P.S. Co-ordinator for the southern section of the Van Nuys District. His knowledge can only help the membership as he is now also working as a local business agent for the National Business Agent office and doing arbitration cases for letter carriers. Velma McClinton continues to represent carriers in her capacity of District 6 officer for the C.S.A.L.C. (California State Association of Letter Carriers) Angela Chang continues to receive the William Doherty Scholarship. Only 15 of these awards are given out each year and this is a tremendous honor for Angela. The branch presented three Gold Cards to members that have been in the National Association of Letter Carriers for over Fifty years. In January I presented a card to past President Harry Brenneman in Tucson and in October we honored Frank Brash and Bernard Siegel for their commitment to this union.
