VICE-PRESIDENT'S REPORT By Art Bocek

Timely Notices to OWCP

Once an employee completes a Form CA-1 or Form CA-2, and gives the completed form to a supervisor, management has the responsibility to submit the form to OWCP in a "timely manner." After receiving a completed form from an employee, under {20CFR 10.102(a)} the completed form must be submitted within 10 working days to OWCP. When a Form CA-7 is submitted by an employee to a supervisor, under {20 CFR 10.106} the completed form must be submitted to OWCP no later than 5 working days from the date of receipt.

When you file a Form CA-1 or Form CA-2, at the bottom of the form is an area whereby the receiving supervisor is to give back to the employee a signed and dated portion of the form. From the date of receipt, management's time limits start. You "MUST" get the signed receipt from the supervisor. Also, you need to photocopy the claim form in order to protect one-self from either misplaced, lost, or noncompliance of submission of your claim to OWCP by management.

If you do not receive a postcard receipt from OWCP indicating that they have received your claim for compensation within 30 days, you need to contact either your steward or the union office and ask for assistance in determining as to why you have not received a receipt of your claim by OWCP. Ten (10) days after submitting your claim to your supervisor, you should call the Injury Compensation Office and find out if your claim form was received from your supervisor and the date Injury Compensation Office sent your claim form to OWCP. If the Injury Compensation Specialist indicates to you that your claim form had not been received, call either the union office or request to see your steward for assistance as soon as possible.

If management for any reason fails to submit your claim or any claim form in a "timely manner," you need to stand up for your right's and file both a grievance, and an EEO Complaint. Management may have violated regulations contained within the Federal Employee Compensation Act (FECA) and the above cited federal regulations regarding the Postal Services requirements in the "timely submission" of OWCP forms.

What every employee needs to remember when dealing with management is: "Management's is only concerned with its "Almighty" budget, loss time hours, and bonuses, and not your paycheck, or career because of an incapacitation due to either an on the job injury or illness."

Remember, "The more you sweat and toil over learning rules and regulations, the less you will_bleed from battle with management".

The Union's message is clear and direct, Postal reform is vital for job security. United States Postal Service has been a great success and is worth preserving for the benefit of the country. But technology is changing the postal industry and the USPS is not viable over the long run without legislative reform and a bold action to boost revenues.

WHERE WE ARE

The Postal Service is in trouble; mail volume is falling. the short-term results of why is the weak economy, the terrorist attacks of 9/11/01, and Anthrax. Long term, electronic alternatives to first class mail. More and more people are using computers to pay their bills and to correspond with each other through such avenues as e-mail and cc-mail. The USPS is slashing employment, 50,000 jobs cut since 1998, 14,000 of those were city carriers, and quality of service is in jeopardy. Financial crisis looming, The USPS is losing hundreds of millions of dollars despite rate hikes. The USPS is \$12 billion in debt nearing legal limit of \$15 billion. In the year of 2002 we experienced a triple whammy, an economic recession. September 11th, mail revenue off by \$1.5 billion in first quarter (10%), Anthrax attacks, mail security costs top \$1.25 billion. In fiscal year 2002 there was a mail volume meltdown, worst year since the great depression.

During the years of 2000, 2001, and 2002 there was financial fallout, mounting losses of \$200 million in the year of 2000, \$1.7 billion in 2001. \$0.7 billion in 2002. There were also three rate hikes in 18 months, January 2001 (4.6%), July 2001 (1.7%), July 2002 (7.7%). There was also cost cutting in the year 2002, there was a 5% cut in work hours and 23,000 jobs cut. In short the United States Postal Service liabilities exceeded its assets.

WHERE ARE WE HEADING

The rising cost of universal service, in 2002 the United States Postal Service provided daily service to 138 million households and businesses six days a week. Operated 38,000 post offices and stations, deployed 215,000 vehicles and trucks. Universal service is costly: \$29 billion. Overhead costs are growing; the USPS adds 1.8 million new delivery points to its network each year. Requiring the creation of 3,000 new routes and the hiring of 4,200 new carriers per year. There is also the construction of 80 new Post Offices each year at a cost of \$5 million each.

Rising retirement costs, FERS and CSRS pension costs will raise to \$11-14 billion in 2010, depending on reform of CSRS funding law. Retiree health benefit costs (FEHBP) soaring, \$858 million in 2001 to approximately \$2.0 billion in 2010, \$48 billion of unfunded liability and \$5 billion a year to the fund. The demand for letter mail is falling, letter mail is the core of our business the USPS depends on letter mail. First class and standard A mail amounts to 80% of the revenue. Mail mix is as important as the volume of mail. First class is the most important mail it pays a majority of overhead costs. Here is a breakdown of the revenue composition for FY-2002, first class amounted to 55% of revenue; standard mail mostly advertising amounted to 24%, priority 7%, package services 3%.

Here is a different breakdown for you, lets look at volume first class mail accounts for 50% of the volume and other mail accounts for the rest. Revenue, first class mail accounts for 54% of the revenue and other mail accounts for 46%. Contribution to overhead costs first class mail covers 66% of the costs and other mail covers 34% of the costs. As you can see first class mail carries the load. General Accounting Office has projected that the mail volume growth in the years of 2004-2008 will be a decline. Key factors explaining decline, elec-

tronic substitution such as electronic fund transfers, e-mail, and electronic bill paying. The Government leads the way in this area with IRS e-filings, Social Security direct deposits, congress post anthrax e-mail, and PRC electronic rate cases.

Obsolete Postal Law. Postal Reorganization Act (PRA) limits the USPS ability to respond to crisis, here is how (PRA) limits the USPS, it restricts volume discounts and service contracts. Prohibits joint ventures, no retained earnings for investments, it takes ten months to raise rates, and it lacks flexibility. There are no seasonal sales and there are no fuel surcharges. In other words cost cutting is favored over raising revenues, we have an outdated rate making system and there are limits on commercial freedom. The bottom line is the problem is structural, there are no easy answers, and reform is necessary.

WHAT IT MEANS FOR LETTER CARRIERS

Jobs: City carrier employment depends on the USPS Wages: NALC success in collective bargaining depends on Benefits: Any taxpayer bailout will threaten postal benefits.

When you look at falling volume, increasing overhead per piece of mail, rising postal rates, and continued falling volume, it becomes a postal death spiral.

What does all of this mean, simply put; we must deal with structural and operational problems. We need postal reform now.

WHAT NALC MUST DO

First lets look at the NALC's agenda in Congress. We must first secure CSRS funding legislation to provide stability for reform. Then we must advocate or oppose recommendation of the Presidential Commission on the USPS. We must also work with mailer and other Unions and new leaders on Capitol Hill to achieve bipartisan postal reform legislation.

Now let's look at the NALC's agenda at USPS headquarters. We must take advantage of stability through 2006 to work on important workplace issues. Such as joint route evaluations, system to identify, intervene and fix troubled work sites. Customers connect, (using carriers as sales agents and other revenue generation tests).

NALC's agenda in the workplace. Build on progress to create a new culture in the workplace. Such as joint letter on violence, JCAM, Dispute Resolution Process. The goal is to shift focus of NALC locals from grievance handling to grass roots organizing for postal reform and other aims.

NALC's agenda in the Branches. To preserve city carrier jobs in the long run, Branch Presidents must become experts on postal reform and the postal business. Branch activists must educate and mobilize members to press Congress for reform. Branches must educate the politicians and the public about the need to preserve the USPS.

The NALC has a reform checklist it is, commercial freedom for the USPS, new revenues/services to replace lost volume. Sensible rate setting process. Maintain universal service, and protect collective bargaining. It is hopeful that this article will help you to realize the state of the postal service and the NALC's role in preserving the USPS and our jobs.

You must have a USPS PIN # to access these programs through Postal Ease. Legislative Alert has again reminded us of the importance of writing to our Representatives in Washington, DC regarding Bills S-380 and HR-735. These bills have a direct effect on Postal business and our jobs. Take time out today and write a quick note telling them of your support for these bills. If we dont take the time to help protect our jobs then who will? NALC in Washington is currently trying to complete a system with the Postal Service to allow you to make a deduction to COLCPE directly from your pay check.
