PRESIDENT'S REPORT By Calvin Brookins

AUTOMATIC COLCPE

Voluntary withholding for COLCPE is now available using PostalEASE System. As I informed you in the October issue of the MailCall a letter from NALC President William H. Young has been mailed to all active members with information on how they can contribute to NALC's Committee on Letter Carriers Political Education (COLCPE) through payroll deductions. Easy to follow instructions appear on the reverse of the letter, advising NALC members to use PostalEASE to initiate voluntary withholding of COLCPE contributions. I suggest that any who have not signed up for COLCPE contributions using PostalEASE should consider doing so immediately.

The projected accumulation for the third regular costof-living adjustment under the 2001-2006 National Agreement declined for the third consecutive month to \$57.20 based on the CPI-W for December. The \$57.20 projected increase equals 2.75 cents per hour or \$2.20 per pay period.

NALC LEGISLATIVE ACTIVIST PROGRAM

Now that thousands of letter carriers have signed up to be NALC's legion of legislative activists and Congress is starting hearings on postal reform, NALC President William H. Young is transmitting his first e-Activist message. Look for the message on your computer and take action accordingly.

For those who have not yet signed up, you can do so by going to the union's website, www.nalc.org. Signing up will enable members to contact legislators and other public officials via the Internet when urgent action is necessary. After entering their e-mail addresses, members will be transported to a page containing an information form that, when completed, will put members on a list for periodic updates on legislative and other matters affecting active and retired letter carriers.

For those who do not have access to a computer contact the union office and I will supply you with a form that you can use to sign up as a legislative activist.

It may be the union's fault for not being able to instill into letter carriers the history, pride and utmost importance of union membership; and we should try harder to do that. However, the decision to become or remain a scab is an individual choice and is a clear reflection of the character of the individual, not a failure of the union.

Jack London aptly described the character of a scab in his classic essay that went like this:

"After God had finished the rattlesnake, the toad, and the vampire, he had some awful stuff left with which he made a scab. A scab is a two-legged animal with a cork-screw soul, a waterlogged brain, and a combination backbone made of jelly and glue. Where others have hearts, he carries a tumor of rotten principles...There is nothing lower than a scab."

Membership in the National Association of Letter Carriers is not mandatory, yet 92% of the letter carriers throughout the nation are proud members. Only 8% are freeloading non-members, and whatever reason they may give to justify being a scab, the real reason is that they are cheap, self-centered individuals who don't give a damn about anyone or anything that doesn't give them immediate personal gain. When I hear some of the pathetic excuses being used as a reason to quit or not join the union, I want to puke.

Those of you who have been here a while should enlighten our new brothers and sisters as to how management can be without the vigilance of the Union. The atmosphere in which you work, the overtime you are paid, the vacation you are guaranteed and every other right and benefit you enjoy was fought for and won by your union. These rights and benefits will be kept and maintained only if you are wise enough to understand that it is you who are the union and you must constantly maintain a vigil over your hard won rights and benefits. Your officers and stewards are only as strong and effective as you make them. If you are weak and disorganized, your union will be weak and disorganized. If you let individuals bad mouth the union on the floor without responding, you weaken your union. When you talk and joke with a scab, you weaken your union.

Every union leader that has served carriers for any length of time knows the frustration of trying to motivate members into being active, caring brothers and sisters, but it can and must be done. Let me leave you with one thought. The principles and ideals of unionism are more important today than ever. In a world full of people whose main focus is "me", your union is a vehicle of "you". It is a vehicle that allows you to do the right thing, not the most expedient thing. It allows you to take the time to ask, "How are you, what can I do to help?"

As you age and mature, you will understand that there is nothing more important than what you have done for others. You will realize that cutting your brothers and sisters' throat for a lousy hour of overtime and just taking care of yourself will come back to haunt you when you are forced by age or health to reflect on what you have done with your life. He union is family, and we support family right or wrong, through thick and thin. If you are a union member, never quit. If you are not, join now! All letter carriers, speaking with one union voice, can say to management loud and clear, "Don't mess with family!"

VICE-PRESIDENT'S REPORT By Art Bocek

Postal Inspectors/ Your Rights

Letter Carriers are all too frequently being called into the Postal Inspectors' office for investigatory review without union representation. Because of this fact, there are fewer carriers working for the postal service. It is paramount to your job and career that <u>you</u> understand the role of the inspectors and your rights. I have in the past written on this subject, but it is most important to remind even an experienced carrier not to mention newer members who might be brought into the office for an <u>"Investigative Interview."</u> For the new and some of you "Lifers," her are some questions and answers <u>you need to know</u>.

Who are the postal inspectors? What do the postal inspectors do? What rights do letter carriers have? Postal Inspectors are employees of USPS. They are neither craft nor management's, but a separate part of the USPS. What do they do? They investigate mail fraud, mail theft, and they also investigate employees. They monitor the day-to-day operations of the USPS. They also prosecute employees plus they harangue-and arrest employees.

So what can I as an employee do to help myself?

- Be professional and do your job in a proper manner at all times
- 2. KNOW your rights and EXCERCISE your rights!
 - A . Contractual: Article 17, Section 3, Paragraph 5: "If an employee requests a steward of Union Representative to be present during the course of an interrogation by the Inspection Service, such request will be granted."
 - B. Weingarten Rights: "...The right to have Union Representation during investigatory interviews, or if the employee believes that discipline may result from the investigatory review.
 - C. Miranda Rights: You have the right to remain silent; anything you say can be used against you in a court of law. You have the right to the presence of an attorney prior to questioning and to be with you during questioning if you so desire; if you can not afford an attorney, you have the right to have an attorney appointed for you prior to questioning. Do you understand these rights? Will you voluntarily answer my questions?"
 - The right to know the purpose of the interrogation prior to questioning.
 - E. The right to have criminal charges read and Miranda Rights read prior to questioning.
 - F. The right to refuse to answer any questions should the investigatory interview become accusatory.
 - G. ELR Manual, Section 666.6: Cooperation in investigations: "Employees will cooperate in any postal investigation."

Once a carrier has been given his/her Miranda Rights, the best you can do as a shop steward is to advise the carrier to not sign anything or make any statements until he/she has engaged in legal counsel! What is the role of the shop steward or Union Representative during the investigation by the Postal Inspection Service? Stewards have the right to know the purpose of the interrogation; to have private conversations with the aggrieved carrier prior to guestioning; to call time-out at any time during the interrogation, and as many times as he/ she feels necessary; to give advice, ask questions and actively recommend a course of action during the interrogation; to brig out facts favorable to the carrier during the interview. Stewards also have the right to keep the carrier from being intimidated and harassed during the interview, and to keep the carrier from incriminating himself/herself.

Stewards do not make deals with Postal Inspectors, just as the Postal Inspectors do not determine the penalties. As a steward, you always conduct yourself in a professional manner, as you can be asked to leave the interview if you shout, scream or use obscene gestures. Remember, it is your job as a steward is to represent and protect! If a steward feels that a Postal Inspector has acted in less than a professional manner during the interview, you can protest these actions to the Inspector General of the Inspection Service. Postal Inspectors do not determine the penalties. Steward may interview Postal Inspectors, may cross examine, and may ask for the Postal Inspector's notes, as those notes are the foundation for discipline. The proper remedy to ask for when Article 17, Section 3, rights and Weingarten Rights have been violated, or when Postal Inspectors refuse the union access to their notes or refuse to be interviewed is: "The employee is to be made whole; reinstated; completely exonerated. and the matter is to be expunged from the employee's file or records."

Remember, "Rights are like muscles, the only rights you have are the rights you exercise."
