PRESIDENT'S REPORT By Calvin Brookins

First of all I would like to thank the branch for sending me to the California State Association of Letter Carriers Convention in Palm Springs. I believe it was well worth it, the stewards were able to get some valuable insight from the training that was done by the National Business Agent's office. Those stewards who attended the casual/complement training done by RAA Joan Hurst seems to have gotten a lot of interesting information from that training. Some of the delegates and stewards attended the OWCP training done by RAA Manny Peralta, which they was able to get more out of than any other OWCP training in the past.

Overall I think the training and convention went very well there was a lot of information dissiminated over that weekend. From what I gathered I from President Bill Young's presentation the mail verification process we just went through is some kind of effort to adjust routes in the future using data from a certain month during the year. Example, the carrier, the union and management will pick a month, they will look at how much time it took that carrier during that month if all parties agree then the route will be adjusted to that time. So if all parties pick the month of September and it took the carrier 9 hours a day to do that route during that time period the route will be adjusted accordingly. There may be more to exactly how this process will work, and I am sure we will be given more information on this in the near future such as at the National Convention in Hawaii.

H.R. 4341 Headed to House Floor on 40-0 Vote; Retains Bargaining Rights and Six-day Delivery

Letter carriers won a significant victory on the road to postal reform May 12 when the House Government Reform Committee voted 40-0 to report out H. R. 4341, The Postal Accountability and Enhancement Act of 2004, and send it to the House floor. It was the first time in over three decades that major postal reform legislation has won committee approval in the Senate or House. The bipartisan document contains several points critical to the NALC and letter carriers. This bill includes retention of universal service to all Americans, six day delivery of mail, and Private Express Statutes, and the continuation of collective bargaining rights. A new postal regulatory commission would not have power to alter collective bargaining agreements or establish pay comparability standards. Just as Bill Young said, "While it is not a done deal...this is a good first step".

Retiree/COLCPE

As I reported in last month issue of the MailCall, retired members of the NALC are now eligible to make voluntary contributions to the Committee on Letter Carriers Political Education (COLCPE) from their monthly annuity payment under the Civil Service Retirement System (CSRS) or Federal Employees Retirement System (FERS). The Office of Personnel Management (OPM) has approved the NALC's request for the change.

In order to participate in this manner, retirees must have both a Civil Service Annuity (CSA) claim number and their Personal Identification Number (PIN) available. (To obtain a PIN, contact OPM either by telephone at 1-888-767-6738, in writing at Office of Personnel Management, Retirement Operations Center, Boyers, PA. 16017, or via the Internet at www.opm.gov

If you plan to start your COLCPE allotment by telephone, call 1-888-767-6738 and speak with a customer service representative.

If you choose the very quick and simple Internet method, simply go to www.opm.gov and click on "Employment and Benefits", then "Retirement Benefits." Under "How do I," scroll to "Set up an allotment to an organization" and click "Go." After reviewing the next page, scroll to the bottom and click "Yes" which will allow you to enter your CSA number and PIN. Once these numbers are inputted, click on "Set organizational allotment" which will allow you to scroll and select "Natl Assn of Letter Carriers-COLCPE." Enter the amount of your monthly contribution, click "Submit" and it is done!

You will receive a confirmation from OPM in the mail giving you the date your first allotment will begin.

I am hopeful that this information will help the retirees of the branch in participating in the payroll type contribution to COLCPE that the active letter carrier now have. This should make it easier for retired members to participate.

Fourth COLA

The projected accumulation for the fourth of eight regular cost-of-living adjustments under the 2001-2006 National Agreement stood at \$416.00 following release of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for April. The \$416.00 annual accumulation equals 20 cents per hour or \$16.00 per pay-period.

VICE PRESIDENTS REPORT ART BOCEK

Compensation by OWCP for Disability, Form CA-7

According to Section 545.8 of the ELM, when the medical evidence shows that a disability resulting from traumatic injury is expected to continue beyond 45 day period, the employee is to be given a Form CA-7 "by day 30" of the COP period. The employee completes the front side of the Form CA-7, the control office (Injury Comp.) completes the reverse side, and sends the completed CA-7 with any accompanying medical documentation to OWCP "by day 40" of the COP period. When a disability is the result of an occupational disease or illness, Form CA-7 is completed and submitted to OWCP "not more then 5 working days after receipt from the employee" (as if this will ever happen in our life time.)

You ask me, why am being so cynical? Well, I have been assisting letter carriers in receiving benefits and I just don't know how to say the way I feel about management's mistreatment of employees after requesting benefits without using a few expletives that are just plain not printable on paper. Management demands of it's employees that you work in a safe manner but then drives you to do more and more, in less and less time. After a claim is filed by you for benefits, you then become one of the "unclean." Management all to often issues discipline without proving "just cause" or just because of the mere fact an accident happens, therefore, "you must be at fault." Management needs to understand and accept the fact of life that employees are going to get hurt or sick on the job and it the management's responsibility to make sure you are taken care of in both medical and financial needs. Since management is always telling how good they are and what they are doing for the good of the company, maybe we the employees should work in the same manner as management in the chart below? So I will leave it up to you fellow brother and sisters and to your good judgment to review the latest OWCP's "CA-7 Submission Timeliness Report" and make your own judgment on how management takes care of its employees in getting and keeping financial needs to an injured or ill employee and see if my cynicism is correct. What kind of a report card are we seeing in regards to how management makes sure the injured or sick employee are taken care of in a timely manner or is management just starving the employee back to work by delaying benefits owed to the employee? This is you vice president, I welcome your comments.

CHANGE # 1

Proposed to amend Article IV, Section which now reads:

The members of this Committee shall not be candidates for the election. The names of the Committee shall be sent to and posted at all carrier units. The names will be published in The Mail Call.

Proposed to Read:

Section 7. The President shall appoint an Election Committee and Chairperson as soon after the Meeting in which nominations are made, as possible. The members of this Committee shall not be candidates for <u>a contested office/position</u>. The names of the Committee shall be sent to and posted at all carrier5 units. The names will be published in The Mail Call.

CHANGE # 2

Proposed to amend Article IV, Section 12 which now reads;

Section 12. (A.) If an elective officer, or representative of the Branch is absent three (3) Meetings without having been excused by the Branch, or if a person resigns his office, his office shall then be declared vacated in accordance with Article X of the National Constitution. Government of Subordinate and Federal Branches and an election held to fill the office in accordance with Article V of the National Constitution of the NALC. Any branch officer who is assigned or appointed to any Branch, State or National assignment or appointment shall be considered excused from any and all Branch meetings during the assignment or appointment. However, the Branch Officer must request such excuse to the Branch within thirty (30) days from the last months meeting of such assignment or appointment.

Proposed to read:

Section 12. (A.) If an elective officer, or representative of the Branch is absent three (3) Meetings without having been excused by the Branch, or if a person resigns his office, his office shall then be declared vacated in accordance with Article X of the National Constitution, Government of Subordinate and Federal Branches. Any branch officer who is assigned or appointed to any Branch, State or National assignment shall be considered excused for that meeting & considered present for attendance purposes.
