PRESIDENT'S REPORT By Calvin Brookins

Route Inspections

As I write this article Sherman Oaks 91423/91403 zones, Panorama City 91402 zone and Encino 91436 zone are all preparing to go through a six (6) day count and route inspection. By the time this publication of the MailCall is received in your homes these stations will have gone through a route inspection class put on by RAA Chris Jackson from our National Business Agent office.

The NALC at the National level has put together route inspection material which includes a special pocket-size handbook. This special pocket-size handbook will be sent to every active letter carrier member to assist them in protecting their rights during the week of count and inspection. The route protection pocket handbook is an easy to handle reference for carriers, which highlights major route inspection and adjustment procedures. Hopefully the pocket size handbooks will be in your hands soon.

Call me a skeptic, but I seriously doubt that the upcoming route inspections will do anything but properly adjust the routes to eight hours. I believe that our current route inspection system is flawed and over the years of seeing route inspections and adjustments do nothing but cause frustrations between the supervisor and the carrier, has convinced this writer that as long as we continue to use this system we will most of the time not get route properly adjusted. I am a firm believer that the only way to get fairly adjusted route in today's world is to adjust the route according to how long it actually takes that carrier to do it. Instead of adjusting the routes based on averages.

Management inspects and adjusts routes in the spring when mail volume is lighter. Then a higher level manager tells you that they are aware that in the months of September, October and November the mail volume will be higher and it will take you longer. But as soon as those months arrive here comes your supervisor fresh out of ASP taking everything that they were fed literally with DOIS in hand and telling you that you can or should be doing your route in less time.

So exactly what did the route inspection and adjustment that you had while the mail was lighter in the spring time do for you "absolutely nothing"? Makes you wonder "what is it good for".

So carriers that mean that we will have to watch them very closely, and make sure that they do everything within the con-

New Reform Bill

Chairman Susan Collins (R-ME) of the Senate Homeland Security and Governmental Affairs Committee, proposed her long awaited version of the Postal Accountability and Enhancement Act of 2005 in the U.S. Senate March 17, setting the stage for months of critical debate on major reform of the U.S. Postal Service. Her offering of S. 662 follows introduction of a similar bill (H.R. 22) with the same title in the House of Representatives earlier this year. Passage of the legislation would be the first significant reform in more than 30 years.

Joint Statement on Violence and Behavior in the Workplace

In brief, the language contained within the "Joint Statement on Violence and Behavior in the Workplace," is quite clear regarding the USPS as an institution and all of us who serve that institution must firmly and unequivocally commit to do everything within our power to prevent any incidents of work-related violence for the basic right of all employees to a safe and humane working environment to prevail. We all know in our daily work duties sometimes there is good possibility of a heightened level of stress in the workplace; but still there is no excuse for and will be no tolerance of violence or any threats of violence by anyone at any level of the Postal Service; and that there is no excuse for and will be no tolerance of harassment, intimidation, threats or bulling by anyone. Each and every employee at every level of the Postal Service should be treated at all times with dignity, respect and fairness. The USPS needs to serve the public efficiently and productively and the need for all employees to be committed to giving a fair day's work for a fair day's pay, but this does not justify actions by management that are abusive or intolerant because they are "Making the Numbers" or an excuse for the abuse of anyone. Those who do not treat others with dignity and respect will not be rewarded or promoted and those whose unacceptable behavior continues will be removed from their positions.

Obedience to Orders

Under Section 666.51 of the ELM, an employee must obey the instructions of their supervisors. If an employee has reason to question the propriety of a supervisor's order, the individual will nevertheless carry out the order and immediately file a protest in writing to the official in charge of the installation, or appeal through official channels.

Maintain Mutual Respect Atmosphere

Section 115 of the M-39, sets out the basic rules and rights governing management and employees in their dealings with each other, but it is the front-line manager who controls management's attempt to maintain an atmosphere between employer and employee which assures mutual respect for each other's rights and responsibilities.

The only time one can refuse to comply with an order is when such an order is either illegal, immoral, or an unsafe act. Don't let "Miss-Management" bait you into a situation, whereby, you now must defend your position, or actions. Let management be the offenders of the "Joint Statement on Violence and Behavior in the Workplace." Let management be the ones defending a position for their careers because of inappropriate actions.

Here are some of the highlights of this proposed bill:

It would protect postal employees' rights to collective bargaining while streamlining the impasse resolution process with mandatory mediation.

It would provide the Postal service with greater flexibility to adjust rates of competitive services.

Repeal the escrow account provisions of the Civil Service Retirement System (CSRS) pension funding reform law, saving the USPS some \$3 billion per year and return to the Treasury Department the liability for military pension benefits earned by former soldiers who now work for the USPS.

Mandate changes in workers' compensation benefits for postal employees, including a three day waiting period before continuation of pay (COP) benefits commence under OWCP and the conversion into a retirement annuity at age 65 of workers' compensation benefits earned by totally or partially disabled postal employees.

The NALC opposes the workers' compensation changes in the bill, but supports advancing postal reform through the Congress. Pay attention to the NALC website for any action plan they may come down from NALC Headquarters.

COLA

The projected accumulation for the sixth of eight regular cost-of-living adjustments under the 2001-2006 National agreement stood at \$156.00 following the release March 23rd of the Consumer Price Index for CPI-W for February.

Thrift Saving last open season:

Over the past two decades, letter carriers and other federal employees have been given just two chances per year to start contributing to the Thrift Saving Plan if they were not already doing so. During these twice a year open seasons they could also adjust the level of their contributions and how much money was invested in the various TSP funds. But the upcoming April 15- June 30 open season will be TSP's last, and every day will be an open season.

Last December Congress passed a law to eliminate open seasons after the federal retirement Thrift Investment Board which administers the TSP, told lawmakers its new computer record keeping system would allow participants to begin and change contribution levels at any time.

At the April 5, 2005 branch meeting I had the pleasure of presenting Mike Brash his 50 year Gold Card. It is really great when you can look around and see men who have been members of this great union of ours for 50 years. Regardless of what anybody tell you 50 years is a long time to do anything. I commend all of the Gold Card members of Branch 2462, because they are the ones who paved the way for those of us

who are still active letter carriers. They are a major reason why we enjoy the benefits that we have today.

On behalf of Branch 2462, I would like to congratulate Mike Brash and wish him well and hope he enjoy the benefits of his well deserved Gold Card.

Finally I would like to take this opportunity to thank the members of Branch 2462 for their support over the last two years. I would also like to thank them for the confidence that they have in me and for allowing me to represent the branch for another term. As I was nominated for President and elected by acclamation.

For those of you who have the NALC Health Benefit Plan you may be happy to know that you can fill your long-term maintenance medicines line at www.Caremark.com. It's an easy-to-use online pharmacy, and much more. You can also find the latest health and drug information. If you have longterm maintenance medicines that you take on a regular basis, you may consider taking advantage of using the online pharmacy for: Convenient 90-day prescriptions, Lower out-ofpocket costs, Easier refills, Timely refill reminders, and Useful prescription estimates. You will need to register the first time you visit even if you have used RxRequest.com in the past. This protects the privacy. The one-page registration form will ask for a few lines of information and it will ask you to create a user name and password for yourself. The next time you visit the site, all you will need to enter is your user name and password. It's that simple. To order a prescription the first time, print out and complete a mail service order form from the site and mail it to Caremark with your doctor's handwritten prescription. It is important that you ask you doctor to write your prescription for 90 days with refills. Your order will arrive by mail in 10-14 days.
