## PRESIDENT'S REPORT By Calvin Brookins

I would like to start my article this month by thanking all of the members for having the confidence in me and again electing me as President by acclamation. I would also like to thank the Executive Board members who chose not to run for re-election for a job well done. Finally I would like to congratulate all of the Executive Board members and the shop stewards who were elected for another term.

Again with route inspections and postal reform looming, and all of the other changing working conditions that letter carriers are having to deal with, we have some tough times ahead and some difficult challenges to deal with. I promise I will put my best efforts forward and together we will face all of the challenges that come our way and deal with each and every one of them.

#### **Postal Reform**

Letter carriers should familiarize themselves with H.R. 22 and S. 662, These are bills that are currently in the House of Representatives and on the floor of the Senate that will deal with postal reform. These bills if passed could make major changes to the Postal Service as we know it today. They will have direct impact on the Postal Service.

H.R. 22, the Postal Accountability and Enhancement Act, was introduced to the House of Representatives by Representative John Mchugh a Republican from New York. Other key persons involved with the bill are Tom Davis, a Republican form Virginia, Henry Waxman, a Democrat from California, and Danny Davis, a Democrat form Illinois.

This legislation is similar to the postal reform legislation introduced in the House during the last session of Congress. The House Government Reform Committee drafted the final language and the Committee by a unanimous vote of 39-0, sent the bill to the full House for consideration. This bill has a strong bipartisan support.

The NALC has endorsed H.R. 22 as voted out of committee. H.R. 22 will allow needed reforms to our current postal regulations that would bring much needed revenue back to the Postal Service while still retaining the current benefits and bargaining rights we participate in.

We will continue to support the bill unless negative amendments, that would hurt our benefits, are added during the debate. In order to prevent this from happening, please take the time when called upon to contact your Congressional Representative and ask them to take the action requested by the NALC.

Republican leaders in the House decided to put off until after the July 4th recess any floor debate or votes on H.R. 22.

The Senate bill, S.662, was co-authored by Senators Susan Collins, a Republican from Maine, Tom Carper, a Democrat from Delaware and George Voinovich, a Republican from Ohio. The two bills are similar in many ways.

The Senate Homeland Security and Governmental Affairs Committee voted on June 22nd 15 to 1, to approve postal reform legislation drafted by Chairman Susan Collins (R-ME) and Tom Carper (D-DE) and send it to the Senate floor. This is the latest action on the long road to revamp the 1970 Postal Reorganization Act.

The only vote in committee against the bill came from Senator Tom Coburn (R-OK), who voice White House objection to a provision that would transfer from the Postal Service to the Treasury Department responsibility for paying military pension benefits of retired postal employees. USPS is the only government agency required to pick up such costs.

### Renewing Prescription's with Caremark & Telephone NALC Health Plan

### Lee Fenstermacher, Retiree

For years, I have been sending my prescriptions to Caremark (NALC Health Plan) via U. S. Mail. Depending on the number of prescriptions sent it would take sometimes up to 15 days. My renewal dates differ and I can sometimes order 5 or 6 at a time. In checking on the status of renewal's I figure it takes 3 to 4 days (via U.S. Mail) to get to Caremark and another 3 to 4 days travel back to me after renewal, total time about 13 to 15 days.

Recently I tried via telephone and internet and found out, on each, that I can complete the cycle in 4 to 5 days, as opposed to 15 days. This saves filling out the forms and postage also.

To renew your prescription, go to their website, www.caremark.com then:

- 1. Log in with "user name & password" click
- 2. On the left side of the screen click on "refill a
- 3. Scroll down and you will get a list of
- 4. At bottom of screen find verify order box

In Caremark you can check on the status of your order as follows, you will get an E-Mail message that 1. Your order has been received then, another one later that you order has been shipped.

More information about your prescription may be obtained after logging in by clicking on:

- 1. My prescription
  - A. Check order status
  - B. Detail order
- 2. A. View prescription history
  - B. Prescription detail

The telephone renewal is as follows, dial 1 (800) 933-6252, then at the prompt punch # 3, then again at the prompt # 1. A representative will then come on the line with his/her name and ID #. You should then tell them that you wish to renew a prescription. They will take you through the process from there.

Active prescriptions are prescriptions that are renewable only. A prescription becomes "active" when started with a prescription from your Doctor.

President Young praised the action of the Senate Committee as a positive step toward eventual reform of the government's postal laws that will enable the U.S. Postal Service to be more competitive and financially viable and thereby protect the jobs and livelihoods of hundreds of thousands of letter carriers and other postal employees.

However, the union opposes a provision in the Senate bill dealing with the banking of amounts of allowable, but unused, postage rate increases in a manner that could have a negative impact on collective bargaining. President Young is optimistic that Senators Collins and Carper will work with the NALC to resolve that issue as legislation proceeds. The House bill does not include such a provision.

All letter carriers as well as other postal employees need to be ready to act when called upon so that we will have our voices heard on Capitol Hill. Watch your e-mail from NALC headquarters to all of you who are E-Activists.

Standing together we can make a difference in protecting our benefits and insuring the future of the USPS.

#### **Deliver those coverages**

A very good source made me aware that Postal Inspectors are out on the street going behind letter carriers checking to see if they are delivering all of the coverages. They are also counting coverages prior to delivery and counting how many deliveries are on a route and checking to see if they have all been delivered.

Point is, make sure that you deliver all coverages (ADVO, PENNYSAVERS etc.) Don't jeopardize your job just to avoid delivering coverages, Remember that is mail also.

#### **Representation / OWCP**

Section 8127 of the Federal Employees' Compensation Act (FECA) provides that an employee or survivor may authorize an individual to represent them before any proceeding under the Act. Any knowledgeable member of the NALC can represent an employee or survivor provided that no fee or gratuity is charged.

OWCP's regulations require an employee or survivor to provide OWCP with written notice of any appointment of a representative. While OWCP has traditionally furnished representatives of the NALC general information regarding the injuries or deaths of employees within the NALC's bargaining unit, it is necessary to furnish the written and signed notice when performing more than routine services for an employee or survivor (e.g., representation at a hearing). In order to avoid any unnecessary delays, an employee requesting the assistance of an NALC representative should always provide written authorization. OWCP's regulations limit employees or survivors to only one representative at any one time. For example, an employee cannot be represented by an attorney and an NALC representative at the same time. Naming more than one NALC representative, however, counts as only one appointment.

#### Time / OWCP

The Federal Employees' Compensation Act (FECA) requires that an employee give written notice of injury or occupational disease and file claim for compensation within specified time periods. If the employee fails to meet the appropriate time limitations, the claim will be denied even if it is otherwise valid. Forms CA-1, CA-2 and CA-7 are provided for the purpose of giving written notice of injury and claiming compensation. The time limitations imposed by the FECA do not apply to minors under the age of 21 or an incompetent individual while he or she is incompetent and does not have a duly appointed legal representative.

For injuries and deaths on or after September 7, 1974, the law provides that a claim for compensation must be filed within three years of the injury or death. Even if a CA-1 or CA-2 is not filed within three years, compensation may still be allowed if written notice of injury was given within 30 days or the immediate superior had actual knowledge of the injury or death within 30 days after occurrence. This knowledge may consist of written records or verbal notification; an entry into an employee's medical record may also satisfy this requirement if it is sufficient to place the agency on notice of a possible workrelated injury or illness. For traumatic injury, the statutory time limitation begins to run from the date of injury. Since traumatic injuries are identifiable as to time and place of occurrence, meeting this time limit is fairly obvious. Although the FECA provides a three-year time frame for entitlement, it should be noted that in order to qualify to receive Continuation of Pay COP), a CA-1 for a traumatic injury must be filed within 30 days of the date of injury. For a latent condition or occupational disease claim, time begins to run when an injured employee who has a compensable disability becomes aware, or reasonably should have been aware, of a possible relationship between the medical condition and the employment. Where the exposure to the identified factors of employment continues after this knowledge, the time for filing begins to run on the date of the employee's last exposure to those factors.
