# PRESIDENT'S REPORT By Calvin Brookins

#### **Route Inspections**

Grievances have been filed in regards to route inspections in Encino, Panorama City and Sherman Oaks, we have more grievances to file in Sherman Oaks as of the writing of this article. Some of the issues that are being addressed are management arbitrarily using the lower of the two times (1840B vs. week of inspection) times in almost all cases. We are also looking into management using the Saturday delivery times as part of the average when the carrier do not deliver the businesses on Saturday. We are also addressing the time it took each carrier to fill out a 3996 during the week of inspection. The NALC takes the position that any time used by the letter carrier during the week of inspection to fill out a PS Form 3996 should be on line 21 instead of line 22. For those of you who don't know line 21 items are built into your route.

In Sherman Oaks there was an issue of waiting for mail; during the week of inspection management had the letter carriers place themselves on line 22 while waiting for the clerks to finish sorting the flats by routes. Prior to the week of inspection management allowed and instructed carriers to go over to that area and pull and record the flats that were available. We take the position that management should have allowed the same practice during the week of inspection.

#### Postal Reform HR-22

On July 26, The House of Representatives rejected a few anti-worker amendments, and then passed by an over-whelming 410-20 vote bipartisan legislation to reform U.S. Postal Service operations in the 21st century while maintaining universal six day delivery service.

Contacts by the NALC e-Activists were critical in blocking these anti-worker amendments. Prior to the vote on this bill, the House also voted on three detrimental amendments. Which are listed below;

Pence (R-IN) Amendment – This amendment would disallow the provision in the bill to have a rotating member from each of the Postal Unions to sit on the Postal Board of Governors.

Flake (R-AZ) Amendment – This amendment would establish a privatization pilot program that would ease the current restrictions on the USPS first class monopoly as well as its exclusive use of mail boxes.

Hensarling R-TX) Amendment – This amendment would require the USPS to pay the full cost associated with

employees' military service retirement instead of reverting them back to the Treasury Department as in previous years. All three amendments were defeated prior to the vote on the overall bill.

Congressman Pence (R-IN) also tried to introduce an amendment that would reduce worker compensation benefits for Postal Employees. The NALC launched an e-Activist action alert on this amendment. This amendment was withdrawn prior to the debate on Postal Reform.

Passage of Postal Reform in the House is just the start to bringing meaningful reform to the Postal Service that will protect our workforce well in to the future. We must now focus our attention on S.662 (Postal Reform) that will be debated in the United States Senate. This is a similar, but slightly different, bill sponsored by Senator Susan Collins (R-ME) and Senator Tom Carper (D-DE).

President Young said the NALC has some issues with the Senate bill relating to the banking resolution, price cap among other things. Senator Collins has offered the NALC the opportunity to discuss these issues and President Young has stated that he is confident that a resolution can be reached that is fair to all.

#### AFL-CIO

The two biggest Unions within the AFL-CIO have decided to disaffiliate themselves from the AFL-CIO, those unions being the Teamsters and the Service Employees (SEIU). These two Unions accounted for 3.2 million of the AFL-CIO membership. Several others including the United Food and Commercial Workers, Unite-Here, and the Farm Workers boycotted the AFL-CIO convention, but did not immediately sever their membership in the AFL-CIO.

The dispute basically came down to whether the federation's focus should be limited primarily to organizing or whether it should continue to also have a major financial and resource impacting the political and legislative arena.

#### COLA

The projected accumulation for the sixth of eight regular cost-of-living adjustments under the 2001-2006 National agreement stood at \$588.00 following the release July 14 of the Consumer Price Index for CPI-W for February. This equates to 28 1/4 cents per hour or \$22.60 per pay period.

# Health Benefits Update by Janette Dolabson Health Benefits Representative

Well, summer is ending but the weather is still steamy. Here is some helpful information for you to think about. Keep your water handy: During a day of normal activity, the body needs 2 quarts of liquid to replace body fluid loses. Eight glasses of this should come from drinking water and other beverages. The remainder, about 2 cups, come from solid foods.

Doctors at the University of Florida College of Health and Human Performance say fruits and vegetables are 84 to 95 percent water. Steak is 50 percent. When exercising, 1/2 to 1 quart of fluids per hour is required to replace sweat loss during moderate physical activity.

In hot weather, the liquid requirement during exercise is higher, depending on the temperature and acidity. In addition, drink water before beginning outdoor activities such as

gardening, and to us who carry mail, lots of water is needed during the hot months to keep us hydrated properly.

Be smart and drink plenty of water.

## VICE PRESIDENTS REPORT Art Bocek

#### **Supervisor Discussion Notes**

Under Article 16 of the National Agreement a supervisor's discussion with an employee is not considered discipline and is not grievable and "no notation or other information pertaining to such discussion shall be included in an employee's personnel folder. The Postal Service acknowledges that the spirit and intent of Article 16 is to provide a mechanism for a supervisor to discuss perceived work deficiencies with an employee without such discussion taking on the formality or significance of disciplinary action. Accordingly, although Article 16 permits a supervisor to make a personal notation of the date and subject matter of such discussions for his own personal record(s), those notations are not to be made part of a central record system nor should they be passed from one supervisor to another.

The Postal Service acknowledges that a supervisor making personal notations of discussions which he has had with employees within the meaning of Article 16 <u>must do so in</u>

manner reasonably calculated to maintain the privacy of such discussions and he is not to leave such notations where they can be seen by other employees to include other supervisors.

#### **Destruction of Discussion Notes**

The proper length of time for supervisors to retain personal notes concerning employees as defined in 314.52c of the Employee and Labor Relations Manual <u>are to be destroyed</u> when the supervisor/employee relationship ceases.

#### **DOIS Estimates**

Dois provides the supervisor with an estimate of a letter carrier's normal daily workload and may be one of the factors considered by a supervisor when discussing a letter carrier's work performance. This does not mean that such a discussion will be of the type referred to in Article 16, Section 2, 1981 National Agreement. It can be merely a work-related exchange between the supervisor and the carrier with the DOIS evaluation as a focus.

DOIS evaluations should not be the basis for a discussion concerning the letter carrier's efficiency held pursuant to Article 16, Section 2., since the efficiency of a letter carrier can more appropriately be determined by a mail count pursuant to 141.2, M-39 Handbook.

#### "8" Hour Work Guarantee

Management <u>may not solicit employees</u> to work less than their call in guarantee, nor may employees be scheduled to work if they are not available to work the entire guarantee. However, an employee may waive a guarantee in case of illness or personal emergency. This procedure is addressed in the F22, Section 22.14 and the ELM, Section 432.63.
