## PRESIDENT'S REPORT By Calvin Brookins

#### **Food Drive**

By the time you get this issue of the MailCall the 2006 NALC Food Drive will be upon us. Janette Dolabson from Tarzana Post Office is the Food Drive coordinator for the branch; please give her your full cooperation this year as you have in the past years. We will welcome all volunteers if you have that day off and want to donate some time for a good cause see the Food Drive coordinator at your station they will be glad to use your services.

Speaking of the Food Drive our branch has been presented with the 2005 Community Award from MEND, for our efforts and work with MEND in regards to the Food Drive. MEND is the Food Bank that we donate all of our collected food to each year. I asked Janette Dolabson (food drive coordinator) and Velma McClinton (Secretary of Treasurer) to attend the award ceremonies at MEND and accept the award on behalf of the branch.

This is an award that was earned by all members of the branch because of your hard work and efforts in collecting this food year after year. My thanks not only go to MEND, but to all of the letter carriers of this branch for being willing to work a little harder to collect the food each year.

### COLA

The projected accumulation for the eighth and final regular cost-of-living adjustment under the 2001-2006 National Agreement stood at \$47.00 following the release March 16, of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for February.

The eighth COLA will be based on inflation between January and July 2006 and will be payable in the second full pay period following release of the July, 2006 index. The \$47.00 annual accumulation equals 2 1/4 cents per hour or \$1.80 per pay period.

The projected accumulation toward the 2007 retiree COLA was 0.8 percent following the release of the February CPI-W.

The 2007 COLA is to be based on the increase in the CPI-W between the third quarter of 2005 and the third quarter of 2006.

The 2007 COLA for Federal Employees Compensation Act (FECA) participants, to be determined on the CPI-W from December 2005 to December 2006, stands at 0.9 percent based on the February data.

#### **Donations**

Last year there were donations taken from Sherman Oaks, Encino, and Civic Center for the American Red Cross to help the victims from Hurricane Katrina. I have recently received receipts from the American Red Cross showing that they have received the donations.

However, I only received receipts for the donations that were presented in the form of Postal money orders. If anyone at your station gave a donation with a personal check, then they should have received a receipt for the amount they donated

# Health Update by Janette Dolabson Health Benefits Rep.

There is some information in the NALC Benefit Plan Report that I would like to take the opportunity to share with you. There have been a higher volume of people in their 30's and 40's with osteoarthritis in their knees. You are not in you 20's anymore. It's time to start exercising smarter. Turning 40 can be a pain in the neck, and in the ankles, back, groin, shoulders, and hamstrings. Baby boomers are suffering more than a million sports injuries every year. The highest numbers are from bicycling, basketball, baseball, and running. The idea of exercise is to stay in good shape. Biking on mountain trails or trying to relive your glory days playing basketball or football isn a weekend-warrior style is not the way to do it. Ageing can't be avoided but injuries can. Exercise appropriately and watch for signs like muscle soreness and joint pain. Then change your routine. Even small amounts of weight loss can improve knee function, especially in osteoarthritic adults. Each pound lost equals 5 pounds less pressure on your knee joints. Achieving and maintaining a healthy weight pays off in pain reduction. Maybe that next diet will help relieve some of the pain I have in my neck and shoulders and knees.

### **Postal Inspectors/ Your Rights**

Letter Carriers are all too frequently being called into the Postal Inspectors' office for investigatory review without union representation. Because of this fact, there are fewer carriers working for the postal service. It is paramount to your job and career that <u>you</u> understand the role of the inspectors and your rights. I have in the past written on this subject, but it is most important to remind even an experienced carrier not to mention newer members who might be brought into the office for an "<u>Investigative Interview</u>." For the new and some of you "Lifers," her are some questions and answers <u>you need to know</u>.

Who are the postal inspectors? What do the postal inspectors do? What rights do letter carriers have? Postal Inspectors are employees of USPS. They are neither craft nor management's, but a separate part of the USPS. What do they do? They investigate mail fraud, mail theft, and they also investigate employees. They monitor the day-to-day operations of the USPS. They also prosecute employees plus they harangue-and arrest employees.

So what can I as an employee do to help myself?

 Be professional and do your job in a proper manner at all times

### 2. KNOW your rights and EXCERCISE your rights!

A. <u>Contractual: Article 17, Section 3, Paragraph 5</u>: "If an employee requests a steward of Union Representative to be present during the course of an interrogation by the Inspection Service, <u>such request will be granted.</u>"

- B. "Weingarten Rights," the right to have Union Representation during investigatory interviews, or if the employee believes that discipline may result from the investigatory review.
- C. "Miranda Rights," You have the right to remain silent; anything you say can be used against you in a court of law. You have the right to the presence of an attorney prior to questioning and to be with you during questioning if you so desire; if you can not afford an attorney, you have the right to have an attorney appointed for you prior to questioning. "Do you understand these rights? Will you voluntarily answer my questions?"
  - D. The right to know the purpose of the interogation prior to questioning.
  - E. The right to have criminal charges read and
  - F. The right to refuse to answer any questions
  - G. ELR Manual, Section 666.6: Cooperation in

Once a carrier has been given his/her "Miranda Rights" the best you can do as a shop steward is to advise the carrier to not sign anything or make any statements until he/she has engaged in legal counsel! What is the role of the shop steward or Union Representative during the investigation by the Postal Inspection Service?

Stewards have the right to know the purpose of the interrogation; to have private conversations with the aggrieved carrier prior to questioning; to call time-out at any time during the interrogation, and as many times as he/

she feels necessary; to give advice, ask questions and actively recommend a course of action during the interrogation; to bring out facts favorable to the carrier during the interview. Stewards also have the right to keep the carrier from being intimidated and harassed during the interview, and to keep the carrier from incriminating himself herself.

Stewards do not make deals with Postal Inspectors, just as the Postal Inspectors do not determine the penalties. As a steward, you always conduct yourself in a professional manner, as you can be asked to leave the interview if you shout, scream or use obscene gestures. Remember, it is your job as a steward is to represent and protect! If a steward feels that a Postal Inspector has acted in less than a professional manner during the interview, you can protest these actions to the Inspector General of the Inspection Service. Postal Inspectors do not determine the penalties. Steward may interview Postal Inspectors, may cross examine, and may ask for the Postal Inspector's notes, as those notes are the foundation for discipline. The proper remedy to ask for when Article 17, Section 3, rights and Weingarten Rights have been violated, or when Postal Inspectors refuse the union access to their notes or refuse to be interviewed is: "The employee is to be made whole; reinstated; completely exonerated, and the matter is to be expunged from the employee's file or records."

Remember, "Rights are like muscles, the only rights you have are the rights you exercise."
