HRSSC

Another acronym; yes it is only this one stands for Human Resources Shared Services Center. HRSSC is the consolidating of USPS Human Resources (personnel) in one location. What this means is that the Postal Service is consolidating all personnel departments through out the country to one location in Greensboro, North Carolina. This went into effect for the Van Nuys District personnel on May 30, 2006, a letter should have been received by now by all employees within the Van Nuys District.

While I do not agree with this idea of closing down personnel, however it is not a decision that I get to make. This is a direction that the Postal Service is going, it basically comes down to reducing overhead which in terms eliminate jobs/positions. This could cause some problems for employees who need help with their own personnel issues.

The Van Nuys District has set up PostalPEOPLE Information Fairs or seminars to help make employees aware of how this new system will work. However, your attendance at these functions is voluntary and off the clock. (See posting in your station).

They have also sent out document packages that explains how this new system will work in regards to the Retirements/Separations Process, Benefits/Compensation Process, and the EAS Selection Process. I will make sure those packages is at every office and that every active letter carrier receives one.

Food Drive

The 2006 NALC National Food Drive has come and gone, as a branch we collected 62,130 pounds of food. That was down from last year however MEND were very appreciative of the food we collected.

I would like to thank Janette for once again a job well done as she coordinated this whole effort for the branch. I would like to also thank all of the coordinators from each station and all other who helped out at the stations. Special thanks go out to the carriers of the branch for all of their hard work collecting the food for the food drive.

COLA

The projected accumulation for the eighth and final regular cost-of-living adjustment under the 2001-2006 National Agreement increased to \$499.00 following release May 17, of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for April.

The eighth COLA will be based on inflation between January and July 2006 and will be payable in the second full pay period following release of the July, 2006 index. The \$499.00 annual accumulation equals 24 cents per hour or \$19.20 per pay period.

The projected accumulation toward the 2007 retiree COLA was 2.3 percent following the release of the April CPI-W. The 2007 COLA is to be based on the increase in the CPI-W between the third quarter of 2005 and the third quarter of 2006.

The 2007 COLA for Federal Employees Compensation Act (FECA) participants, to be determined on the rise in the CPI-W from December 2005 to December 2006, stands at 2.4 percent based on the April data.

The announcement of the retirement of National Business Agent Dale hart was confirmed at the State Convention. Dale will be retiring at the end of his term in December.

National President Bill Young has endorsed the candidacy of RAA Manny Peralta as National Business Agent for region # 1. Manny has served the union for many years and is one of the most gifted union officers within the NALC.

Physician as defined under FECA

The term "physician" includes surgeons, podiatrists, dentists, clinical psychologists, optometrists, osteopathic practitioners, and chiropractors within the scope of their practice as defined by State law. The services of chiropractors may be reimbursed only for treatment consisting of manual manipulation of the spine to correct a subluxation as demonstrated by X-ray to exist, except that a chiropractor may also provide services in the nature of physical therapy under the direction of a physician. By regulation, the term "qualified physician" does not include those individuals whose licenses to practice medicine have been suspended or revoked by a state licensing or regulatory authority or who have been excluded from payment under the FECA.

A diagnosis of "spinal subluxation as demonstrated by x-ray to exist" must appear in the chiropractor's report. A chiropractor may interpret his or her x-rays to the same extent as any other physician. OWCP will not necessarily require submittal of the x-ray, or a report of the x-ray, but the report must be available for submittal on request. The costs of physical and related laboratory tests performed by or required by a chiropractor to diagnose a spinal subluxation are payable.

A clinical psychologist may serve as the sole treating physician in cases where the accepted condition is wholly emotional in nature, but may not serve as the sole treating physician in cases that include a physical component unless the applicable State law allows clinical psychologists to treat physical conditions. A clinical psychologist may also perform testing, evaluation and other services under the direction of a medical doctor.

OWCP uses a schedule of maximum allowable medical charges. This schedule applies to charges for medical services rendered on and after June 9, 1986, by physicians, surgeons, podiatrists, clinical psychologists, optometrists, chiropractors, osteopathic practitioners, physicians' assistants, and therapists. The fee schedule includes those services rendered in a hospital or nursing home setting, and to outpatient hospital services. It also applies to inpatient hospital services and pharmacy charges after January 4, 1999. However, nursing home charges are not subject to a fee schedule. The employee does not have to pay the difference between the maximum charge set by the schedule and the charge made by the provider.

Just a reminder that the Picnic will be on July 23rd. Picnic will start at 10:30 am through 4:00 pm. Food will be served from 1200 (noon) till 2:00 pm. Judging for the "Salsa Contest" will start at 11:15 am, 1st prize is \$ 100.00, 2nd prize is \$ 50.00, and 3rd prize is \$25.00. Adult guest tickets are \$ 20.00, children guest (7-17) tickets are \$10.00, guest children (6 and under) are Free. Baseball game(s) time and field assignments to be announced later.

Non Union Employees need not show. Member's tickets are not transferable to either guests or non members, but you still can join the union at the picnic and attend the picnic. Guest tickets are valid only when union member is present at the picnic.

FOOD DRIVE UPDATE
