To Outlaw "Contracting Out"

On May 23, 2007, Senator Tom Harkin (D-IA) introduced in the U.S. Senate legislation to protect city and rural letter carriers from having their work contracted out by the USPS to private contractors and individual.

S. 1457 is titled the "Mail Delivery Protection Act of 2007". This bill is designed to keep the postal service from entering into any contract with any motor carrier or other person for the delivery of mail on any route with 1 or more families per mile.

This bill will stop the Postal Service's attempt to privatize mail delivery. There were several Senators joining Harkin as co-sponsors of this bill they are: Max Baucus (D-MT), Jeff Bingaman (D-NM), Robert Casey (D-PA), John Kerry (D-MA), Jon Tester (D-MT), Byron Dorgan (D-ND), Patrick Leahy (D-VT), and Patty Murray (D-WA).

Dog Bites

On May 21, 2007, Representative Thaddeus G. McCotter (R-MI) sponsored House Resolution 419 that calls on communities to take steps to protect letter carriers and other citizens against dog bites.

This resolution is designed to raise awareness among Americans. More than 3000 letter carriers were victims of dog bites last year. This resolution would also have Congress recognize National Dog Bite Prevention Week of May 20-26.

This has been an ongoing problem for letter Carriers and the Postal Service for a long time. Everyday letter carriers have to be on their guard against unexpected dog attacks. Hopefully this bill will encourage local government and homeowners to ensure that there dogs are restrained and that it is safe for letter carriers to deliver the mail. With that said, I am asking all members of this branch to be vigilant and very careful when it comes to dogs in the area that you are delivering mail. Summer time is here and with that dog attacks can increase.

Retiree COLA Reaches 1.5 Percent

The 2008 COLA for retirees stood at 1.5 percent following the release by the U.S. Bureau of Labor Statistics May 15 of the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for April.

The COLA will be paid in 2008 based on the increase between the third quarter of 2006 and the third quarter of 2007.

For Federal Employees Compensation Act (FECA) participants, their 2008 FECA COLA stands at 2.5 percent based on the latest figures.

PS Form 1510

As of June 1, 2007, PS Form 1510, Mail Loss/Rifling Report will be obsolete and discontinued. All Post Offices have been advised to destroy all forms currently in stock. They are also advising customers who wish to report suspected mail theft or rifling must contact the Postal Inspection Service.

Therefore, I am advising all carriers to make sure that they properly deliver parcels and you might not want to leave them on porches without having something in writing from the customer to protect yourself.

Food Drive

The NALC collected 70.7 million pounds of food nation-wide, this branch collected 95,864 pounds of food. There are a lot of people who have played a major role in our food drive for a lot of years. Regulations Enforced by the EEOC

The U.S. Equal Employment Opportunity Commission (EEOC) enforces all of the above laws. EEOC also provides oversight and coordination of all federal equal employment opportunity regulations, practices, and policies.

Under "Title VII of the Civil Rights Act of 1964," regulations clearly prohibit the employment discrimination based on race, color, religion, sex, or national origin. The "Equal Pay Act of 1963" (EPA), protects both men and women who perform substantially equal work in the same establishment from sex-based wage discrimination. The "American Disabilities Act (ADA), which protects individuls prohibits employment discrimination against qualified individuals with disabilities in the private sector. Under the "Rehabilitation Act" discrimination against qualified individuals with disabilities who work in the federal government is also clearly prohibited. The "Civil Rights Act of 1991," which among other things, provides for "monetary damages" in cases of intentional employment discrimination.

Other federal laws, not enforced by EEOC, also prohibit discrimination and reprisal against federal employees and applicants. The Civil Service Reform Act of 1978 (CSRA) contains a number of prohibitions, known as prohibited personel practices which are designed to promote overall fairness in federal personnel actions (5 U.S.C. 2302). The CSRA prohibits any employee who has authority to take certain personnel actions from discriminating for or against employees or applicants for employment on the bases of race, color, national origin, religion, sex, age or disability. It also provides that certain personnel actions can not be based on attributes or conduct that do not adversely affect employee performance, such as marital status and political affiliation. The Office of Personnel management (OPM) has interpreted the prohibition of discrimination based on conduct to include discrimination based on sexual orientation. The CSRA also prohibits reprisal against federal employees or applicants for whistle-blowing, or for exercising an appeal, complaint, or grievance right. The CSRA is enforced by both the Office of Special Counsel (OSC) and the Merits Systems Protection Board (MSPB).

I am happy to write this article this year. Last year was disappointing because we only collected around 61,000 pounds of food. This year we really pushed everyone to step up and give your best effort. We challenged you to do at least 10% more then last year. We asked you to bring in food yourselves to donate. We asked for volunteers to go out and circulate flyers. With all that we asked, we did way more then the 10% we were hoping for. This year we collected 95,864 pounds of food. That's a huge increase and largely due to all your hard work and the efforts of the coordinators and yes, I have to say, the managers. Without your cooperation working together to get this task done we would not have seen this come to fruition.

I want to start my thanks with Sherman Oaks. They have a coordinator over in that station named Sonia Ruiz. Thanks to Bob Johnson and Elaine Boyd for cocoordinating Main office this year. Your office did much better this year then last, by about 100 tubs.
