PRESIDENT'S REPORT By Calvin Brookins

NRP - National Reassessment Process

The National Reassessment Process is a process developed by management with the intent to properly place employees who have been injured on the job into positions within their medical limitations. However, the Postal Service is attempting to change their policy on providing limited duty work to employees who have partially recovered from work related injuries or illnesses. Management is attempting to do this through the National Reassessment Process.

Over the last 10 months or so we have heard about management attempting to send carriers who have been injured on the job and can no longer carry mail to places like Wal-mart and other jobs outside of the postal service. Basically management has taken this "if you are hurt we don't want you" type attitude.

The union has filed a grievance at the national level regarding the implementation of the National Reassessment Process because of management's unilateral change in the definition of the Postal Service's obligation to provide limited duty work under Article 19 and Section 546.142 of the Employee Labor Relation Manual. The union contends that management implementation of the NRP is inconsistent and in conflict with Section 546.142 of the Employee Labor Relation Manual as well as provisions of the EL-307 and EL-505 handbooks and applicable laws and regulations. As soon as I have more information on the grievance filed at the national level I will past it on to you.

Section 546.142 of the Employee Labor Relation Manual specifically requires the Postal Service to "make every effort" toward assigning to limited duty consistent with the employee's medical limitations. Management for a long time now has accommodated limited duty employees. Management has gone so for as to create rehab assignments that consisted of clerk duties in an effort to fulfill their obligation under Article 19 and the ELM, Section 546.142 as well as the federal law.

The language "make every effort" is strong language, which has stood the test of time. Management must make more than some effort, or a lot of effort they must "make every effort"! We have already had some situations in one of the Van Nuys station where management has chosen to send two different carriers home who have an on the job injury, just because their restrictions did not allow them to do work that management wanted them to do. This little escapade only cost management in excess of \$18,000.00. I want go into the other \$20,000.00 plus that local management have paid out to letter carrier because someone made a decision that they did not need to provide light duty work several other individuals, that is a subject for another article at a later time.

That being said, if any carrier who have an on the job injury is sent home by management claiming that they no longer have work for them you need to immediately request to see your shop steward or call the union office.

Contracting out Moratorium

On Friday February 21 it was announced that the moratorium on contracting out letter carrier work called for by the Article 32 Committee Memorandum of Understanding in the National Agreement will be extended until July 31, 2008.

The moratorium applies to city carrier offices not covered by the National Agreement's life of the contract ban on CDS routes in offices that employ only city carriers (as determine at the time the contract was negotiated).

The NALC and the postal service have agreed to update the list of city carrier offices covered by the MOU on contracting out. The new list will be posted on the NALC website as soon as possible.

COLA

The next regular cost-of-living adjustment (COLA) under the 2006-2011 National Agreement will be \$458.00 annually based on the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for January.

The cost of living adjustment, effective the pay period beginning March 15 (pay date April 4) is the second of eight COLA's included in this current contract.

The new COLA of \$458.00 annually is equivalent to 22 cents per hour, or \$17.60 per pay period. This COLA of \$458.00 raised the total annual pay for top rate carriers to \$51,251.

SPECIAL ANNOUNCEMENT

As most of you know by now, Vice President Art Bocek has retired from the Postal Service, I have also received a resignation letter from Vice President Bocek, resigning his

Vice President position. He has decided to pursue some other interest in his life, while Art will not serve as Vice President he is available just in case I need his services for something like assigning him to deal with some issues at Encino, that would be fun to watch. Well I wish Art well in his retirement I know he will enjoy it and we will miss him being around all of the time.

I have asked Janette Dolabson to move over to the Vice President position and she has gracefully accepted. Janette will do a great job at that position she is very knowledgeable and will serve the membership well.

I have also received a presidential ruling from President Young that allows me to appoint Larry Dolabson as HBR and he has also accepted that position, Larry will be an asset to the membership while servicing in this position.

I am very happy to announce that Tia Wilson from Sun Valley will fill the Trustee position left vacant by Larry Dolabson. This is the first time that I know of that we now have every one of the stations within Branch 2462 represented on the Executive Board.
