First let me offer up my congratulation to Trustees Mullinax, Wilson and Jackson on their re-election to their respective positions. All three of these individuals have served the branch well as Trustees and I know they will continue to do a very good job as Trustees. Along with Vice President Janette Dolabson others on the Executive board and some of your shop stewards I am now confident that I have a group of people in place that I can train to continue to represent this branch into the future.

I also want to thank Vice President Janette Dolabson for heading up another year of a successful food drive. I also want to thank all of the food drive coordinators at each of the station for their efforts and a job well done as well as all of the other carriers that stepped up to the plate to help out at the stations. On a national level we collected 73.1 million pounds of food that is slightly more than we collected last year.

Customer Connect

FYI - Customer Connect - Sierra Coastal District Customer Connect Lead Ranking Report as of May 30, 2008, shows our district ranks 26th out of 80 with 546 leads submitted year to date.

Customer Connect Revenue Ranking Report shows our district ranks 32nd out of 80 with \$2,404,289 year to date revenue.

Customer Connect Carrier Participation Ranking Report shows our district ranks 50 out of 80 with YTD carrier participation at 18.31% the YTD target is 63.88%.

I would also like to congratulate Letter Carrier Ruben Cu from Sherman Oaks on his recent customer connect sales of \$998.00.

COLA

The third regular cost-of-living adjustment (COLA) under the 2006-2011 National Agreement stands at \$633.00 annually based on the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) for April.

The \$633.00 annually is equivalent to 30.4 cents per hour, or \$24.33 per pay period.

The accumulation towards the 2009 retiree COLA stands at 3.5 percent based on the April CPI-W.

The COLA for Federal Employees Compensation Act (FECA) beneficiaries in the year 2009 stands at 2.4 percent based on the April data.

COLCPE

Committee on Letter Carrier Political Education, this is a topic that is very important to every city letter carrier in the country. COLCPE is the only financial means the NALC has to contribute to the campaign of a worker friendly politician. To donate to COLCPE is totally voluntary; thousands of letter carriers through out the country donate to COLCPE year after year. There are several ways to donate to COLCPE, (1) you can donate through payroll deduction or by direct bank account deduction or by sending a personal check to the NALC in care of COLCPE. For retirees you can have your donations to COLCPE come out of your annuity.

Unlike some other unions none of your union dues money goes toward any politicians for lobbying or otherwise. As a letter carrier I believe COLCPE is something that we all need because it helps to give us as letter carriers a voice in Washington just as the special interest groups have. After all us working stiffs cannot afford to pay thousands of dollars to some politicians for a plate of food just to get them to vote our way on issues important to working Americans.

COLCPE is the NALC's Political Action Fund (PAC) and it helps elect and lobby friends of letter carriers, friends we need in office to help in our fight in making Postal Reform work. All members of this great union can do their part by contributing to COLCPE.

I for one believe COLCPE is making a different, some may ask; what has COLCPE done for us? On February 9, 2006, the Senate passed S. 662, the Postal Accountability and Enhancement Act. This came after the passing of HR 22 by the House of Representatives by a vote of 410 to 20. This legislation is the first comprehensive overhaul since the Postal Reorganization Act of 1970, which changed the Post Office Department to the United States Postal Service. It is also the result of years of negotiations and compromises involving lawmakers and Postal Service stakeholders and is the key to the future of the Postal Service as we know it today.

During the elections in 2006 COLCPE allowed the NALC to play a major role in electing a much more worker friendly congress. Numerous congressmen and senators have expressed their gratitude for the support given to them by the NALC. These elected representatives refer to themselves as friends of the NALC and are very aware of letter carrier concerns and issues.

Prior to our most recent contract negotiations President Bill Young met with these representatives of congress and explained the threat of contracting out that were facing letter carriers at that time and these representatives assured him that they would give their support to help stop contracting out. The issue of contracting out letter carrier's jobs is a very real issue. As you all know, the issue of contracting out letter carrier's jobs was a major sticking point that kept us from agreeing to a negotiated contract in November of 2006.

The restrictions on contracting out city letter carriers work is only good for the life of our current contract, when this contract is up in 2011 the Postal Service may again attempt to contract out our work. The bottom line is COLCPE donations is needed even more than ever, because if the Postal Service attempt to contract out our work at the end of this contract we will need all of our political friends in Washington.

I am encouraging every member of the NALC Branch 2462 to give just \$5.00 per pay period through payroll deductions or through direct bank account deductions, that works out to just .50 cents per work day. I am urging all members of Branch 2462 to donate just \$5.00 per pay period it is your voice that needs to be heard and your job that need to be protected. Please help the NALC protect your job by donate \$5.00 to COLCPE through automatic payroll deductions.

We would be glad to assist members at the union office who want to sign up for automatic contributions, just contact Jeff Jackson at Panorama City station or myself at the union office or Civic Center station. Active members will need to bring a copy of their pay stub and their PIN number; Retired members will need to bring their CSA retirement claim number and their PIN number.

So sign up for COLCPE automatic contributions and help the NALC secure a future for all city letter carriers

Antioxidents
