Second Early Out

The Postal service has informed the NALC that letter carriers will be included in the new Voluntary Early Retirement offer now being planned at USPS headquarters. Details on the new program including the timing for VER applications and the deadline for action have not yet been set. This early out may have the same terms as the program offered in 2008. Last years terms listed as follows:

Carriers who were at least 50 years old and had at least 20 years of service, and carriers of any age with at least 25 years of service, were eligible to take the early retirement. All of those carriers were sent an annuity estimate letter which showed their accrued annuities would be reduced to reflect a longer period of retirement. Shortly after that a formal letter was sent offering a chance to apply for early retirement with all of the details on how to proceed. The program from 2008 offered no financial incentives to take the early out and there may not be any incentives with the new program. Details of the new Voluntary Early Retirement will be shared once they become available.

NALC / APWU win a key ruling in OIG case

NALC and APWU had an important preliminary victory in their law suit against the postal service and the Office of Inspector General (OIG). In a ruling on March 3rd U.S. District Court Judge Denny Chin denied a motion by the defendants (USPS & OIG) to dismiss the case. The lawsuit which had been held in abeyance pending a decision on this motion will now proceed forward for consideration on the merits. This ruling will allow the case to be heard on it's merit and show once and for all just how out of control the Office of Inspector General is, and allow the evidence to show just how they are violating our members' privacy rights.

The NALC and APWU filed their joint lawsuit against the Postal Service and the Office of Inspector General on January 17, 2008, in the Federal District Court in New York City, in an attempt to stop OIG agents from obtaining confidential medical information about employees without their knowledge or consent. The issue of the OIG's unlawful practices came to light in September of 2007, when the NALC obtained a copy of a standard form letter used by OIG agents

when demanding that physicians and other health care providers disclose sensitive health information.

This information is used to guide the OIG's in their investigations of alleged employee misconduct. The letter advises the physician not to inform the patient or the affected employee of this disclosure. The lawsuit states that this practice violates federal statutes and regulations, as well as the U.S. Constitution. The lawsuit asks for an injunction requiring the Postal Service and the Office of Inspector General to cease and desist. You will be informed as we receive more information.

National Reassessment Process, Pilot program

Recently the USPS announced to the NALC that it was going to conduct a pilot test concerning National Reassessment Program (NRP) Phase 2 modified assignments. The announcement goes on to state that "...The primary purpose of the pilot is to test application of established processes used for rehabilitation employees in NRP Phase 2 in making modified assignments for employees with temporary medical restrictions (Limited Duty). Assignment made or modified during this pilot test will be consistent with current relevant regulations..."

The pilot test is being conducted in the Los Angeles, Sierra Coastal and Santa Ana districts and was identified to be a test of approximately 30 days. Well looking at this so call test on the surface it is apparent that management is not consistent with all of the current relevant regulations as they have stated that they would be. The union is currently preparing to file all necessary grievances in regards to management latest actions.

I know that there are some very upset carriers out there, but I ask that you remain calm and be patient and I know that is easier said than done but please try your best. I believe management basically treated all those that they walked off the workroom floor in a very bad and nasty manner, these carriers only down fall is that they was injured in the performance of their duties for which the postal service hired them for. This is the thanks that the USPS is giving them for their sacrifice to this organization; they were all treated as if they were criminal or had violated some hideous rule or regulation. Basically they were walked off the workroom floor as if they were being placed out of work under Article 16, Section 7 in an emergency suspension type situation. As if to say thank you very much for getting hurt on the job now get out.

This is no way at all for employees who has done nothing wrong to be treated, not only are they injured employees but management took the extra step to humiliate them and strip away their dignity. What management does not seem to understand is the chilling affect this could have on employees who may get hurt in the future, those employees will be reluctant to report their injuries and try to work through it and therefore, cause even more damage to their injured body parts that could be irreparable. Or on the other hand may be management is counting on that chilling affect, in hopes of cutting down on their cost of dealing with injured employees. In other words what ever it takes.

I don't know if this decision was made at the headquarters, area or district level of the postal service, but it does not seem as if they thought about the long term affect this could have not only on the employees but also on the USPS itself. They obviously did not take in to consideration on how disruptive this would be to those who they walked off the workroom floor or those who work hours were drastically reduced. Stay tune letter carriers I am sure there will be something else that we would have to react to down the road. Again the union will file all **necessary** grievances in regards to this matter, just as management is claiming that they have no **necessary** work for letter carriers.

There was no projected accumulation toward the fifth regular cost-of-living adjustment (COLA) for letter carriers under the 2006-2011 National Agreement in February following the release of the March CPI.

2010 Retiree COLA

There was no projected accumulation toward the 2010 retiree COLA in February following the release of the January 2009 BLS CPI.

2010 FECA COLA

Following the release of the January 2009 CPI, the projected accumulation toward the 2010 Federal Employee Compensation Act (FECA) COLA is 0.4 percent.

Health Benefit Update By Larry Dolabson

I am happy to report we have 26,000 new health plan members nationally. You all should have received your new cards. If you have not then call the plan and tell them so they can send the new one, that's right there should only be one card this year, not two. The two card thing was a bit confusing so now all the information is on one card and you will only have to have that one card for all your medical needs.

Beware of pulmonary embolism danger: From the deep veins of the legs and pelvis it's a straight shot to the heart, and only short distance farther to the lungs. If a fragment or more commonly, several fragments of a deep vein thrombosis break loose, they can be carried to the lungs, blocking blood flow. This is called a pulmonary embolism, and it can be fatal.

Signs and symptoms of pulmonary embolism vary. Sometimes, no symptoms are evident. However, seek emergency medical care if you experience: Unexplained shortness of breath, sharp chest pains when you inhale or cough, feeling light headed or dizzy or even fainting, or coughing up blood.
