PRESIDENT'S REPORT By Calvin Brookins

NRP Pilot Program

The grievances regarding NRP Pilot Process is ongoing and being processed through the grievance/arbitration Procedure. The grievances from Panorama City have been scheduled for arbitration on 8-21-09. The NRP Pilot grievances from Civic Center, Sherman Oaks, Main Office, Sun Valley and Encino have been requested for arbitration by the National Business Agent's office.

New NALC President

NALC Executive Vice President, Frederick V. Rolando has been installed as the 18th President of the National Association of Letter Carriers. He officially became President on July 4, 2009. Fred has served as EVP since December of 2006 and has moved up under the terms of the NALC constitution. He took the oath of office on July 2, 2009, at the NALC Headquarters in Washington, DC. The installing officer was Bill Young who had recently announced his retirement as President of the NALC.

President Rolando immediately announced the appointment of Vice President Gary Mullins as Executive Vice President, and Assistant Secretary-Treasuser George C. Mignosi as Vice President succeeding Gary Mullins. Bill Young has been a valuable friend to our branch and we wish him well in his retirement, he has been an advocate for letter carriers for over 40 years and on behalf of Branch 2462 and its membership I would like to wish Bill Young a very happy and enjoyable retirement. At the same time I as President of Branch 2462 urge all of our membership to fully support Fred and his endeavors as our new President. I know he is very capable of getting the job done.

5-Day Delivery

I have received report from several stations about stand-ups given by management telling employees that we are going to 5 day delivery. Let me make this clear, the postal service does not have the authority nor do they have the right to unilaterally go to five day delivery. The following is the NALC's official position and what has happened lately in regards to 5-day delivery.

On June 10, 2009, USPS informed NALC that it was conducting a study of the impact of switching to five-day delivery and developing an implementation plan. The study was to be completed in 60 days. USPS sought our "input" and our views on the issues such a change would raise and the "impact" it would have. And they wanted that input and those views -- for one of the most momentous decisions in postal history -- by June 19, 2009, just seven business days later.

On June 17, NALC responded, requesting a prompt meeting with the USPS' study team and its technicians to receive a detailed briefing including review of the relevant data, projections, sensitivity analysis and assumptions being used in the study.

On July 7, we attended a meeting in response to our letter. We received none of the information or data requested. We were told that there were a lot of experienced, knowledgeable people in the Postal Service who understood the issues, had determined to explore dropping Saturday delivery, would conduct meetings and polls, and expected the draft report in a few weeks. USPS told us they "understood our position."

The Postal Service cannot unilaterally end Saturday delivery. Such a change would require a change in the law and a 90-day review by the Postal Regulatory Commission. NALC will fight any attempt by the Postal Service to convince Congress to make this radical change.

Needless to say, we relay this report with great disappointment and regret. NALC will proceed professionally and vigorously to oppose the elimination of six-day delivery on its merits. Notwithstanding our position, we will also carefully scrutinize the Postal Service's study to ensure that its data and assumptions are credible and that it fully considers all the ramifications of such a radical change. NALC would much prefer to work with the USPS on win-win solutions to the ongoing crisis, but is prepared to act on its own to defend the long-term viability of the U.S. Postal Service.

HR 22 Passes full committee

July 10, 2009, the full Committee on Oversight and Government Reform ordered H.R. 22, which would allow the United States Postal Service to pay its share of contributions for annuitants' health benefits out of the Postal Service Retiree Health Benefits Fund, to be reported out of committee by Voice Vote

Committee Chairman Ed Towns (D-NY) stated during the hearing "The Postal Service is facing a financial emergency and HR 22 would allow the Postal Service to live to fight another day." The bill will now move forward to the entire House for further debate and a floor vote.

Vice President's Report

The House unanimously approved HR 2990, a bill that could increase the pensions for hundreds of thousands of federal employees covered by the Federal Employees Retirement System (FERS). The measure credits the unused sick leave of retiring FERS employees toward their time-inservice when calculating their pensions. There are roughly 1.4 million employees in the FERS. Employees under the older Civil Service Retirement System (CSRS) have always had this benefit.

The House approved the measure, called the Disabled Military Retiree Relief Act of 2009, by a 404-0 vote. It now moves to the Senate, which stripped similar provisions from a bill giving the Food and Drug Administration the authority to regulate tobacco.

The bill also allows FERS employees who leave and then return to federal service to get credit for their previous service and to redeposit their retirement annuities so they can receive a pension for their entire federal service. CSRS employees already have this benefit. But CSRS employees also would benefit from the bill if it gets passed. It would let CSRS employees who choose to work part-time at the end of their careers collect their full annuities.

The MIARAP process is moving forward. These adjustments are not perfect in anyway and it has not at all been fun adding or moving around territory and abolishing routes out of offices but I do know it's necessary. The Postal Service has to be a viable business. With the continuing drop in volume the routes keep shrinking. We don't know how far it will drop or if it will increase at some point but most of us letter carriers want to have routes that are 8 hours and not have to use our annual leave or leave without pay or figure out how to make our routes 8 hours. For now this is what we must accept the first round of adjustments will be in place for 3 months and then we will revisit them and hopefully be able to fix any problems with the adjusted territory. After this we are headed in, what I like to call the Flat Sorting ERA. Many of our offices will be going online with the flat sorting machines before the end of the year which will entail another whole round of adjustments. Strap yourselves in it's going to be a crazy ride but in the end we will still be standing.
