Vice President's Report

Some or us attended the Leadership Conference in San Diego where many issues were discussed including MIARAP. One of the most important issues of this process is the data entries in the stations. If it is not the same as what your supervisor had you down for then you need to notify your shop steward immediately. Keep a running total. Also, you need to stop handling your coverage mail and DPS and parcels in the office. Please I urge you to do this on street time. Your routes will not be adjusted properly because you will not be able to capture that office time you spend on doing this if you are over 100% to standard. If your route is out or whack and I know some of them are please let your steward know that immediately so we can look at fixing it before the revisit in the Fall. We don't have to wait until then to fix things that are fixable now.

As of now, there is no mention of lay offs coming from the Postal Service. We will however be losing TE carriers when their time is up. Hopefully not all of them but it is looking grim for them as far as keeping employment in the Postal Service for much longer. The new JCAM is available online for anyone wanting to look at the changes in our contract, especially you shop stewards.

Health Benefit Update By Larry Dolabson

Kidney stones are made up of crystal-forming minerals in the urine. If you drink an adequate about of water, urine is diluted and these crystals pass out or the kidneys. Normal urine also contains substances that inhibit crystal formation. However, if urine is too concentrated or if these crystal-preventing compounds aren't working properly, crystals may gradually accumulate and grow to form one or more kidney stones. At some point, most kidney stones are passed naturally from the kidney and down the tubes connecting the kidneys to the bladder, and out in your urine. Signs and symptoms of kidney stones to watch for are blood in the urine, nausea or vomiting, persistent urge to urinate, and fever and chills if an infection is present. To help limit the risk of kidney stones you should drink plenty of water, limit meat intake, reduce sodium, and get calcium in your diet.

According to the Postal Service the employee incentive offer is the latest in a series of cost reductions the Postal Service has made this year. Cost saving during 2009 is expected to total more than \$6 billion, included is the following actions:

- > Cutting more than 100 million work hours, the equivalent of 57,000 positions;
- > Halting construction of new postal facilities;
- > Closing six district offices;
- Negotiating an agreement with the NALC that adjusts letter carrier routes to reflect diminished volume;
- > Instituting a nationwide hiring freeze;
- Reducing authorized staffing levels at postal headquarters and area offices by at least 15 percent;
- > Selling unused and under-utilized postal facilities;
- Adjusting Post Office hours to better reflect customer use:
- > Consolidating mail processing operations;
- > Freezing salaries of all postal service officers and executives.

I don't know if these costs cutting efforts that the Postal Service is making will actually work, but only time will tell. However, if they continue to push for five (5) day delivery I believe that in and of itself will harm the Postal Service as opposed to helping. Remember once we lose that day of delivery I do not believe we will ever get it back and UPS and FED-EX is sitting there waiting for it to happen so they can put there contingency plans in place to make deliveries on a day that the USPS will choose to no longer service. Let's hope wisdom prevails.

Results From the Recent MIARAP Adjustments

The following is the results from the MIARAP process the affects the offices that are represented by Branch 2462.

Sun Valley there was two (2) regular routes eliminated, one (1) auxiliary route eliminated and one (1) regular route converted to an auxiliary route.

Tarzana there was two (2) regular routes eliminated, one (1) auxiliary route eliminated and one (1) regular route converted to an auxiliary route.

Encino 91316 there was no regular routes eliminated; however, there were two (2) auxiliary routes eliminated and two (2) regular routes converted to auxiliary routes.

Encino 91436 there was two (2) regular routes eliminated, no auxiliary routes eliminated and no regular routes converted to auxiliary routes.

Sherman Oaks 91403 there was two (2) regular routes eliminated and one (1) auxiliary route eliminated.

Sherman Oaks 91423 there was one (1) regular route eliminated and one (1) regular route converted to an auxiliary route.

VNMO 91405 there was two (2) regular routes eliminated, one (1) auxiliary route eliminated and one (1) regular route converted to an auxiliary route.

VNMO 91406 there was two (2) regular routes eliminated, one (1) auxiliary route eliminated and one (1) regular route converted to an auxiliary route.

VNMO 91411 there was one (1) regular route eliminated, one (1) auxiliary route eliminated and one (1) regular route converted to an auxiliary route.

In all there were 15 regular routes eliminated, 10 aux routes eliminated and 9 regular routes converted to aux routes. Three (3) of the nine (9) auxiliary routes have additional duties added to make an eight (8) hour bid position, such as collection runs.

Happy Anniversary to the NALC

On August 30, the NALC will observe its 120th anniversary; the NALC was first organized on August 30, 1889 during a meeting above Schaefer's Saloon in Milwaukee, Wisconsin. This is when a small band of letter carriers held a meeting above Schaefer's Saloon and created a national association to represent them in obtaining better wages and benefits. The 60 or so letter carriers unanimously voted to form the union, and quickly chose William Wood of Detroit as the National Association of Letter Carrier's first President and appointed an Executive Board to work with members of Congress on legislation that would benefit them. There will be further information on the anniversary in the August Postal Record magazine.

No COLA Adjustment for January - July Period

There was no COLA accumulation reflected during the six month fifth cost-of-living (COLA) period under the 2006-2011National Agreement between January 2009 and July 2009.

There also has not yet been any accumulation toward the 2010 retiree COLA based on the July CPI-W.

The next COLA period the sixth under the current contract runs from now through January 2010.

The projected accumulation toward the 2010 COLA for Federal Employees Compensation Act (FECA) participants, which is based on the increase in the CPI-W between December 2008 and December 2009, is 2.8 percent through July.
