PRESIDENT'S REPORT By Calvin Brookins

On the Political Side of Things

The House of Representatives has passed H.R. 22 by a vote of 388-32. The legislation will provide short term financial relief to the Postal Service by reducing the amount it must pay to pre-fund future retiree health benefits. The one year version of H.R. 22 approved by the House is a good first step toward devising a more sensible and affordable schedule for pre-funding our future retiree health benefits.

This past Wednesday night the Senate approved a continuing resolution that included the postal financial relief language from H.R. 22. With the passage, the Postal Service will be able to defer \$4 billion in payments to a fund for its future retirees' health benefits, this will give the Postal Service some flexibility for dealing with the current recession.

The ALF-CIO has unanimously passed our nationwide resolution opposing a Do Not Mail Registry at their National Convention in Pittsburgh. This is a crucial step in allowing us to present an all labor supported front when we need to lobby against these individual Do Not Mail proposals state by state.

Retirement Counseling

The NALC and the Postal Service has resolved a national level dispute over management's responsibility to provide retirement counseling to letter carriers. NALC has protested the discontinuance of the practice of providing inperson counseling to letter carriers on postal premises. Instead, the USPS amended the ELM to permit that counseling to be conducted primarily by telephone with a retirement specialist at the Human Resources Shared Services Center (HRSSC).

The settlement provides that employees may request counseling on the clock, and that local management will arrange reasonably private space for this purpose. The employee's spouse and/or advisor may be with the employee during this process. In addition, employees who cannot begin or complete the process of obtaining counseling from HRSSC without assistance will be offered assistance by local management.

Muscular Dystrophy Association (MDA)

NALC branches from across the country presented pledges and donations totaling \$2.1 million to the 44th Annual Jerry Lewis MDA Labor Day Telethon this year and helping MDA achieve nearly \$60.5 million in donations.

Myself alone with Vice President Janette Dolabson and MDA coordinator Sandy Anger and her boyfriend George all went down to the studios and answered phone taking donations during the telethon on Labor Day. On behalf of the branch thank you Janette and Sandy for participating in the telethon.

As we continue to raise money for Muscular Dystrophy Association (MDA) we will be having a Bowl-a-thon sign-up sheets have already been posted in every office if you have not signed up please see your shop steward. If you do not wish to bowl please sponsor someone from your station by making a donation either by number of pins or a set amount. All information about the bowl-a-thon should be posted in your stations.

Most Trusted Again

The U.S. Postal Service came in third place in the 2009 Most Trusted Companies for Privacy Award commissioned by the Ponemon Institute, an information security research company. eBay, Verizon and the Postal Service were 1, 2, and 3 in the survey, no other government agency was in the top 10.

Requesting a Form 3996

It has recently come to my attention that some carriers are not being given a Form 3996 or they are not requesting a 3996, in some cases carrier are allowing management to tell them that they do not need additional time to complete the route they are assigned to as opposed to estimating their workload and given their estimate to their supervisor on a 3996. Handbook M-39, Section 122.33 states as follows:

122.33 Administration of City Delivery Service

The employee, upon request, will be provided a Form 3996, Carrier -Auxiliary Control, after the supervisor has been verbally informed as to the reason for the request. The employee shall not be denied the form and, upon request, a duplicate of the completed form will be provided the employee.

If on any given day you believe that you will be unable to complete your assignment within eight (8) hours, you should request and complete a Form 3996. If you truly believe that you cannot complete your assignment within eight (8) hours do not allow your supervisor to talk you into trying to do the route in eight hours. If your supervisor chooses to have you curtail/cut mail they should provide you a PS Form 1571 for you to identify the mail you are leaving behind. Please protect yourself and the route you are assigned to.

No Accumulation Yet for Sixth COLA

There was no accumulation for the sixth cost-of-living adjustment (COLA) under the 2006-2011 National Agreement.

There also has not yet been any accumulation toward the 2010 retiree COLA for both CSRS and FERS retirees.

The projected accumulation toward the 2010 COLA for Federal Employees Compensation Act (FECA) participants, which is based on the increase in the CPI-W between December 2008 and December 2009 increased to 3.1 percent through August.

Saxsenmeier Scholarship Program

The California State Association of Letter Carriers (CSALC) is now accepting applications for the 2010 Carl J. Saxsenmeier Scholarship Program. All applications must be sent to the Scholarship Chair by January 8, 2010. The Chair will send scholarship packets to all applicants by the end of January 2010. The scholarships are available to the dependent children or grandchildren of members of NALC Branches within the State of California who have not served in a supervisory capacity in the previous two (2) years from the date of 2010 award announcement. Applicant's parent / grandparent must be a member in good standing of the NALC for at least one year prior to applying. Applicant must be a high school senior when applying. Saxsenmeier Scholarship awards are issued in the year of graduation and are not renewable.

Applications have been mailed to all shop stewards and contain all information that is needed when applying.

If you have questions about your volumes or if there was an addition to your route that is not working, or your line of travel isn't right, you need to tell them. There has been a lot of complaining and finger pointing from some of you and we know that it has been very frustrating, however, when in the past have you ever had the chance to have an adjustment fixed in a revisit? The answer is never. This process affords us the opportunity to come back and check how you are doing on your route with the NALC there to make sure it's fair and done with integrity. If we can make something work we will. If it doesn't you should be told why. Not everyone will be happy with this process its impossible the make everyone happy. All we can do is the best we can. This branch will do the best it can in this process for you. We will need your help to be successful. If there is now comments or suggestions from you we will be flying blind when it comes to knowing what you might have an issue with on your route. I can't tell you how many times someone complained about their adjustment and when we went back and looked again at their comments or suggestions there weren't any. If you were a COR site you have a right to be skeptical. Your comments meant little. I admit, because that program does what it finds to be the most economical for the Postal Service. It does not care about routes or carriers because it's a program. But, like most programs if the data entered was correct the problems will be minimal. That wasn't the case in many of the COR sites it was used in but those issues are being addressed and the more the program is used the more we are able to get around the problems and fix them. Hopefully, the revisit will help alleviate some of the problems caused by this new and frustrating, often misunderstood program.

Sherman Oaks and Encino will not be on the first machine for FSS. That is good news. It buys you some time between disrupting route adjustments. It is coming sometime early next year for offices in our branch. We will be looking at close to 7 hour street times and 1 hour office times. It also means another round of pulling out routes in stations. This time it will be done without any NALC members on the team and all the FSS sites will be COR adjusted. I pray that the data input, by then, will be perfected and the technicians will be competent.
