# PRESIDENT'S REPORT By Calvin Brookins

#### **NRP** Grievances

During our last leadership conference this past August the National Business Agent office announced that they were attempting to settle all NRP cases that were pending at their level. Those efforts continued for awhile, but recently those efforts reached an Impasse and all NRP grievances are to be processed through the grievance/arbitration procedure at this time. We currently have several NRP and NRP pilot grievances pending arbitration some have actually been scheduled for arbitration and others are waiting. The carriers involved in those that has been scheduled for arbitration have been contacted by this office if I have not talked to you I will be contacting you soon.

### **Muscular Dystrophy Association (MDA)**

The final results from the bowl-a-thon held in November has been published in the January 2010 Postal Record. The top fund-raisers according to branch size were also printed in the Postal Record. According to the report the first National Bowl-a thon put on by the NALC raised \$300,000.00 for Muscular Dystrophy Association (MDA).

#### No Accumulation for Sixth COLA

There was no accumulation for the sixth cost-of-living adjustment (COLA) under the 2006-2011 National Agreement. There also will not be any accumulation toward the 2011 retiree COLA for both CSRS and FERS retirees. Retirees will not receive a cost-of-living adjustment in 2010 because of declining prices.

The projected accumulation toward the 2010 COLA for Federal Employees Compensation Act (FECA) participants, which is based on the increase in the CPI-W between December 2008 and December 2009 stands at 3.5 percent this will be effective on March 1, 2010.

#### **Food Drive**

Registration for the 2010 NALC Food Drive has begun; the NALC Food Drive is on verge of reaching a mile stone by breaking through the one billion pound level in total donations collected since the Food Drive began in 1993.

President Rolando is urging all branches to increase their efforts, we are attempting to do that by getting more media support through MEND and KCBS and KCAL television networks. We will know more of how that is going after our next meeting with them on Wednesday January 13, 2010.

#### **FSS Impact**

Our National Business Agent Manny Peralta has been notified as to how many routes and/or full time carriers will be impacted by the implementation of the FSS machines. In a letter dated December 14, 2009, the Postal Service notified our National Business Agent of their intent here in the Sierra Coastal District to utilize the provisions of Article 12, Section 5.C.5 of the National Agreement to involuntarily reassign up to 201 full-time carriers and part-time flexible carriers at 18 separate post offices from the craft and/or installation based on the deployment of the FSS. Here in Van Nuys management has projected that there will be 33 full-time carriers impacted by the implementation of FSS. That basically means that we could have up to 33 letter carriers excessed from Van Nuys five city offices.

The impact list that I received did not include Sun Valley and Tarzana in regards to carriers being excessed. However, management in this district does intend to withhold up to 120 full-time residual assignments in the carrier, clerk, mail handler and custodial crafts in offices and plants within a 200 mile radius for placement of the impacted carriers in the 18 separate post offices that was listed. This is an important message to all letter carriers, when an assignment is posted for bid and you are an unassigned regular you should make sure that you bid on any and all assignments that are posted for bid. If those assignments are posted and no one bid on them, then management will withhold those assignments for the purposes of excessing employees. As I get more information on this issue I will place it in the MailCall.

#### WORKING OFF THE CLOCK

As I go from station to station I continue to find carriers working off the clock, either prior to begin tour in the morning or after ending tour in the afternoon. It is alarmingly shocking to me as to why anyone would work off the clock, basically working for free. For all of you who are working off the clock let me remind you of something. The way that your route is being adjusted these days is all based on the mail volume you get and the time you use performing your letter carrier duties. When ever you decide to show up at work 30

minutes early and case mail, pull redis, sort your parcels and load your coverage's in your vehicle and then walk over to the time clock and clock in you have just reduced the time that could have been you to properly adjust your route. You at that point have successfully taken time away time from your route that cannot be accounted for.

The Collective Bargaining Agreement has language in it that states management should not allow employees to work off the clock; this includes allowing employees to work through their 10 minute breaks. The National Agreement states in relevant part;

Article 41.3.K. Supervisors shall not require, nor permit, employees to work off the clock.

Rest Breaks. National Arbitrator Britton ruled that the Postal Service must ensure that all employees stop working during an office break. Contractual breaks must be observed and cannot be waived by employees. (H4N-3D-C 9419, December 22, 1988, C-08555)

This language is not negotiable on a day to day basis, and your supervisor should not look the other way when you are working off the clock, believe me they see you while you are working off the clock but guess what that help them accomplish what they need to with using less time for it.

So please stop working off the clock because you are placing me and the shop stewards in a position as to where we will have to force your supervisors to follow the National Agreement by filing grievances for them to stop carrier from working off the clock. Then if you do not stop working off the clock after your supervisor has instructed you to, then they will attempt to issue discipline. Please do not force us to go that far with this. When you work off the clock you are basically working for free. Why work for free when you can work and get paid for it.
