PRESIDENT'S REPORT By Calvin Brookins

In last month "Mail Call" I wrote an article about carriers working off the clock, I will continue to periodically place this article in the "Mail Call" in the future. Because it appears that there are some carriers who need a constant reminder of this. So if you are one of those carriers that need a reminder here it is again alone with the contract regulations regarding you not being permitted to work off the clock.

WORKING OFF THE CLOCK

As I go from station to station I continue to find carriers working off the clock, either prior to begin tour in the morning or after ending tour in the afternoon. It is alarmingly shocking to me as to why anyone would work off the clock, basically working for free. For all of you who are working off the clock let me remind you of something. The way that your route is being adjusted these days is all based on the mail volume you get and the time you use performing your letter carrier duties. When ever you decide to show up at work 30 minutes early and case mail, pull redis, sort your parcels and load your coverage's in your vehicle and then walk over to the time clock and clock in you have just reduced the time that could have been used to properly adjust your route. You at that point have successfully taken time away time from your route that cannot be accounted for.

The Collective Bargaining Agreement has language in it that states management should not allow employees to work off the clock; this includes allowing employees to work through their 10 minute breaks. The National Agreement states in relevant part:

Article 41.3.K. Supervisors shall <u>not require, nor permit</u>, employees to work off the clock.

Rest Breaks. National Arbitrator Britton ruled that the Postal Service must ensure that all employees stop working during an office break. Contractual breaks must be observed and cannot be waived by employees.

(H4N-3D-C 9419, December 22, 1988, C-08555)

This language is not negotiable on a day to day basis, and your supervisor should not look the other way when

you are working off the clock, believe me they see you while you are working off the clock but guess what that help them accomplish what they need to with using less time for it.

So please stop working off the clock because you are placing me and the shop stewards in a position as to where we will have to force your supervisors to follow the National Agreement by filing grievances for them to stop carriers from working off the clock. Then if you do not stop working off the clock after your supervisor has instructed you to, then they will attempt to issue discipline. Please do not force us to go that far with this. When you work off the clock you are basically working for free. Why work for free when you can work and get paid for it.

IN OTHER NEWS

President Obama recently released his FY 2011 Budget and in that budget he supports the continued six day delivery. He also went on record and stated that he does not support privatization of the Postal Service. However, it was reported in the news on Tuesdays March 2, 2010, that Postmaster General Potter is going before Congress again asking that the Postal Service be allowed to go five day delivery. I believe this is a bad idea for the USPS because once we lose that service we will never get it back, I also believe a move such as this would be counterproductive. Let's just hope President Obama has some influence in this issue.

The NALC has gone on record opposing the elimination of 6 day delivery; President Fredric V. Rolando issued a press release shortly after the report came out, I am placing it here in the "Mail Call" for your convenience.

Letter carriers union opposes cutback in mail service; urges Congress to give USPS financial breathing room.

The president of the 300,000-member National Association of Letter Carriers (NALC) today opposed the proposal by Postmaster General John E. Potter to eliminate Saturday delivery to American homes and businesses, and urged Congress instead to take steps that would provide financial breathing room while a better plan can be developed.

MIARAP will have concluded and hopefully most of the problems on your routes have been alleviated.

GPS is here and being used in some offices to track carriers out on the routes. Right now there are no offices in our branch with these devices on their vehicles. If they decide to use them in your office you will be notified. Not all the routes with have the vehicles with the devices. They plan on targeting only the routes that the carriers are working substantially over their base times or routes that have unexplained mileage beyond with the route should have. The vehicles with these devices will be moved into those stations and on the routes that they are going to target. If you are not doing anything to draw suspicion to you then there is nothing to worry about. If your route has delivery issues that need to be fixed please have those issues addressed now so you will not be one of the "lucky" carriers that will be using one of these vehicles.

Notify your Congressman and your Senators and that you want to continue to deliver mail 6 days a week. Ask them not to support a 5 day work week. If the Postal Service succeeds in getting this to pass Congress it will cost us over 25,000 jobs and severely hurt customer service. If we don't deliver on Saturdays someone else will.

union. Start now contacting your Congress person and encouraging them to vote to preserve six day delivery.

We also received word from California State Association of Letter Carriers President John Beaumont; he stated that while they were in Washington D.C. they were able to mount an attack on Postmaster General Potter's ill advised plan to push five day delivery. He stated that they were able to meet with 20 representatives from the California Delegation and every one of them pledged to sign on to H Res 173, which states that the United States Postal Service should take all appropriate measures to ensure the continuation of its 6-day mail delivery service.

So we need to be ready to fight for 6 day delivery, one way we can fight against Postmaster General Potter's actions is to contact our Congressional Representative and encourage each of them to support the continuation of 6 day delivery. We can only do this with the help of all members of the branch. There is currently a House Resolution bill called H-Res 173. It is a bi-partisan bill that was introduced by Republican Sam Graves of Missouri. That bill states as follows; "That it is the sense of the House of Representatives that the United States Postal Service should take all appropriate measures to ensure the continuation of its six-day mail delivery service".

A vital step in the process of eliminating PMG Potter's actions toward five-day delivery is to get co-sponsors for this bill H-Res 173. All letter carriers need to write a letter to their Congressional Representative encouraging them to be a co-sponsor on H-Res 173.
