## PRESIDENT'S REPORT By Calvin Brookins

#### Flat Sorting System (FSS)

FSS is here, it was implemented in Tarzana on January 25, 2011, on that day the carriers cased the FSS flats for quality purposes. On January 26, 2011, the carriers took the FSS mail directly to the street without casing it. To this point the carriers has had very few flats to case and this saves on office times and most carriers if not all have some amount of under time. In other words FSS does have an impact on office time. What has to be determined is the exact impact FSS will have on each route. We do know that there will be an impact on the letter carrier craft because of FSS, and that we will lose routes as a result of FSS. However, FSS is going to be a learning experience for us all.

The Step 4 decision gives two different scenarios on how letter carriers can handle the residual cased mail on coverage days on park and loop routes or portions thereof. The Step 4 decision reads as follows;

In order to maintain three bundles on pre-sequenced mail days, letter carriers serving park and loop or foot deliveries may only be assigned to either:

Case residual mail, then collate with FSS mail while in the office... or, case residual mail, then collate with the presequenced addressed mail (coverage) during pull down while in office. There is no change to current work methods for other types of deliveries.

At this time management has agreed that on park and loop routes or those portions of park and loop deliveries on a route on a coverage day the carrier will be allowed to case residual mail and pull it down and collate it into the FSS mail while in the office.

We are currently still trying to get management to allow carriers to collate residual mail into FSS flats on all routes and on all days regardless of type of delivery. What management needs to understand is that they will get their savings when they are able to adjust routes and eliminate routes. They will not get a true realization of their savings from whether or not a carrier is allowed to collate their mail on any route everyday regardless of type of delivery.

## **Vice President's Report**

Our National Food Drive is coming up within the next couple months. The T-shirt order forms will be given to the shop Stewards in your stations soon. The shirts this year will be red with pockets and will all cost \$14.00. I haven't yet heard from Ralph's about getting bags again this year. I hope we do since it helped us double our food donations. We had a meeting with KTLA and they are going to do a Public Service Announcement this year and we are working on doing another event with them the week of the Food Drive. Perhaps with one or more of their on air personalities. We are also going to attempt another kick off media event at the MEND food bank on May 10th.

By the time you read this many of you will be on FSS and route adjustments will be eminent. These adjustments will be difficult and most of your routes will be very different then they were. Make sure that the line of travel is the way it should be before it is finalized. Management does not have to ask you so you ask them to let you check the line of travel. If they are smart they will ask you the best way to deliver it. If this doesn't happen and your line of travel is messed up it will take a long time to get it fixed. There will be a lot of lost routes and we may have carriers excessed. Come to the next branch meeting where we will be talking about excessing and FSS and COR adjustments. You need to be coming to the meetings the first Tuesday of the month. The time is now for you to get involved in the future of the Postal Service and your place in it. We all have to work together in a professional way to make this all work.

Unfortunately, there are offices where the relationship between the managers and the craft has become difficult and disrespectful. This will make this process of change much more difficult and stressful. We will try and make sure it goes as smooth as we can. I know I have said this all before but it needs to sink in. Managers are the ones freaking out and unsure what to do. Carriers, no matter what, come in and get the mail delivered no matter with the new process is or system implemented. Collate- don't collate- collate schmollate who cares? They don't let us do it in the office we don't do it in the office, but be sure of this, it will take longer on the street if we don't.

Kerry Wolny, our District Manager has said he believes we should be collating our residual flats into our FSS but he won't make his Postmasters and MPO's implement that policy. He should step up and enforce the same policy in all zones of collating on all routes everyday and stick too it.

An agreement was reached between the USPS and the NALC back in 2007, allowing management to determine the methods to be used to estimate the impact in a delivery unit and make route adjustments accordingly. The Memorandum of Understanding reads in relevant part;

Once FSS is fully implemented in a delivery unit, management will determine the methods to estimate impact in a delivery unit and make route adjustments accordingly.

Sixty days after implementing route adjustments for FSS, the local parties will review the adjustments to ensure that routes are as near 8 hours as possible... If either parties determines that the route(s) is not properly adjusted, then the route(s) will be adjusted in accordance with the provisions of Handbook M-39 or, if applicable, a locally agreed upon adjustment formula.

In this district management look at the FFS volume during the first week of FSS or the first two weeks of FSS and then determine the impact of FSS and then adjust accordingly, then the adjustments will be reviewed in 60 days.

In short we have some challenges ahead with FSS and the adjustment of routes which will no doubt be under the COR process, which we are likely to lose routes and after that possible excessing of letter carriers to withheld positions in other offices.

On Monday February 7, 2011, FSS will be implemented in Encino 91316 zone.

On Wednesday February 16, 2011, FSS will be implemented in Encino 91436 zone.

On Tuesday February 15, 2011, FSS will be implemented in Sherman Oaks 91423 zone.

On Thursday March 24, 2011, FSS will be implemented in Sherman Oaks 91403 zone.

The following is only to give you an example of how an office could be impacted because of FSS and the adjustments of routes.

Union Chief Blasts New Postal Delivery Scheme Used in Brookline, Mass.

"The president of the union representing Brookline, Mass. letter carriers criticized the cutting of Post Office routes as part of a new automated mail-sorting effort that has led to complaints about late mail delivery. Robert A. Lind, president of Branch 34 of the National Association of Letter Carriers, said the implementation of the new flat-sized mail sorting process and a cut of a dozen mail routes in town - was a purely budgetbased decision, and letter carriers are struggling to keep up."

such as Article 41, Section 3.0 under the National Agreement as well as possible excising under Article 12 of the National Agreement.
