PRESIDENT'S REPORT By Calvin Brookins

As some of you may know by now there was an unprecedented congressional hearing regarding an agreement negotiated by the Postal Service and the APWU. This shows just what the letter carriers and the rest of the postal workforce are up against with this current Congress. On April 5, 2011, the Republican-led House Oversight and Government Reform Committee held a hearing titled "Are Postal Workforce Costs Sustainable?" It was aimed at scrutinizing the recently agreed upon contract hammered out between the USPS and the APWU. There were several anti-labor committee members saying that it didn't go far enough in reducing postal service costs. Three of the witnesses called to testify were APWU President Cliff Guffey, Postmaster General Patrick Donahoe and Postal Board of Governors Chairman Louis Giuliano. They only had good things to say about the agreement between the APWU and the USPS.

However, there was a fourth witness, Board of Governors member James Miller, a Bush appointee he agreed that the tentative contract was the best possible agreement that could have been reached under current laws. Then his comments seem to turn south real fast only to agree with Committee Chairman Darrell Issa unfounded complaints about postal pay and benefits. Issa and Miller both want the same thing, to discredit the agreement and attempt to force the USPS into privatization. We should keep politics out of postal bargaining; by not having politics mixed up in bargaining has served the parties, the American people and the mailing public very well for 40 years. In case they haven't notice we have decent jobs, the mailers get high-quality service at very affordable rates and the taxpayers don't have to foot the bill. 'Unlike Wall Street'.

Every instance where Donahoe or Democrats made their case, anti-labor members of the committee just as often returned to criticism of the APWU-USPS agreement. Many appeared to favor ideas that tipped bargaining scales in the Service's favor and that would reduce workers' benefits and wages. Miller, appointed by George W. Bush and a former Board of Governors chairman, has made no secret of his interest in privatizing the Postal Service and nullifying its collective bargaining agreements with its craft unions.

President Rolando put the session in a broader context when he stated. "We letter carriers are fooling ourselves if we believe that we are going to get a pass from

these anti-labor forces that are unfairly targeting firefighters and police, nurses and teachers, and are doing so with little regard for the facts," he said.

"And in this atmosphere, it won't be impossible to get our legislative agenda passed, but it will be extremely difficult. It will take all of us standing together, and working with our allies on Capitol Hill and elsewhere."

Congress Back to Work:

While Congress was on its two-week spring break, letter carrier activists were busy visiting members in their home-district offices, pressing for support for <u>H.R. 1351</u>, the USPS Pension Obligation Recalculation and Restoration Act. Now's the time to make sure they're signed on as co-sponsors. So far, **35** House members are on the list.

On April 5, 2011, Rep. Stephen Lynch (D-MA) introduced H.R. 1351, the United States Postal Service's Pension Obligation Recalculation and Restoration Act of 2011.

Lynch, the ranking member of the House Subcommittee on the Federal Workforce, Postal Service, and the District of Columbia, was the first member of Congress to author legislation last Congress to address a decades-old accounting error that led the Office of Personnel Management (OPM) to overcharge the Postal Service by billions of dollars for payments into the Civil Service Retirement System (CSRS).

Lynch's bill once again takes a big step toward making sure the Postal Service is treated in a fair and equitable manner, allowing it to overcome the very difficult financial challenges it currently faces. In addition to addressing the CSRS overcharge, H.R. 1351 also deals with the more recent finding regarding another overcharge to the USPS related to the Federal Employees Retirement System (FERS). Even so, H.R. 1351 only addresses the CSRS and FERS overcharges and does not repeal the onerous, legally mandated, annual pre-funding payments into the Postal Service Retiree Health Benefit Fund (PSRHBF).

It calls on the OPM to recalculate the USPS surplus in the Civil Service Retirement System within six months of enactment, using a methodology that fairly allocates the cost of pensions between the Post Office Department and the U.S. Postal Service as proposed by the Segal Report. Then, once

The bill would then direct the OPM to permit the USPS to use most of its \$6.9 billion surplus in the FERS system to satisfy two obligations in FY 2011: a \$5.5 billion payment due to the PSRHBF, and a \$1.2 billion estimated payment to the Department of Labor for Federal Employees Compensation Act (workers comp.) expenses. Any remaining funds would be used to reduce the Postal Service's normal cost-percentage for FERS in future years.

Additionally, the date of the transfer for the overcharge is less important than the acknowledgment by Congress and the OPM that the USPS has sufficient assets to cover all its retirement obligations for both pensions and health benefits. Since the PSRHBF already has more than \$42 billion in it, and since the surplus transfer from the CSRS pension fund would likely leave the PSRHBP fully funded, passage of H.R. 1351 makes an irrefutable case for the repeal of the prefunding payments called for by current law.

The Lynch bill would transfer surplus CSRS and FERS assets paid for by ratepayer and employee contributions not taxpayer funds to the Postal Service's retirement health fund, and it would have absolutely no effect on any current or future federal retiree's annuity. The NALC supports swift passage of H.R. 1351.

By the time you read this our 19th Annual Food Drive would have come and gone. I will not have the totals from each station until the July Mail Call newsletter since I will not have them before this goes to press for the June news letter. I know you all worked very hard to make this year's drive as successful as last years. Thanks for your efforts. COR = Carrier Optimum Routing- what can I say about this program? Well let me start by saying it isn't the program that is the problem. It's actually a decent mapping tool we can use to move territory from one area to another. The problem is poor data prep, bad 3999's and COR tech's who push the button to generate routes without entering the proper parameters such as, bag weight, speed limits and turn defaults etc. Worst of all, not taking into account local office knowledge when doing lines of travel, not making sure that the edit sheets are corrected and verified before sending the adjustment to AMS for implementation. Even if this is done, if the data prep and 3999's were inaccurate the adjustments will be less than stellar. Most COR tech's do many different scenarios to try to get the best outcome for the office. Key word, most. Many tech's will take seniority into account when doing adjustments. Key word, many. In the JARAP process, seniority has to be considered. In the FSS offices it is not. We were not part of the FSS adjustments (officially, some were able to help) but we will be part of the 60 day review to help realign routes to 8 hours if they are still out of adjustment. My guess is there will be guite a few.
