### **Contract Negotiations**

On August 18, 2011, the NALC and the USPS opened negotiations on a new collective bargaining agreement. Contract negotiations is ongoing we should get an update at the Rap Session later this month.

In accordance with Article V of the NALC Constitution and Article V of the By-Laws of Branch 2462, NALC, notice is hereby given for the Nomination and Election of Delegates to the State and National Convention, Nominations will be held at the December Meeting on December 6, 2011. Election if needed, will be held in January 2012 and will be conducted by mail, as provided in Article IV of the By-Laws of Branch 2462 NALC. All members, in good standing, are eligible to be nominated. Any member, not in good standing or who has not attended at least eighteen (18) regular meetings during the twenty-four (24) months prior to their nomination as a Delegate shall not receive any expenses from the Branch. All members of the Executive Board, by virtue of their office, shall be Delegates to all National and State Conventions. # Vice President's Report Janette Dolabson

This is an email I received from our California State President, John Beaumont regarding HR 1351

"Two weeks ago we had the opportunity to meet with Democratic House Leader Pelosi's Chief of Staff, and Lead Counsel on the status of the Postal crisis and HR 1351. Last Monday we met for the second time this year with Leader Pelosi herself in California. At last weeks meeting Leader Pelosi again acknowledged her strong support for continuing 6 day delivery and support of Lynch's bill, HR 1351, but again stated the House Leaderships policy of not co-sponsoring bills. Representative Pelosi was very interested in our concern and at the conclusion of our conversation she agreed to at least look at the bill again before the end of last week.

This morning Leader Pelosi's Chief of Staff called to tell me that the Leader has agreed to co-sponsor HR 1351. She later sent an email to confirming the Leaders decision to co-sponsor our legislation.

To date now all 34 California House Democrats are on our bill. First time this has happened in over 10 years."

We will not give up 6 day delivery without a fight. Those of you who think it would be great having weekends off are assuming that the day of delivery being eliminated is going to be Saturday. That is not necessarily the case. The Postmaster General has stated it would be 5 day delivery. Not no Saturday delivery. It will probably be Wed, or Thursday that would be no delivery. Once the Postal Service is given the authority to decide on their own how many days to deliver mail don't think they will stop at 5 days. There would be nothing to stop them from going to 4 days soon after. Think about it. If we are only working 4 days what do you think that does to our full time status? We now would be part time employees. What would that do to your budget? Your benefits? Be smart and fight for 6 day delivery.

Hope those of you who came to the picnic had a good time. It may be the last one we have in a while. It is getting too expensive to put on, especially when so few members even go to it. We will be deciding the fate of the annual picnic at upcoming meetings. Perhaps we will only have one every other year. We shall see

### **Obama's Proposal**

President Obama sent a deficit-reduction package Sept. 19 to the special joint committee of Congress established by the debt limit law to find ways to reduce the federal budget deficit. The package included a number of reforms to address the financial crisis at USPS. We are both encouraged and disappointed.

We are encouraged that President Obama is attempting to creatively address the USPS cash crisis through the deficit reduction process and welcome his proposal to return the \$6.9 billion postal pension surplus in FERS to the Postal Service as proposed in Rep. Stephen Lynch's <u>H.R.</u> 1351.

But we are very disappointed that the administration opted for a deferral of the next two pre-funding payments (\$5.5 billion each) instead of embracing a permanent reform based on the Lynch bill's recovery of the even larger CSRS surplus. And we deeply regret that the administration has given into pressure from the postmaster general and has proposed to eliminate Saturday mail delivery.

The NALC has carefully examined the various elements of the White House plan. It is important to remember that these are just proposals; they cannot become law unless Congress adopts them. We want to assure our members and all those who are interested in preserving the U.S. Postal Service that we will work with everyone involved, including members of the joint congressional committee, to build a strong Postal Service that will continue to provide exceptional service to the public six days a week.

### HRSSC

Human Resources Shared Services Center (HRSSC) has begun processing all Family Medical Leave Act (FMLA) requests for all employees this started on September 10, 2011. FMLA requests will continue to be handled in accordance with the policy outlined in the Employee Labor Relations Manual (ELM).

The FMLA packet will be updated to reflect a return address and fax option change to that of the HRSSC. An HRSSC Processing Specialist will now be the point of contact rather than an FMLA Coordinator.

The HRSSC staff will be available far case specific questions, Monday through Friday from 7:00 a.m. until 8:30 p.m. EST.

On September 15, 2011, NALC President Fred V. Rolando was sent a letter from Alan S. Moore Manager Labor Relations Policy and Programs the letter stated the following;

The Postal Service plans to test restructured city letter carrier assignments by separating a delivery unit's office casing and associated duties from street duties.

For the test we will evaluate the value of existing assignments and then, to the extent practicable, create fulltime street assignments and full time office assignments. Depending on mail volume and operational requirements, office assignments may include some associated street duties.

During the test, casing configurations in some units may be reduced by combining casing equipment or by creating carrier cases that dictate horizontal casing by block face rather than by separate addresses.

We intend to test this concept in more than one phase. The first phase will include existing Flats Sequencing System (FSS) units that have not had initial FSS adjustments. We expect to later test in non FSS sites with different levels of mail volume.

We have enclosed a list of delivery units that will participate in phase one. We anticipate that assignments will be created and assigned on or about October 1, 2011. The test is tentatively scheduled to continue for a period of six months.

Since we work in the Pacific Area I am going to only list the test sites in this area.
