PRESIDENT'S REPORT By Calvin Brookins

Withheld Positions

The NALC is in the process of getting all withheld positions that has been withheld for a year or more released. Once that happen the Union will be asking that the senior PTF be converted to full-time and assigned that position. At this time we only have one withheld T-6 position in Tarzana. There are several T-6 positions that have been withheld through out the country and the NALC is in the process of getting those positions released and attempting to get the appropriate senior PTF converted to full time and placed into those vacant positions. I will update you at a later time on that progress.

Contract Negotiations

We have now moved closer to interest arbitration. In interest arbitration, each party selects an arbitration advocate to represent it on a three-person board, with the third person being an independent and neutral third party chosen by both parties to resolve the dispute. We now know who that neutral third arbitrator is. His name is Shyam Das. Arbitrator Shyam Das will chair the three person arbitration board that will set the terms of the Collective Bargainin Agreement.

Arbitrator Shyam Das is a member of the American Arbitration Association's labor panel and has been a full-time labor arbitrator since 1977. He has served on national arbitration panels involving postal workers since 1996 and has chaired arbitration proceedings involving United Steelworkers and Major League Baseball Players Association. The arbitration board is now working on a schedule for hearing. Once arbitration is underway, those hearings could last for several months.

Safety

It is important that all letter carriers take this advice seriously, whatever you do not ever get out of your postal vehicle and leave the engine running. Remember if that vehicle starts to move without you in it you have no control over it at t hat point. Again if you get out of your vehicle for any reason you should turn off the engine, even if you are just doing a vehicle check in the parking lot. You do not want to be that person that causes power rollaway that could injure you or someone else. Please be safe while performing your postal duties.

An appropriations battle on six-day delivery service

By the time you receive this copy of the MailCall, the fight to save Saturday delivery will have taken center stage in the House of Representatives. The House is expected to take up H.R. 6020, the annual Financial Services and General Government appropriation bill. Although the bill does not appropriate any taxpayer money for the Postal Service, its passage is important to the future viability of the USPS since it includes a provision (policy rider) mandating the continuation of six-day delivery service just as it has every year since 1984. NALC has learned that House Government Reform Committee Chairman Darell Issa (R-CA) may seek to strip the provision from the bill next week when the House begins debate on the legislation by raising a parliamentary point of order arguing that the six-day mandate violates House rules that bars Congress from legislating on an appropriations bill. Issa sent a letter to the Rules Committee Chairman David Drier in June requesting an "open rule" for the debate on H.R. 6020 so that he can raise the point of order, which Drier granted.

Six-day delivery service has broad bipartisan support in the House, as demonstrated by the 222 co-sponsors of H. Res 137, who call for six-day delivery service to be preserved. Nevertheless, Issa is using the financial crisis caused by the 2006 mandate to pre-fund future retiree health benefits as an excuse to massively downsize the Postal Service. If he is successful in stripping the six-day delivery service provision from H.R. 6020, some 25,000 city letter carrier jobs and 80,000 USPS jobs could be threatened. Such a service cut would do more harm than good as more mailers would abandon the USPS as the value of mail declined.

NALC is mobilizing its grassroots network of legislative activists to resist the Issa attack on six-day delivery service. We will target our efforts to build a solid majority of Congress to support continued six-day delivery service.

A Senate appropriations bill, which serves as a counterpart to H.R. 6020, contains the six-day provision and has been passed by the Senate Appropriations Committee. A vote of the full Senate on this measure is still pending. Once both houses of Congress have acted, a conference committee would need to reconcile differences between the bills. NALC will fight to preserve six-day delivery service in the House and in any future conference committee.

Vice President's Report Janette Dolabson

We have become aware that the new OIC of Van Nuys has decided that it would be a good idea to set up a rating system for letter carriers based on managements perceived opinion of the carriers performance. The carriers are rated D-1 through D-4 with D-4 being the best and D-1 the worst. The "best" carriers will be left alone and not be questioned on their 3996 requests, while the "worst" performing carriers will be guestioned and scrutinized daily.

This is clearly a violation of the contract. I am sure Mr. Martino is aware that you cannot discipline carriers about their performance unless they can identify what the carrier is doing that is a time wasting practice or what deficiencies the carrier has. This is obviously an attempt at intimidating carriers in to working faster or skipping breaks and lunches so they don't get in trouble when they find themselves being over the time management has told them they should need rather than what they actually need based on all data that managers don't take into consideration.

If you find yourself being rated and called into the office and asked why you have not performed properly, you need to ask for a steward because it has just become a fact finding. If the manager states that these questions will not lead to discipline you should still ask for a steward. If you are refused one, file a grievance.

Health care update from NALC web site

"Last week, the U.S. Supreme Court rejected efforts to invalidate President Obama's historic health care law that will extend health insurance coverage to nearly 30 million Americans between now and 2014. Right-wing opponents of the legislation asked the Court to throw out the law enacted in 2010 as an unconstitutional use of power by the national government. By a 5-4 vote, the Court upheld the legislation, preserving reforms that are already benefiting NALC members, including a provision that allows children to stay on their parents' health plan until the age of 26 and a provision that eliminates the so-called 'donut hole' in the Medicare Part D program that saves seniors thousands of dollars on prescription drug costs."
