# PRESIDENT'S REPORT By Calvin Brookins

#### House committee passes Issa bill:

On July 24, 2013, The House Oversight and Government Reform Committee passed Chairman Darrell Issa's (R-CA) Postal Reform Act of 2013 bill H.R. 2748. Obviously the NALC opposes this bill and is asking committee members and the rest of the House of Representatives to vote NO on this bill

The reason the NALC is asking the committee members and the rest of the House of Representatives to vote NO on this bill is being reprinted in this issue of the MailCall.

The reason it is being reprinted in the MailCall is because I want every member of this branch to clearly understand why it is utterly important that you contact your Congressman or Congresswoman to encourage then to vote NO on H.R. 2748.

## Vote NO on H.R. 2748: The Postal Reform Act of 2013

<u>Title I of H.R. 2748 slashes services to Americans and eliminates at least 100,000 good jobs:</u>

- Elimination of Saturday mail delivery would sacrifice the Postal Service's biggest advantage over its competitors.
- The forced removal of 30 million household & business mail boxes would impose an unfair and deeply unpopular burden on customers with door deliveries while conversion costs add an additional \$1 billion in debt (see Sec.504).

# <u>Title II of H.R. 2748 creates a costly new level of</u> bureaucracy at the Postal Service:

- Rather than skimming the fat off the top, this bill cuts services and blue-collar jobs in favor of creating a \$10 million a year Governance Authority.
- Congress should improve the existing USPS Board of Governors by requiring well-qualified business leaders focused on long-term growth and innovation.
- Instead of fixing what is really broken, H.R. 2748 creates a new body that will be tasked with cutting costs by abrogating collective-bargaining agreements and dismantling the Postal Service's networks.

# <u>Title III of H.R. 2748 is a direct attack by Congress on</u> collective bargaining:

- This section would unfairly codify into law the views of postal management.
- This kind of one-sided interference by Congress is totally unjustifiable and is an attack on postal employees.
- Mandating the terms of future collective-bargaining agreements would completely undermine a process that has worked extremely well for over 40 years keeping postage rates low and eliminating all taxpayer subsidies.
- This section also mandates new "official time" reporting procedures that will increase costs and bureaucracy for the Postal Service to fix something that is not broken.

#### <u>Title IV of H.R. 2748 fails to recognize the Postal</u> Service's flawed rate-setting model:

- H.R. 2748 does not give the Postal Service the flexibility it needs to adjust rates to ensure that products cover their costs. Instead, the bill forces the Postal Service to cut services and eliminate jobs unnecessarily.
- H.R. 2748 does not free the Postal Service to meet the evolving needs of the American economy by allowing it to expand into new lines of business that would leverage its firstand last-mile networks.
- H.R. 2748 eliminates the small appropriation that the USPS receives annually to provide free service to the blind and to combat serviceman who wish to vote by mail in American elections shifting costs to business mailers.

# Title V of H.R. 2748 fails to provide a long-term solution to the disastrous and unfair pre-funding burden:

- The Committee is being asked to vote on a bill without cost estimates of the new pre-funding schedule.
- While the bill provides earlier access the Postal Service's own money in the Retirement Health Benefit Fund (PSRHBF) and *appears* to defer pre-funding payments for two years, the remaining 40-plus years of scheduled payments will remain unaffordable, surpassing the \$5.6 billion annual payments mandated by current law.

# Title VI of H.R. 2748 jeopardizes the Postal Service's most important asset: Its brand for trusted universal service:

- The USPS has delivered reliable service to both urban and rural communities across American for centuries.
- Veteran's preference and solid union contracts have created America's most trusted workforce.
- The Committee should reject the destructive increase in sub-contracting that H.R. 2748 mandates.

# Postal unions write joint letter to Reid against Carper-Coburn postal bill: **S.1486**

On August 5, 2013, the presidents of the four postal employee unions the National Association of Letter Carriers, the American Postal Workers Union, the National Rural Letter Carriers' Association and the National Postal Mail Handlers Union sent a letter to Senate Majority Leader Harry Reid (D-NV).

This letter was sent to express their dismay with the introduction of S. 1486 on August 1, 2013, a postal bill introduced by Senators Tom Carper (D-DE) and Tom Coburn (R-OK) that renews a commitment to the disastrous Bush administration policy to mandate massive pre-funding of future retiree health benefits and provides for major downsizing measures to pay for it. #### Postal Service overtime costs top \$3.5 billion

The following was recently reported in the Federal Times – FYI

Even as total work hours are falling, overtime at the U.S. Postal Service continues climbing. Overtime costs last year hit \$3.5 billion, up almost 7 percent from 2011, according to a new audit by the agency's inspector general. At one Des Moines, lowa distribution center, overtime pay for seven mail handlers ranged from \$65,000 to \$76,000 each, more than double their respective salaries, according to the audit.

Although overtime hours are not supposed to account for more than 5 percent of total work hours under USPS management target, they added up to 7.8 percent last year. After falling sharply in 2009, the proportion of overtime hours has risen every year since.

Auditors attributed the increase in part to the continued downsizing of the Postal Service's workforce. But at some mail processing plants, they found that staffing failed to match the workload. Between 2009 and 2012, total work hours worked at the U.S. Postal Service fell 11 percent, while overtime hours worked increased 30 percent.

# **Cost-of-living adjustments**

The projected accumulation toward the next cost-ofliving adjustment (COLA) for letter carriers under the 2011-2016 National Agreement is **\$541**, based on the July 16 release of the June Consumer Price Index (CPI).

This COLA will be based on the increase in the CPI between January 2013 and July 2013.

NOTE: Under the terms of the 2011-2016 agreement, payment of this COLA will be deferred for one year and will take effect in the second full pay period after the release of the July 2014 CPI.

SPECIAL NOTE: Following the Feb. 21 release of the January 2013 CPI, the first COLA for letter carriers under the 2011-2016 National Agreement was \$145.60 annually. This first COLA was based on the increase in the CPI between July 2012 and January 2013. It amounts to 7 cents per hour, the equivalent of \$5.60 per pay period or \$145.60 annually. Note that under the terms of the 2011-2016 agreement, payment of this COLA will be deferred for one year and will take effect in the second full pay period after the release of the January 2014 CPI.

# John Beaumont President – California State Association of Letter Carriers

Today, by a strictly partisan 22 to 17 vote, Congressman Issa rammed through the Committee on Oversight and Government Reform his Postal Reform bill, HR 2748. While not one Democratic Representative supported his legislation, Chairman Issa and the Republican Majority members on the committee decided that the best way to reform the Postal Service would be to dismantle it.

How bad could this bill be?

Well imagine a bill that would eliminate more than 100,000 postal jobs, end Saturday mail delivery, discontinue door to door service to nearly 40 million American households adding an additional \$1 billion in debt to the USPS in conversion costs, abolish our no lay-off clause provisions in our contract, and mandate the terms of our future collective bargaining agreements. Well Issa's Postal Reform bill, HR 2748, contains all of these provisions and more. And if that wasn't enough this bill does not even address the largest fiscal issue facing the Postal Service by failing to provide any long-term solution to the disastrous and unfair pre-funding burden.

Prior to the hearing our members launched a barrage of calls to our other two committee members from California, Congresswoman Jackie Speier and Congressman Tony Cardenas encouraging them to support our NALC supported amendments and not support the final vote for HR 2748. Both representatives listened to your concerns and voted to protect our interests throughout the day. Unfortunately the numbers were stacked against us even before the hearing started and as the day went on vote after vote went against our interests and the interests of the American public including the final passage of the bill out of committee.

The CSALC wishes to thank all our members who took the time to call these representatives the day of the hearing in our effort to solicit their help on the bill.

The following five amendments were presented by members of the committee who believe in responsibly reforming the Post Office for both the patrons and the employees. The NALC also backs these amendments:

# 1. Cummings Amendment –

The Ranking Minority Member's amendment would strike H.R. 2748 entirely and thus prohibiting the move to a 5-day delivery schedule and expediting the closure and consolidation process of postal facilities. The Ranking Member's bill would also include his language from the Innovate to Deliver Act of 2013; H.R. 961, the United States Postal Service Stabilization Act; H.R. 1431, the Postal Employee Appeal Rights Amendments Act of 2013. The

inclusion of these bills would permit the Postal Service to offer non-postal products and services, recalculate the FERS surplus using Postal-specific assumptions and return any surplus.

Vote (22 Against to 17 For –Amendment fails)

## 2. Tierney Amendment striking section 306 -

This would eliminate the Chairman's provision to remove Postal employees from the Federal workers' compensation program into a Postal-specific program.

Vote (22 Against to 17 For – Amendment fails)

#### 3. Lynch Amendment #1

Striking section 102 – this amendment would eliminate the Chairman's provision requiring the Postal Service to convert existing addresses from door delivery to a curbside or centralized delivery point. The Chairman's bill would require the Postal Service to convert 30 million addresses by 2022.

Vote (22 Against to 17 For – Amendment fails)

## 4. Lynch Amendment #2 striking section 301 -

This amendment would strike the Chairman's provision to prospectively prohibit the use of anti-Reduction-in-Force language in collective bargaining agreements.

Vote (22 Against to 17 For – Amendment fails)

## 5. Lynch Amendment #3

Striking sections 501 & 505 and replacing the sections with H.R. 961

Vote (22 Against to 17 For – Amendment fails)

Even with this setback, the bill still must be scheduled by the Speaker for an overall vote by all the members of the House of Representatives, including votes on even more amendments to try to correct many of the onerous provisions Issa has written into the bill. Then if it is passed by the House it must be taken up by the Senate, who at this time is working on their Postal Reform legislation.

Taking this into account, we must prepare our membership for the next move. National President Rolando, and our DC Legislative staff, will be working with us on what will be needed to lobby our congressional representatives and our patrons so we can stop Issa and Postmaster General (PMG) Donahoe in their ill-advised plan to dismantle the United States Postal Service.

Now is the time for all of us to join the fight to Save 6 – Day Delivery and prevent the PMG and Congress from Dismantling the Postal Service. Everyone's livelihoods are at stake. Can we count on your help?
