## New MOU on filling residual vacancies:

NALC and the Postal Service have entered into the Memorandum of Understanding Re: Residual Vacancies - City Letter Carrier Craft (M-01824), which establishes a process for filling residual vacancies. Anyone who wants to consider transferring to another area can view the residual vacancies on the NALC website.

### M-01823 new MOU

The NALC and the Postal Service has reached an agreement regarding the hours of training that a new employee receives when arriving at the duty station. This provides 3 days (24 hours) of orientation and training when in this case new CCA's arrives at the carrier station. This is done with an OJI. Also CCA's are required to receive at least 2.5 hours of case training during the time they are with the OJI.

## Correspondence from the USPS to the NALC

### **DOMA**

On June 26, the Supreme Court ruled that Section 3 of the Defense of Marriage Act (DOMA) is unconstitutional. As a result of that ruling, the Office of Personnel Management (OPM) has decided to extend marriage based federal benefits under its supervision and control to federal employees, annuitants, and their same sex spouses who have legally married in a jurisdiction that permitted same sex marriages, regardless of where they currently live or work.

Regarding internal regulations, the Postal Service will recognize same sex spouses who have legally married in a jurisdiction that permitted same sex marriages, regardless of where they currently live or work.

#### **Handheld Scanners**

The Postal Service has notified the NALC that it intends to conduct a next generation Handheld Device test. The postal Service plans to evaluate six different devices from three vendors. Field testing is scheduled to begin September 30, 2013, and run for approximately six weeks. Test sites have

yet to be finalized but will be selected from the Dallas Northland and/or Baltimore districts. The Postal Service intend to survey carriers (city and rural) before testing to gather input on divide applications. Carriers will test a different device each week for six consecutive weeks. If necessary, carriers will be required to continue to use the current scanner device during the test due to possible limitations in the functionality of the test devices. Participation carriers will be asked to provide feedback on the functionality and ease of use of each of the devices. This feedback will be considered during the evaluation and selection of the next generation of handheld scanners.

## Real Time Tracking for Parcels and the Letter Carrier

All of our stations have the new cell phone devices that connects to the bulky scanners that we use that will allow for real time scanning of the parcels. In addition to carrying your scanner you will also be carrying this cell phone. This is good for our customers since it will allow the customer to track their mail, parcels, Express etc with real time tracking. There is another side to this device for letter carriers, this device has been equipped with GPS and can track where you are. Your supervisor will be able to see if you are off your line of travel, off of your route altogether, or if you are spending long periods of time without moving.

If management looks at this GPS and think you are doing something that you shouldn't be doing or you are somewhere that you should not be they will probably do an investigative interview (fact finding) and eventually issue discipline. The best thing that you can do is to do your job the way you should be doing it everyday. We have always advised our members to do your job as if someone is watching you all the time. You should be conscious of following the rules, be safe and professional. With this new GPS device this is more important than ever.

If you have to deviate from your route for any reason please get permission from your supervisor first. If you are in a location longer than normal keep track of why, such as discussion with a customer, multiple parcels or accountable items, or sorting your outgoing and other mail at the end of your route to bring it back to the office. There are a lot of reasons that you might be in the same location for a length of time. There are also several reasons that you might have to deviate from your line of travel. Such as Express mail in order to get it delivered by noon or 3:00 pm. Try to let your supervisor know that you will have to deviate for this reason, this is a very common reason to go off your line of travel. Just be aware that they have a new toy and can't wait to play with it, and use it against you the letter carrier. CYA, don't give them a reason.

# Vice Presidents Report

Here is a Summarized version of an article I read on line about the Postal Service. It made total sense to me. America needs to know the facts on the United States Postal Service's financial crisis. Little of what people have heard about the Postal Service's financial crisis is accurate; indeed, the USPS is doing far better financially than is suggested by many news reports that cite -- but don't explain -- billions in red ink. The service is breaking even delivering the mail this year, and some quarters it's even making a profit. For example, in the first quarter of this fiscal year, it had a net operating profit of \$100 million. You read that correctly. It took in \$17.7 billion in revenue from selling stamps (the agency is self-funded and hasn't received a dime of taxpayer money for 30 years) and spent \$17.6 billion delivering the mail. It accomplished this despite the economy and despite the Internet.

Yes, first-class mail revenue is down about 2 percent this year. But that same Internet also leads more people to order goods online, and the resulting revenue from packages deliveries has risen by 9 percent. That, of course, bodes well for the future, with the Internet beginning to offer as many opportunities as challenges. Now, as for that red ink you've heard about, it exists -- but it has surprisingly little to do with delivering the mail. It's almost entirely an external problem created by politicians. In 2006, Congress mandated that the Postal Service pre-fund future retiree health benefits for the next 75 years, in 10 years at a cost of \$5.5 billion a year. Prefunding accounts for 100 percent of USPS red ink this year.

Unfortunately, some lawmakers want to use the very financial crisis they helped bring to the USPS as a pretext for dismantling an institution relied on by millions of Americans and by small business owners. Instead of addressing prefunding -- which they instituted and could fix, thereby actually addressing the source of the financial drain -- they want the public to take the hit. They advocate ending home mail delivery, which would force residents to go to "cluster boxes" in all kinds of weather and safety conditions. And they seek to eliminate Six Day delivery, which would raise costs for small businesses.

Our representatives in Washington have a decision to make. They can degrade service to the public and send the Postal Service on a downward spiral toward its demise. Or, they can fix the pre-funding fiasco so citizens and our businesses can continue to receive the services they have counted on for decades.
