Delivery Unit Optimization (DUO)

By the time you read this the movement of Sun Valley Post Office to Burbank will have taken effect on February 8, 2014. There was a stand up at Sun Valley with the MPOO the Union and others from Sierra Coastal District. This stand up was held to answer any questions and to let the carrier know that this move is definitely going to take place. That mean we could very well be losing valuable members of our branch to the Burbank branch, that decision has to come from National President Fred Rolando. Therefore, to all the members at Sun Valley Post Office this means that you may be represented by another NALC branch in the future.

I have been made aware by RAA Brian Voigt that everything will remain the same until our National President Fred Rolando makes the decision as to who will represent the letter carriers. What that means is for now you will still be represented by NALC Branch 2462. A complete package of information has been sent to President Rolando and the Director of City Delivery Lew Drass in regards to the DUO or move of the Sun Valley carriers. When our National President Fred Rolando makes that decision I will let everyone know what it is ASAP.

The other move of Reseda to Tarzana is currently on hold and according to the MPOO for that office it may not happen at all as he doesn't seem to think it will fit. However, the person in charge of finance for the District Ralph Tapia is still pushing for that move to take place. So we will see and I will keep you posted as I get more information.

(CCA) conversions to full-time regular career status. An updated list of vacancies available for transfer opportunities under M-01824 was posted in eReassign Feb. 1 and is available on the NALC website. Transfer requests from career employees will be accepted through eReassign following the procedure in the MOU.

Route Inspections

Route inspections are coming next spring for Van Nuys main office 91405 scheduled for March 1, 2014, 91406 scheduled for March 22, 2014, and Tarzana scheduled for April 12, 2014. We will plan route inspection classes for these offices.

Customer and employee rights when USPS solicits customers to change to centralized delivery.

NALC has recently become aware of an effort by the Postal Service in different parts of the country to convince customers to agree to change their mode of delivery to cluster box or centralized delivery. The following information details the rights of both postal customers and letter carriers:

Customer Rights

Sections 631.6 and 631.7 of the Postal Operations Manual (POM) govern conversion of mode of mail delivery. A conversion is changing from one mode of delivery to another. The most common example of this occurs when USPS solicits customers to change from receiving mail at their door to a centralized location where a number of deliveries are made into a cluster box. In such cases the customers have to go to the cluster box to retrieve their mail.

As letter carriers know, these changes are often pushed without regard for the safety of the customers or the security of the mail. The relevant language from the POM is shown below followed by a brief explanation highlighting a few key points.

631.6 Conversion of Mode of Delivery

In this section, conversion refers to changing existing mail delivery to a more economical and efficient mode. The key to converting existing deliveries is identifying those deliveries that are most costly to the Postal Service. Delivery managers can go into any delivery territory where delivery has been established for over 1 year and solicit to convert the mode of delivery if it would be cost beneficial to the Postal Service.

Postmasters should not establish a mixed delivery area where the carrier must zigzag from the door to the curb when previously the carrier took obvious shortcuts to effect delivery. Postmasters must weigh the advantages and disadvantages of converting less than 100 percent of the deliveries.

Customer signatures must be obtained prior to any conversion. In single-family housing areas (including manufactured housing and mobile homes) where the residences and lots are owned, each owner must agree to the conversion in writing. Owners who do not agree must be allowed to retain their current mode of delivery.

When a residence is sold, the mode of delivery cannot be arbitrarily changed prior to the new resident moving in. The existing mode of delivery must be retained. If an owners' association represents the community, it can direct the mode of delivery for the community. In rental areas, such as apartment complexes and mobile home parks, the owner or manager can approve the conversion.

The language above makes clear that property owners must sign indicating their agreement with the conversion. If property owners do not sign, they retain their current mode of delivery. Owners' associations and managers in rental areas may also control the mode of delivery. The final paragraph states that the Postal Service may not arbitrarily change the mode of delivery when a residence is sold.

Employee Rights

Section 667.12 of the Employee and Labor Relations Manual (ELM) provides the following in regard to employees engaging in campaigns for or against changes in mail service:

667.12 Engaging in Campaigns for Changes in Mail Service

Employees in active status must not engage in campaigns for or against changes in mail service. This regulation must not be construed to infringe on the rights to participate in labor organizations.

Committee set to continue mark-up of S. 1486: The following is an update on S. 1486 as per the latest news from the NALC website. I am reprinting this in the MailCall because I think it is something that the membership should be aware of.

On Jan. 29, the Senate committee with Postal Service oversight, the Homeland Security and Government Affairs Committee, spent nearly three hours in a mark-up meeting to debate a handful of proposed amendments to S. 1486. "Unfortunately, none of the proposed amendments to S. 1486 will fix the fundamental flaws with the bill," NALC President Fredric Rolando said, "and at least one amendment on rate-

setting would make the bill worse." As written, S. 1486 would facilitate the end of door delivery and the elimination of Saturday delivery, therefore destroying tens of thousands of letter carrier jobs. It also would endanger all postal jobs by slowing service and driving business away from the Postal Service.

"I am disappointed that the committee will seek to advance this flawed legislation," Rolando said. "We will continue to fight for the kind of reform that will strengthen the Postal Service without slashing service or attacking hardworking postal employees."

Round 1

One of the first amendments considered after the first mark-up meeting came to order on Jan. 29, from Sen. John McCain (R-AZ), called for an immediate end to six-day delivery. It was easily defeated on a voice vote.

Sen. Rand Paul (R-KY) proposed an amendment calling on the Postal Service to declare bankruptcy and reorganize. In the senator's vision of reorganization, collective-bargaining agreements between USPS and its employee unions would be renegotiated, while existing no-layoff protections and the ability to bargain over wages would be banned. The committee voted down the Paul amendment 11 to 4.

An amendment offered by Sen. Jon Tester (D-MT) called for the removal of the bill's unfair provisions regarding injured workers. As written, S. 1486 imposes cruel and discriminatory reforms to the Federal Employee Compensation Act (FECA) that would leave injured federal workers with the worst long-term injuries vulnerable to impoverishment when they reach Social Security retirement age. This FECA language was originally proposed by Sen. Susan Collins (R-ME) under last Congress' postal bill, S. 1789. Collins no longer serves on the oversight committee, but the language was still carried over into S. 1486.

Tester's amendment failed, and the FECA reform language was retained. However, Sen. Tom Coburn (R-OK), the committee's ranking member, admitted that the language was reflective of the last Congress' priorities, and he said that even if it made it into the final bill, he believed it would be removed during House-Senate conference committee negotiations. Tester disagreed, saying that he was hearing that the House would likely follow the Senate's lead on the matter and leave the language in the bill, untouched.

Sen. Tammy Baldwin (D-WI) raised some concerns over the new bill's call to transfer rate-setting authority from the Postal Regulatory Commission the Postal Board of Governors, effectively giving complete rate-setting ability to the Postal Service with greatly reduced oversight. She also raised concerns about a revised price index system.

Following a great deal of back-and-forth discussion on the matter, Baldwin's concerns were noted and her amendment was held over for future consideration.
