### DUO's

The move of Sun Valley to Burbank that has already taken effect. As of right now all route inspections for Van Nuys main office and Tarzana has been canceled.

#### NALC stands with APWU to 'Stop Staples

NALC President Fredric Rolando encourages all NALC members to join with the members of the American Postal Workers Union and the other postal unions in a national day of action on **Thursday, April 24,** to protest the privatization of postal retail services at Staples stores. As we proved in our successful 2007 campaign against the contracting-out of mail delivery. Americans value and deserve postal services provided by highly trained, uniformed and accountable employees who work directly for the Postal Service, not for an office-supplies retail chain. Just as the members of the APWU stand with the NALC in our battle to preserve six-day mail delivery service, so do letter carriers stand with our brothers and sisters in this fight against privatization.

### USPS announces new scanning device

The Postal Service has announced the deployment of a new Mobile Delivery Device (MDD) to be used by letter carriers. The device, from Honeywell, will transmit scan data in real time and will replace the current Intelligent Mail Device (IMD) and paired cell phone. There will be more detailed information on the new scanners in the Director of City Delivery Brian Renfroe's April 2014 Postal Record article. See the latest NALC Bulletin for a picture of the device.

The first phase of the deployment will take place this summer and the new scanners will be assigned to approximately 75,000 city and rural routes, mostly in major metropolitan areas and other areas involved in the same day and Sunday parcel delivery areas. (Amazon)

#### **Cost-of-living adjustment news**

There will be no third cost-of-living adjustment (COLA) for letter carriers under the 2011-2016 National Agreement because the Feb. 20 release of the January Consumer Price Index (CPI) showed no increase in the CPI between July 2013 and January 2014.

With the recent release of the January 2014 CPI-W (1967=100), 685.220, showed no increase over the July 2013 index number, 685.350. As there was no increase in the index, the third COLA for letter carriers under the 2011-2016 National Agreement is \$0—i.e., there is no third COLA. The COLA calculation is based on the increase in the CPI-W between July 2013 and January 2014.

However, under the terms of our agreement, the deferred payment of the previously announced *first* COLA, \$146 annually, did take effect in Pay Period 07-14, which was March 8-21, pay date March 28.

### Second Contract COLA

Following the Aug. 15 release of the July 2013 Consumer Price Index, the second cost-of-living adjustment for letter carriers under the 2011-2016 National Agreement was **\$541 annually**. This second cost-of-living adjustment was based on the increase in the Consumer Price Index between January 2013 and July 2013. It amounts to 26 cents per hour, the equivalent of \$20.80 per pay period or \$541 annually. Note that under the terms of the 2011-2016 agreement, payment of this second cost-of-living adjustment will be deferred for one year and will take effect in the second full pay period after the release of the July 2014 Consumer Price Index.
