Vice President's Report Janette Dolabson

NALC plans to fights plant closures and consolidations:

During the week of August 11, 2014, half of the Senate sent a letter urging Senate Appropriations Committee Chairman Barbara Mikulski (D-MD), Appropriations Committee Ranking Member Richard Shelby (R-AL), Financial Services and General Government (FSGG) Chairman Tom Udall (D-NM) and FSGG Ranking Member Mike Johanns (R-NE) to embrace a one-year moratorium on the closure and consolidation of any additional mail processing facilities and to maintain July 2012 service standards.

The letter comes on the heels of the announcement by the postmaster general that the USPS plans to close or consolidate 82 more mail processing facilities around the country, shedding an additional 15,000 jobs in 2015. The closures will eliminate First Class overnight delivery in areas serviced by these facilities and slow mail processing throughout the nation.

NALC is backing an effort to generate support for the moratorium in the House, which is being led by Reps. Dave Joyce (R-OH), Ron Kind (D-WI), Pete King (R-NY), Peter DeFazio (D-OR), Frank LoBiondo (R-NJ), Gerry Connolly (D-VA), Michael Grimm (R-NY), Michelle Lujan Grisham (D-NM), Michael Fitzpatrick (R-PA) and Matt Cartwright (D-PA). The House letter, which is identical to the Senate letter, is also directed to House Appropriators including Appropriations Committee Chairman Hal Rogers (R-KY), Appropriations Committee Ranking Member Nita Lowey (D-NY), FSGG Subcommittee Chairman Ander Crenshaw (R-FL) and FSGG Ranking Member Jose Serrano (D-NY).

"This ill-conceived idea will do nothing but disrupt residential and business customers from receiving timely deliveries -- ultimately leading to more late deliveries and driving away business," NALC President Fredric Rolando said. "Instead of embracing bad idea after bad idea in an attempt to 'save the Postal Service,' the PMG should look at new and innovative ways to serve the public and businesses through expanded partnerships and work toward the elimination of the pre-funding mandate that continues to cripple the Postal Service. Until this realization is made, we will continue to see more of the same from the PMG and we will work against these needless service cuts."

When Congress returns on Sept. 9, it has little time to complete legislative business before its expected adjournment for the elections by month's end. Therefore, Congress is expected to take up a comprehensive omnibus spending package for FY 2015 instead of individual appropriations measures, which could enshrine the moratorium in law.

Upon examination, the committee determined that three nominations did not meet the requirements for certification under the terms of the NALC Constitution, and committee members voted unanimously to disqualify all three.

Those disqualified were director of retired member's candidate Ken Ring of Minneapolis Branch 9, director of safety and health candidate Travis Lober of Arizona Merged Branch 1902, and national trustee candidate William Heller of West Coast Florida Branch 1477.

As a result of these disqualifications, the committee declared winners in two of the races for national office:

- Manuel L. Peralta Jr., a member of Garden Grove, CA Branch 1100, for Director of Safety and Health
- Ron Watson, a member of Corvallis, OR Branch 1274, for Director of Retired Members

The third disqualification leaves a field of five remaining nominees for the three national trustee offices.

Cost-of-living adjustment

COLAs total \$1,227 annually: Following the Aug. 19 release of the July Consumer Price Index (CPI), the fourth cost-of-living adjustment (COLA) for letter carriers under the 2011-2016 National Agreement is \$686 annually. Under the terms of the 2011-2016 agreement, payment of this fourth cost-of-living adjustment will take effect in Pay Period 20 (pay date Sept. 26), the same pay period that the deferred second contract COLA will take effect. The second cost-of-living adjustment for letter carriers under the 2011-2016 National Agreement was \$541 annually. Combined, the two COLAs equal \$1,227. This increase will be added to the salaries of all steps in Table 1 and Step O of Table 2, with proportionate application of the COLA to Steps A-N of Table 2.

For the Good of the Association: New York City Post Office now named for Sombrotto

On Aug. 8, President Barack Obama signed into law H.R. 2291, which officially renamed Manhattan's Grand Central Station Post Office, located at 450 Lexington Ave. in New York City, as the Vincent R. Sombrotto Post Office.

Sombrotto, a member of New York City Branch 36, led the Great Postal Strike of 1970. He later served as NALC president from 1979 to 2002. He died Jan. 10, 2013.

The measure swiftly moved through both houses of Congress this summer before landing on President Obama's desk for his signature on Aug. 8. USPS will work with Rep. Carolyn Maloney (D-NY), the original sponsor of the legislation, to prepare a dedication ceremony. USPS Operating Profit On August 11, 2014, The Postal Service released figures that showed an operating profit of slightly more than \$1 billion for the first three quarters of Fiscal Year 2014, continuing a trend of operating profitability that began in October 2012.

The Internet is now helping the Postal Service as ecommerce grows especially in the area of parcels from Amazon. USPS Chief Financial Officer Joseph Corbett called the third quarter a very good quarter in a lot of ways, because mail revenue increased by \$424 million, package revenue rose 6.6 percent, and standard mail revenue rose 5.1 percent and first-class mail revenue was up 3.2 percent. The red ink at the Postal Service is attributable to non-mail factors.
