PRESIDENT'S REPORT By Calvin Brookins

Recently the NALC Branch Presidents here in the Sierra Coastal District had a meeting with District Manager Kerry Wolny. He basically laid out the district plans to deal with the potential on slot of parcels that are expected during this up coming peak season or Christmas season. Last year there were 236,074 packages delivered per day in the district, they are expecting close to a 40% increase for Amazon this year. They are also expecting to deliver more parcels this peak season than last season.

Last year Fed-EX and UPS failed during the holiday delivering period, remember it was all over the news. Well this year the USPS here in Sierra Coastal district believes that all the parcels that those 2 companies can't get delivered this year will get pushed to the Postal Service at the very last minute. The USPS will try to hire more PSE's to get the parcels sorted and processed and ready for delivery.

Amazon is asking Post Offices to be open 24 hours to receive packages. They are expecting so many parcels during the peak season that some parcels may have to be staged in the parking lot behind vehicles in the morning. This could raise a security issue in some offices. Also extra hampers are supposed to be stored at the offices so that it can be replaced once it fills up.

New MOU on Holiday Carrier Assistants in 2014

The NALC and USPS have entered into the Memorandum of Understanding *Re: Holiday Carrier Assistants – 2014* (M-01844). This MOU allows the Postal Service to begin hiring retired employees that wish to work during the upcoming four week December period. However, such employees shall not perform city letter carrier craft work prior to the four week December period in accordance with the Memorandum of Understanding Re: Additional Resources - Holiday

Carrier Assistant. Retired letter carriers in areas in need of holiday carrier assistants will be notified of these opportunities in the near future.

Therefore, USPS is also looking to hire retirees for the peak season; some may have already received something in the mail from the Post Office. Those that are hired must be on the rolls by October 27, 2014, but can't start working until December 6, 2014, and can work through January 7, 2014.

In regards to vehicles, management plans to get LLV's from their maintenance reserve and lease cargo vans. The Union is asking that those vans be equipped with side doors for safety reasons. The next day the District Manager Kerry Wolny had his secretary send us an example of the type of van and it is similar to the UHAUL cargo van with side doors.

He also stated that the 5 o'clock window very likely will change, because we will be delivering packages until 8 or 9 at night. The landscape is changing. They also plan to have CCA's report to work at 4:00 to start delivering packages. The way it was stated to us the CCA's will start at 4:00 a.m. go out to deliver packages using the regular carrier vehicle and be back by the time the regular carrier is ready to leave for the street.

They are also looking for equipment ideas, such as Hats with lights built into the bib. Light weight Dollies and reflector vests for safety since we will have carriers out there in the dark morning and night. He also stated that they would like for the T-6's to agree to come off their assigned route for that day to deliver parcels only and have a CCA cover the route. This is because the T-6 knows the routes on their string and can get the packages delivered more efficiently for those routes.

Of course this will depend on language in the LMOU's. They are anticipating needing about 600 CCA's to get the packages delivered during the peak season. Also each station will become a hub as opposed to having a centralized hub. Amazon fresh is currently being tested in San Francisco, that will be expanded to southern California in November, that type of delivery takes place between 3:00 a.m. to 7:00 a.m.

The Postal Service also have parcel lockers in several 7/11 stores for Amazon packages. The way this works is the customer receives an email with a code to get into the locker where the carrier has delivered the package earlier in the day.

Management is also plans to get new vehicles and they will be closer to the 2 ton type vehicle. We were also told that we are scheduled for new scanners sometime in October maybe around the 24th.

The District Manager also asked us to go to MYUSPS.com and sign up for this program. This is a program that is available to customers and it basically works when you scan a parcel for delivery it will tell the customer that you have just delivered their parcel. Keep in mind you will not be able to scan that parcel at the back of your vehicle at the beginning of the loop before you get to the house or delivery point. You also will not be able to scan the packages in the parking lot before you leave for the street. Therefore, I remind all letter carriers not to scan a parcel as delivered until you are at the actual delivery point.

At this time I would like to wish every member and their family a Happy and Healthy Thanksgiving. Remember be thankful for all you have been blessed with.
