PRESIDENT'S REPORT By JANETTE DOLABSON

Food Drive

Our 24th Annual Stamp Out Hunger Food Drive was a huge success. The final totals are in. We nationally collected 80.1 million pounds of food. The highest previously collected total was 77 million pounds. This is a new record! So this is a new record! Our Region 1 total is over 8,300,000 pounds! That is also a new record for our region. Great job everyone! I am very proud of all your hard work! We have been able to help a lot more people who are food insecure with this food! Congratulations! Over the 24 year history of the food drive we have collected well over 1.5 BILLION pounds of food.

For the first time our region has 4 branches in the largest branch category in the top ten branches who collected the most food. Los Angeles Branch 24, who was number 1, Garden Grove Branch 1100 who was number 3, San Diego Branch 70 number 6 and Sacramento Branch 133 was 7th! Congratulations to all these Branches! Great job!

In our size of Branches we, for the first time, were in the top 10 nationally at number 7. Yay! We did real good.

Legislative

The House has voted to approve a 21.7 billion Fiscal Year 2017 spending package which cuts spending at more than 2 dozen agencies. During considerations of the bill a "point of order" was made to take out an amendment that would restore USPS delivery standards back to before July 1, 2012. Since that language is not in the House passed bill, the service standards will not be addressed through the appropriations process this fiscal year.

John Burton, President Branch 4006, Jill Lemons, President Branch 2902, Frank Salazar and California State Association of Letter Carriers President, John Beaumont and myself met with District 25 Congressional Candidate, Brian Caforio last week to talk about his run for the seat in that district to oust Republican Congressman Steve Knight. Congressman

Knight is no friend to labor and has not supported any legislation in support of Letter Carriers. He has made statements in public suggesting that social security should be privatized. He needs to go! The NALC has been requested to approve release staff to help elect Brian Caforio in that district. (Santa Clarita, Simi Valley, Palmdale and Lancaster, just to name some of District 25). We will be asking for volunteers to help us do phone banking and precinct walking to help with this effort.

Contract Negotiations

The APWU has a New Contract! We have been waiting to see what their new contract Looks like because it might have a huge barring on what we may be receiving in our contract that is still being negotiated. Below are a few of the high lights.

- 40 month length contract from May 21, 2015- Sept. 20, 2018
- Across the board pay increases of 3.8% for career employees over the life of the Agreement.
- 1.2% retroactive from Nov. 26th, 2015
- 1.3% effective Nov. 26th, 2016
- 1.3% effective Nov. 25th, 2017
- -Cost of Living Adjustments (COLA) will be made for career employees in March and Sept. Of each year old contract.

AMAZON----Groceries and Parcels

Amazon is just that! A gigantic multi-billion dollar company that sells everything and ships all of their goods to businesses and residences all over the world. Even though Amazon is building out their own network of hubs and delivery trucks, we are still the only company that delivers to every delivery point in the country. We are still receiving a large amount of packages and Amazon Fresh each day. There are areas of the country that have lost Amazon Fresh and the package business for the inability of our workforce to scan packages and deliver their groceries within the allotted time.

Unfortunately, carriers are continuing to not scan packages and not deliver the Amazon Fresh within the time they are expected and thus, discipline is up. We should be focused as carriers on customer satisfaction by scanning and delivering these products in a safe place and give the customers and shippers the service they are paying for.

We are in competition for a large portion of the growing package business with UPS, Fed Ex, On-Trac, Amazon and others. Why can we not be #1? We can, if we can show our customers and shippers that we can do the job in the most cost effective and efficient way possible. We must protect each package by scanning all of them and placing them in a safe place where only the customer can retrieve them. Amazon Fresh must be treated with the importance of Express Mail by scanning each bag, putting sticker on 3996, bringing back empties by scanning keychain and doing so within the time frame asked for.

We can only hope heading into the heavy fall season that we continue to increase market share in the package business and keep up with the demand. Take the time to deliver packages in a correct fashion. The future of our business depends on the volume of packages we continue to get. We need to make sure that Amazon continues to be a big part of what we do. I can assure you that failing Amazon Fresh and Amazon packages over time does not reflect well on our customers nor the companies shipping them.

The consequences of losing the Amazon part of our business would be felt all across our company, especially in the carrier craft. If you remember back 3-4 years ago when we had a handful of packages per day per route; management was eliminating routes and there was talk of excessing and layoffs. When our package business then took off, CCA's were hired in large quantities to keep up with the demand. Unfortunately, if we were to lose Amazon, we could be looking again at larger routes, loss of jobs, less revenue and profit and less negotiating leverage when it comes to negotiating local and national contracts.

I urge every letter carrier in this great union to scan every package every day and deliver Amazon Fresh in a timely manner. Help protect our revenue, our routes and our jobs so that we can all continue to support our families and look forward to that day we can retire in comfort. In Unionism

- PSE (clerk version of our CCA's) will receive wage increases but no COLA 2.2% retroactively from Nov. 14th 2015 2.3% effective Nov. 26th, 2016 2.3% effective Nov. 25th, 2017 - PSE's wages will be increased by .50 per hour the life of the contract

0.09 per hour retroactive from 2015 0.20 per hour in Nov. 2016 0.21 per hour in Nov. 2017

- -Career employees have retained their no layoff protection -PSE's will now have Health Benefits and Holiday pay.
- -PSE's will receive an annual uniform allowance We would like to Congratulate our brother and sister clerks, maintenance workers, and motor vehicle craft folks on their new contract.

We are hopeful our CCA's will be considered generously in our next contract. They deserve it!
