PRESIDENT'S REPORT By JANETTE DOLABSON

Postal Reform:

This week, NALC President Fredric Rolando testified before a hearing of the House Oversight and Government Reform Committee on postal reform legislation. The committee's leaders have introduced two bills: H.R.756, the Postal Reform Act of 2017, and H.R.760, The Postal Service Financial Improvement Act of 2017. His testimony was used to provide suggested improvements to the bills, which may be marked up later this month. He also urged the committee to adopt the two bills because they contain all the essential elements to achieve two core goals for postal reform:

- a workable resolution of the retiree health pre-funding burden, achieved by maximizing participation in the Medicare program and investing the Retiree Health Fund more sensibly; and
- a partial restoration of the rate increase that expired last year, to provide USPS with the revenues needed to stabilize its finances as the Postal Regulatory Commission conducts its 10-year review of the rate-setting system for market-dominant products.

Assuming the bill is approved by the committee, it will be referred to the Congressional Budget Office for a review of its impact on the federal budget. The legislation will also be sent to the two House committees that share jurisdiction over the Medicare program: the Ways and Means Committee for the bill provisions involving Medicare Parts A and B, and the Energy and Commerce Committee for the Medicare prescription drug provisions. Once all the committees have had their say, the bill must go to the floor of the House for debate, amendments and a final vote. Meanwhile, this whole process will have to be repeated in the Senate. The NALC's ultimate objective is to achieve the two core goals described above while protecting our jobs, our rights, our networks (including door delivery, Saturday delivery, etc.) and the interests of all annuitants from any unreasonable hardships caused by the bill's Medicare provisions.

Vice President's Report By Tracy Mullinax

Discipline----Time Limits

When a letter carrier is called into the office for any reason, the first thing you ask is if this can lead to discipline? If no, then you listen and follow the instruction unless it is unsafe, immoral or illegal. If yes, then you answer no questions until you have a union steward present. During a fact-finding, you are asked a series of questions about an incident that recently took place and the union steward should have you answer them truthfully what you can remember of it. A fact-finding is an investigative interview that May or may not lead to discipline. If a carrier receives discipline based upon the fact-finding, you should sign for it because you are not signing off that you are guilty of the charges instead; you are only signing that you are receiving it, not that you are agreeing or disagreeing with it. Management, at that point, must give you a copy and you need to give it to your shop steward as soon as possible. The union has only 14 days to gather all the necessary information,, formulate arguments, put together the case and have to set up a meeting to meet on at the Informal 'A. All discipline starts out in your file for 2 years! It is up to your shop steward to negotiate the discipline down lower or have it thrown out if not warranted. The carrier has a responsibility to give that discipline to their union representative ASAP! Recently, we have had a number of grievances that have been filed late because carriers are not letting their stewards know about their discipline until after the 14 day period. Some as long as 5 weeks! Once we have been notified, we have 14 days to grieve it! If you have been sitting on it for weeks at a time, you have taken our ability to negotiate a Lower settlement and management can make the untimely argument we cannot win! Your discipline will now be in your file for 2 years, unless management decides to reduce it! Do not put the union in this uncomfortable position and have management dictate the terms of your settlement. Most every letter carrier has received some type of discipline during their postal career. All discipline is uncomfortable to receive, but imagine how uncomfortable your union rep is when you hand them the discipline after 14 days, tie your stewards hands and put them in the unenviable position of being at the mercy of management with the inability to negotiate.

Letter Carrier Political Fund:

Why should you donate?

"Congress is the Postal Service's de facto board of directors—535 people who have enormous power over our jobs and our future," Rolando said. "Not only do they have near-total control over the Postal Service, they also legislate many of our benefits, including retirement and health care, and set the bounds of our collective-bargaining rights. We need to educate these 535 individuals and make them understand the value of the Postal Service and its letter carriers to all Americans." LCPF helps pro-letter carrier candidates in two important ways. The PAC donates directly to candidates' campaigns to help them cover the cost of campaign operations, which includes staff, offices, media, events and general operations. And while House districts are apportioned equally according to population, district sizes vary greatly. For Senate their geographical, campaigns must reach an entire state. In 2016, candidates in battleground Senate races spent an average of nearly \$20 million. In the House, some candidates spent nearly \$10 million. But money alone cannot win races, so LCPF also devotes resources that allow for the release of a number of letter carriers to work on select races to get out the vote for letter carrier-friendly candidates. Most of the released carriers contact voters through phone banks or by walking door to door."

Our allies in the House and Senate have helped us defeat more than a dozen attempts to end Saturday delivery and to deregulate mail delivery. They have helped us defeat bills aimed at ending door-to door delivery. They helped us stop several federal budget measures that would have drastically cut our pension and health care benefits.

Last November's election results have made it easier for bad ideas, and perhaps some far worse ones, to become law. So having people who speak for us on will be important in the coming years. We could face proposals to not only cut pay and benefits and reduce service, but they may also be going after our collective-bargaining rights or try to privatize the Postal Service. The Letter Carrier Political Fund is an important tool in making sure Congress understands our concerns, because it helps the union build relationships and open lines of communication with them.

Food Drive Update:

We met with KTLA on Feb. 9th in Los Angeles to discuss our event with them this year. The date for our annual morning news event for our 25th Anniversary Stamp Out Hunger Food Drive will be on Thursday May 11th, 2017. I want to invite anyone who wants to come out and be part of the broadcast to put in for it now. It will start at 6:00 AM and end around 9:00 AM. It will be held at MEND Food Bank 10641 San Fernando road, Pacoima Ca. I will remind you again in later articles. Our Kick off event at MEND will be on May 9th at 10:30 AM. This year we have Actess Jeri Ryan who has graciously agreed to be a spokesperson. We have asks in to Mayor Garcetti's office and waiting to hear back from them. We also will be inviting Edward James Olmos and Anthony Anderson, both of whom have participated in prior years. Ralphs' has again agreed to sponsor bags for Sierra Coastal

District. I do not know the amount of the donation yet but we are so grateful for their continued support of this great event.

Postal Facts from The Washington Examiner:

"Overall, the Postal Service delivers to 155 million residences and businesses six and increasingly seven days a week, providing them with the industrial world's most affordable delivery network. Consistently rated the public's most trusted federal agency, the USPS is particularly critical to small towns and rural areas as well as to small businesses. It is also the nation's largest civilian employer of military veterans. These are just some of the reasons why the Postal Service enjoys enthusiastic support from the public and from lawmakers across the political spectrum, including many conservatives and Republicans.

Regarding its finances, the Postal Service is operating in the black – despite what you may have heard. USPS revenue exceeded operating expenses by \$610 million in Fiscal Year 2016, bringing its total operating profit the past three years to \$3.2 billion. Bear in mind that this is earned revenue; by law USPS gets no tax dollars. It earns its money by selling stamps and other products and services

Two structural factors account for this impressive performance: As the economy gradually improves from the worst recession in 80 years, letter revenue is stabilizing. And as the Internet drives online shopping, package revenue is rising sharply (up 16 percent in 2016), auguring well for the future. Record worker productivity also contributes

.Critics like to depict a harshly competitive delivery environment, but significant public-private cooperation actually exists. For example, UPS and FedEx bring an increasing portion of their parcels – millions a year – to the post office for "last-mile" delivery. The private carriers go to perhaps every 50th address while letter carriers go to every address anyway, so UPS and FedEx – and their customers – save money while USPS earns revenue. There is red ink but it stems not from the mail, but rather from congressional politics.

LETTER CARRIER POLITICAL FUND BY JOHN BURTON

The Letter Carrier Political Fund is a non-partisan political action committee (PAC) established for electing qualified candidates who support letter carriers and who are committed to maintaining a strong and innovative U.S. Postal Service. Each year, NALC fights to fend off attacks in Congress that threaten letter carriers' collective-bargaining rights, retirement benefits and livelihood. There are several things that are about to come out of Washington. congress wants to create a national right to work law which doesn't mean you have a right to work. it means that any employee can be removed from their job for any reason. There is also the PAGE ACT (PROMOTE ACCOUNTABILITY AND GOVERNMENT EFFICIENCY ACT) which if enacted This bill requires civil service employees to be hired on an at-will basis beginning one year after this bill's enactment. Such an employee may be removed or suspended from service by the agency head for good cause, bad cause, or no cause at all, without notice or right to appeal. This act alone would kill all government unions.

Other things coming include postal reform which would end door to door delivery first to businesses then residential and would also change retirement health benefits from FEHB as the primary insurance to Medicare as the primary insurance even for current retirees.

So, what can you do to make sure labor friendly candidates and fight off the attacks on us. Donate to the letter carrier political fund. it can be done thru payroll deduction we ask that you give \$ 5.00 per paycheck but give whatever you can.
