Vice President's Report John Burton

The NALC has negotiated a new National Agreement that will help keep us unified and equal. We pay our union dues to ensure that we can be as well prepared as possible to attain a fair deal for letter carriers. We've always been successful. This also goes for our fight with Congress. The contract oversees every day operations, but Congress has the ultimate say over the longevity of the USPS. NALC has been successful in our fight for:

A strong middle-class job, Leave (annual and sick), Overtime, Affordable healthcare, TSP (thrift savings plan), Workers compensation, Dependent care, and collective bargaining to name a few. We have done this through our union's PAC, Letter Carrier Political Fund (LCPF). But the fight is not over. While the USPS negotiates the contract, Congress has the right to take collective bargaining away with ONE vote.

Are you willing to sit back, and hope that Congress does the right thing, or are you willing to stand up and fight for your future? If you are ready to fight, there are some things that you may not be aware of. For example: how do we finance our struggle? Not with dues money, but with LCPF contributions. Not one single dollar from dues goes into Political Activity. I hope you will find all the information you need to convince you of the importance of becoming a LCPF contributor. The \$5 per pay period is your willingness to help continue to fight to keep the benefits that our brothers and sisters who came before us fought so hard to earn

LCPF is here in order to:

- o Allow NALC to support political leaders and groups in both parties who defend Letter Carrier benefits and protect Letter Carrier jobs.
- o Give NALC the opportunity to show our friends in Congress who have supported us in the past that we appreciate the work they have done and encourage their continued support.
- o Provide NALC the opportunity to support policies that are favorable to all working people defending social security, improving health care benefits, and strengthening collective bargaining rights.

LCPF is a Non-Partisan PAC

- o That contributes to candidates that are friendly to Letter Carriers regardless of their party.
- o LCPF contributions have gone to a diverse group of elected officials from Minnesota Democrat Senator Al Franken to South Dakota Republican Representative Kristi Noem.

- o Job security for Letter Carriers.

- o Fair and livable wages.
- o Safe and secure pensions

LCPF Disclaimer

By making a contribution to the Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 per calendar year. Any guideline amount is merely a suggestion, and an individual is free to contribute than the guideline suggests, and the Union will not favor or disadvantage anyone by reason of the amount of their contribution or their decision not to contribute.

Legislative update

On Oct. 26th the House of Representatives voted to adopt a budget resolution (H. Con. Res. 71) to set funding levels for the government for Fiscal Year 2018 as well as budget targets for Fiscal Years 2019 through 2027. The plan allows for major tax cuts and calls for massive reductions in Medicare and Medicaid spending.

H. Con. Res. 71, initially passed by the House on Oct. 5, invoked a process called "budget reconciliation," a tool that allows for Senate passage with only 50 votes, rather than the 60 votes needed to prevent or overcome a filibuster. Budget reconciliation is a potentially dangerous tool that could lead to major policy changes. In this case, its primary intended purpose was to overhaul the nation's tax code and to reduce mandatory spending levels on entitlement programs such as Medicare.

To accomplish the spending reductions, the House resolution called for 11 House committees to cut a total of \$203 billion in mandatory spending programs over 10 years. The House Committee on Oversight and Government Reform would have needed to find \$32 billion in cuts, placing federal employee health and retirement benefits in jeopardy.

Luckily, the Senate developed its own version of a budget resolution (S. Con. Res. 25) that did not call for using reconciliation to reduce mandatory spending. Instead, it focused almost entirely on tax-related reconciliation instructions to pave the way for tax reform. The Senate passed its version and sent it back to the House in the form of H. Con. Res. 71. Today, the House passed the Senate's version of H. Con. Res. 71 without amendment.

For NALC members, this is a significant victory in protecting active and retired letter carriers against the numerous proposals we have been hearing about in House and White House budget proposals.

"Without reconciliation, major cuts to federal employee benefits will be much harder to enact—a major victory for all federal employees," NALC President Fredric Rolando said. "But we are not entirely in the clear. The attack on Medicare will not spare retired letter carriers, and tax cuts that explode the deficit will expose our benefits to future cuts."

The Postal Service has proposed a national guideline for the existing Safety Captain Program and rebrand it as Safety Ambassador Program. The purpose of the new Safety Ambassador Program is to design a standardized safety program based on the existing and locally developed Safety Captain Program. The new program will focus on employee engagement, training, communication, hazard identification/abatement and accident reduction.

Safety Captains will be renamed Safety Ambassadors and will partner with the Facility Safety Coordinator and/or the installation head using existing programs to promote a culture that encourages employee participation to improve the safety climate in the workplace.

Creating an Engaging Workplace (CEW)

The Postal Service has put together a pilot test training called Creating an Engaging Workplace (CEW). Participants will consist of volunteer bargaining unit employees and will provide input on the training. The pilot test was held in October in San Francisco and the feedback will be evaluated before the program will be rolled out Nationally. DOIS Update:

The Postal Service is updating the Delivery Operation System (DOIS) to enhance is functionality. This will include Automated download of piece counts for packages and small parcels and rolls (SPRs) from arrival at unit, elimination of the option to print PS form 3971, and conversion of several forms from Adobe form fill to Live Cycle.
