PRESIDENT'S REPORT By JANETTE DOLABSON

Consolidated Casing Sherman Oaks

We are filing a lot of grievances for Sherman Oaks regarding Consolidating casing. Some of the issues we are not going to be able to come to any agreement on so those are being appealed. The Article 8 grievances are mostly being settled at the local level. Some of the issues we are seeing in the office that continue to happen that can be fixed by the carriers is the continuous working off the clock. We know there is a lot of pressure for carriers to get off the clock in the afternoon. But some folks are clocking in from the street and then immediately clock out end tour and continue to work off the clock. Some are coming in early and working at the cases off the clock cleaning up from the day before. Some are working during their breaks and not taking your lunches. Some are not doing their vehicle inspections. Some are doing the vehicle inspections off the clock before they begin tour. We know this process stinks. It's frustrating. Your routes are not 8 hours. This process is considered, by the Postal Service as a "test" but our contract is not a test. They still must follow the contract. When they don't, we file a grievance. If you don't want this process to succeed, then don't give them free time. Stop working off the clock. Every minute you give them helps them make this ridiculous process look better for them. The working conditions are rough. You are all working hard and doing your best to get through it. We know you just want to get off and go home. We do understand that. Hopefully the NALC at the National Level will win in arbitration and the USPS will have to end this consolidating "test". But as you know by now, arbitration cases can take a long time to be heard and a long time before there is a decision. We ask that you have patience. We can't just wave a magic wand and make it all go away. I wish we could.

VICE PRESIDENTS REPORT By John Burton

Today, the House of Representatives passed the USPS Fairness Act (H.R. 2382) in a 309 to 106 vote. As letter carriers know, this bipartisan bill seeks to end the mandate for the Postal Service to prefund retiree health care decades in advance.

Passage of H.R. 2382 is a tremendous achievement for letter carriers and the broader postal community. This is the first major piece of legislation tackling postal issues that has passed the House of Representatives since the 2006 passage of the Postal Accountability and Enhancement Act, which forced the disastrous prefunding mandate onto our employer.

"Letter carriers should be proud of their hard work to educate members of Congress and gain their support on this very important issue," said NALC President Fred Rolando. "House passage is a major victory in the battle to end this disastrous mandate, but our work is not done. We must now turn our attention to the Senate."

NALC asks letter carriers to please thank their Members of Congress who voted in support of the bill. The roll call vote of yea's and nay's may be found here.

Now that the bill has advanced through the House, it will be up to the Senate to act on S. 2965, the bipartisan companion bill. Letter carriers should be ready to engage and educate their Senators and staff on the need to repeal the prefunding mandate.

Our union has endorsed Dem. Christy Smith for Congress for the 25th congressional district which includes antelope valley, Santa Clarita valley, parts of Simi Valley and Porter Ranch. Christy will be an advocate for the NALC, and I encourage everyone in the district to vote for her twice one for the remainder of this term and second for the next term.

Route Inspections

Starting at the end of February we are having some of our zones scheduled for route inspections. First will be Encino 91316 zone. We held an inspection class for them at the end Feb. The next class will be for Panorama City in March. They

are scheduled for inspections the week of March 21. We will hold an inspection class the week before. I will send out a sign- up sheet for that class. The last zone scheduled for inspections will be Encino 91436 zone the week of May 16th. We will hold a class for that one the week before that inspection. I can not stress enough how important it is to attend the inspection classes held at the union office especially if you are a regular carrier on a route, a CCA on an opt or anyone who has not gone through an inspection before.

CCA Conversion from Postal Record

Up Dates

NALC and USPS have settled a national-level grievance regarding non-compliance with the contractual caps on the employment of City Carrier Assistants (CCAs). This settlement (M-01906) provides that all city carrier assistants in any size office with 30 months of relative standing on February 15, 2020, will be converted to career status within 60 days from the signing of the agreement on January 22, 2020. CCAs meeting this criteria in 200-workyear offices or larger will be converted to full-time regular, and CCAs meeting this criteria in all other offices will be converted to part-time flexible.

Select districts will make conversions to career status in addition to those described above. The districts where these conversions will take place and the number of months of relative standing to be used are identified in the settlement. The criteria for these additional conversions will otherwise be the same. All CCAs converted to career status in accordance with this settlement will be converted within their current installation. NALC projects this settlement will result in almost 4,800 CCA conversions to career status, including approximately 3,000 conversions to part-time flexible in smaller offices.

NALC Health Plan Members there is a few Hospitals that are no longer within in your network. One of them is Northridge Hospital. They have terminated their Cigna Open Access Plus contract. The following PPO facilities DO have access. Please make sure that you go to one of these Hospitals and Medical Centers for care:

Providence Tarzana Medical Center, Valley Presbyterian Hospital, West Hills Hospital and Medical Center, Providence Holy Cross, Pacifica Hospital of the Valley, Ronald Reagan UCLA Medical Center, Henry Mayo Newhall Memorial Hospital.

To be sure there is no interruption in your medical care, the Plan does provide transitional care for those members who are being treated by specialists for chronic and disabling conditions and will lose access to their physicians. This allows the patient to continue care with their current provider, for 90 days from January 31, 2020. It also allows time to transition to another provider who is a PPO participant.
