PRESIDENT'S REPORT By CALVIN D. BROOKINS

Update to Article 10 Charges:

This is an update to the July 14 notification of charges received by the NALC Executive Council proffered against President Brian L. Renfroe by another member of the Council. On Aug. 29, the NALC Executive Council received the report of the member appointed to investigate the charges in accordance with Article 10 of the *NALC Constitution*. Per Article 10, the NALC Executive Council was required to determine "whether a substantial charge is presented by the report." Of the original eight charges, two were withdrawn by the charging party. Of the remaining six charges, four were determined by the Executive Council to be substantial. The four charges determined to be substantial are:

- "Abandoned Position and Dereliction/Neglect of duty."
- "Neglect of Duty."
- "Conduct. Impaired driving after hours in a NALC owned vehicle."
- "Circulating False or Misleading Statements about a NALC Officer: Brian Renfroe shared and referenced confidential information about an employee matter."

Note: a finding that a charge is substantial is not a determination of guilt, but rather triggers an evidentiary hearing in accordance with Article 10.

In accordance with Article 10, the Executive Council will appoint a panel of three disinterested members, excluding the investigator, to conduct a hearing regarding the four charges. The panel shall make a report with recommendations to the Executive Council, which shall be served on the accused officer and charging member, who may, within 15 days, file with the Executive Council objections or comments thereon.

We will keep you all updated as this saga continues.

SAFETY DEPENDS ON YOU!

Protecting yourself during an active shooter situation USPS and the Postal Inspection Service are continuing Project Safe Delivery, a national initiative to protect employees and the security of mail and packages. Today, we will talk about active shooter situations. We have all heard stories about active shooters in the workplace or other public arenas. An active shooter is defined as an individual actively engaged in killing or attempting to kill people in a confined and populated area, typically with firearms. An active shooter can be anyone: a customer, a stranger or a current or former employee. Research shows that in most school shootings, the suspect told one person — sometimes two or more — about the attack beforehand. That means you could be the key to preventing an active shooter incident. If a co-worker, friend, child, family member, customer — anyone — speaks of committing harm to others or themselves, do not ignore it. Do not assume someone else will report it or that the person is incapable of such violence. Report your concerns to law enforcement. If the person is a co-worker, call the Postal Inspection Service 24/7 at 877-876-2455. If you ever find yourself in an active shooter situation, follow these guidelines:

CALL OUT!

- Communicate the threat to everyone using all possible means — shouting, phoning, texting, etc.
- Use simple, repetitive language: "Shooter in the building, escape now!" or "Active shooter, run!"
- Call 911 when it is safe to do so.

GET OUT!

- Have an escape route and plan and ensure it includes people with disabilities.
- Leave your belongings behind.
- Keep your hands visible do not distract law enforcement.
- Move quickly do not wait for approval to act.

HIDE OUT!

- If you cannot escape, hide in an area out of the shooter's sight.
- Block entry to your hiding place lock doors and deny the shooter access.
- Keep quiet silence your cellphone and all electronics.
- When it is safe to do so, GET OUT! As a last resort, and only when you have no other options: try to incapacitate or overpower the shooter by whatever means necessary, Act with physical aggression.

Call the Postal Inspection Service 24/7 at 877-876-2455 to report suspicious activity and with any questions related to the above guidelines. An active shooter situation is a traumatic event. The Employee Assistance Program, also known as EAP, is available to help anyone affected by violence. EAP provides confidential, voluntary counseling and access to resources that can aid in recovery. Call EAP toll-free at 800-327-4968 (800-EAP-4-YOU), or TTY at 877-492-7341 for confidential assistance 24 hours a day, seven days a week. Remember: You are our most important delivery!

The NALC Disaster Relief Foundation was created to fill a need that many branches and their members faced when these disasters happen. Such as, the wildfires that burned areas in northern and southern California, and now Hawaii, as well as hurricanes that went through south Texas, Puerto Rico. the U.S. Virgin Islands, and parts of Florida.

The Foundation helps branches to know where they can send desperately needed supplies and money to a central location. This Foundation makes it easier for us to help other members of our Union that are in need quickly and efficiently. The Foundation has been set up to function in two ways by providing hands-on relief and by receiving donations to offer financial grants.

NALC has created response teams throughout the country. Those folks on the teams receive disaster relief training from charitable organizations and government agencies, including the American Red Cross, the Federal Emergency Management Agency (FEMA) and Occupational Safety and Health Administration (OSHA).

The NALC Disaster Relief Foundation also provides financial support through grants. Any NALC member who has faced hardship because of a natural disaster will be able to apply for assistance. The foundation's board of directors will consider the hardship applications and will issue grants on an objective basis to eligible individuals as fund are available. Job performance or history of donations to the foundation will not be considered as part of the selection process.

The NALC Disaster Relief Foundation is a 501(c)(3). therefore your contribution to the NALC Disaster Relief Foundation may be eligible for a tax deduction. It is strongly recommended you seek further advice from your tax advisor regarding that type of tax deduction.

Health Benefits Report JANETTE DOLABSON, HBR

Suicide Awareness and Prevention:

Something to look out for when concerned that a person may be suicidal is a change in behavior or the presence of entirely new behaviors. This concern is the sharpest if the new or changed behavior is related to a painful event, loss, or change. Most people who take their lives exhibit one or more warning signs, either through what they say or what they do. Some of these are:

Talking, discussing, fixating on death. Giving away valuable or meaningful possessions. Having reckless and dangerous behavior. Increasing the use of alcohol and/or drugs. Sleep issues, too much or too little. Not taking basic care of self. Having a history of suicide attempts. Putting personal business in order. Neglecting doctor's orders. Increased anger and intensified mood swings. Withdrawing, isolating, and disconnecting from others.

Know what to do:

- 1. Offer hope. Reassure the person that help and resources are available. Let the person know that their life is important to you and there is light at the end of the tunnel.
- 2. Take action. Talk about steps you can take together to keep it a secret.
- 3. Get help. There are services designed to assist you with preventing suicide. Get immediate care for someone with suicidal thoughts or feelings.

Ensure the appropriate people are aware of the situation. Never try to take on the situation alone.

Seek additional support from trusted family, friends, neighbors, a coach, or religious leader. You can also reach out to the EAP (Employee Assistance Program) at 1 (800) 327-4968, 1 (877) 492-7341 or EAP4YOU.com.
